Notice Re-obstructing Drains on Public Highways

The attention of the public is called to Section 65 of the Road Act which reads as follows:—"No person shall obstruct or impede the water course of any drain draining any highway in order to facilitate his access from his property to such highway, and it shall be the duty of every owner or occupier of land fronting on the highway to see that such drains are kept open at the point of approach through any gateway, lane or other way from the property owned or occupied by him to such highway, and any offence against this provision shall be punishable by fine not exceeding ten dollars." All Inspectors and Overseers are hereby required to see that the Act in this respect is strictly complied with.

Thinks Faster Than Most Of Us

LONDON, Nov. 29.—The leading weeklies take a gloomy view of the French attitude at Washington. The Nation declares Briand's speech "means, as we all expected, France vetoes any attempt to regulate land armaments. Balfour, in carefully turned phrases, expressed regret at this attitude, but stopped short of reproach. The result is that while the Washington conference will almost certainly bring great gains in economy to the naval powers, France has contrived that it should promise no moral disarmament of Europe. H. G. Wells thinks faster than most of us, but his blunt sentences are not far ahead of the general impression." The writer adds that France should answer "the grave charges" brought against her by Wells.

The New Statesman regards the French attitude as the most serious danger of the conference, and having mentioned Briand's demand, adds: "It is unexpected and so out of keeping, either with her needs or with anything that has hitherto been projected or discussed in Paris, that its seriousness might on its face be doubted. But unfortunately there is only too much reason to believe the French Government regards with serious disfavor any prospect of Anglo-American understanding and might even be willing, bankrupt as it is, to incur considerable expenditure to prevent it. It is impossible, therefore, to be sure that these new claims are as frivolous as they appear."

Truro Witnesses On The Stand At The Trial of John Paris, Who is Charged With Murder

ST. JOHN, N. B., Nov. 29.—At the trial on Saturday, of John Paris, charged with the murder of little Sadie McAulay, here on August 2, evidence was produced by the defence tending to show that Paris had been paid money by an employee of the Eastern Hat and Cap Company, of Truro, in that town on August 2. This evidence was corroborated by another employee of the firm, Stanley Nichols, a garage owner of Truro, testified to having purchased some gasoline from Paris in Truro on August 2. In the morning the testimony of James W. McNaught and Christina McBenz, employees of the hat firm, was given and Nichols also testified. In the afternoon the cross-examination of Nichols took place and when adjournment was taken he was still on the stand. He was closely questioned as to alterations in entries in a book placed in evidence. The evidence of Miss McKenzie was not concluded and she will be recalled. The trial continues tomorrow.

AERIAL LINE PROJECTED TO PLY FROM EUROPE TO SOUTH AMERICA

Scheme Being Worked Out in Germany for Opposition Under Spanish Auspices of Gigantic Zeppelin Passenger Ships, With Capacity of Forty Persons Each.

LONDON, Nov. 29.—The project of an aerial line connecting the continent of Europe with South America by gigantic Zeppelin passenger ships is being worked out in Germany. Doctor Hugo Ecker, one of the chief directors of the Zeppelin works, Germany's most famous pilot, and for many years a co-worker of Count Zeppelin, has just returned from a visit to Argentina and Spain. Dr. Ecker has spent several months in these countries studying routes and landings, and assisting in the organization of the company. He says that he found Southern Spain ideally located for a European air harbor and as a port for a trans-Atlantic Zeppelin line. The other end of the line will be near Buenos Aires, where it is declared that weather and wind conditions are very favourable. He estimates that a Zeppelin with 150,000 cubic meters gas capacity has a speed of 115 kilometers an hour, with forty passengers, can make the trip from Spain to Buenos Aires in ninety hours. One hundred hours will be required for the trip to Europe on account of less favorable wind conditions. As the peace treaty places almost insurmountable obstacles in the way of organizing and operating air ships from Germany, the organization will be exclusively Spanish, with Germans in charge of all operations.

CANADIANS WHO FOUGHT IN MOROCCO ARRIVE PENNILESS IN LONDON

Tell Bitter Stories of Having Been Beaten With Rifle Butts and Slashed With Whips by Spanish Officers.

LONDON, Nov. 29.—Fifty-three members of the British Contingent to the Spanish Foreign Legion arrived in London today from Spain, and they tell bitter stories of hardship and ill-treatment at the hands of the Spaniards. PIECES OF BONE HUMAN TEETH

ASTONISHING IDENTIFICATIONS MADE AT TRIAL OF FRENCH "BLUEBEARD."

PARIS, Nov. 29.—Landru's life today hangs on the single thread as to whether the jury will accept as positive the identification by experts of 256 pieces of bone found in the rubbish heap back of the Gambais villa. The positive testimony was that the bones had belonged to three and possibly more persons, one expert positively affirming that those persons were women. Professor Sauvalze, head of a French dental institution, this afternoon took a tiny fragment of ivory scarcely bigger than a piece of a match stick, and deduced from it that it was once a part of a hollow tooth of an adult person, probably a woman about five feet tall and middle aged.

Similar astounding identifications made by other famous chemists during the day produced the most unfavorable impression against the Bluebeard that has appeared since the trial began. Rumors of a bitter quarrel between Landru and his attorney, the famous Moro-Glaffier, seemed to be confirmed when Landru several times waved aside the warning of his counsel and insisted upon explaining the answers to questions. At a quarrel in Landru's cell late last night it is declared Glaffier threatened to throw up the case unless Landru left the defense wholly in his hands to which Landru is said to have retorted: "Your have only your reputation to lose, but I have my head."

The present indications are that the case is steadily going against Landru. LIBERAL CRITICISM.

(Saturday Night.)
"Ladies and gentlemen, I have another question to put to the Hon. Arthur Meighen; and I hope that he will show more candor in answering it than he has in replying to certain other questions of mine. It is this: Is he aware that during a period embracing the hours between dawn and darkness on November 9th, the heaviest snowfall which has been known in Eastern Canada, at so early a period for many years, took place in Ontario; is he aware that eight inches of Nature's ermine mantle fell; is he aware, that, as is usual in such cases, the snow was white? Will he deny or affirm this assertion; or will he resort to evasion? I fancy that he dare not. The facts are plain. And what do they signify, ladies and gentlemen? They signify a great deal. An early snow storm is a serious matter. It obscures hill and dale; it makes roads muddy, sometimes impassable; it brings discomforts to thousands in city and country alike; it interferes with the garnering of turnips and mangle-wurtzels. Now the party with which Mr. Meighen has been identified has had a full decade in which to deal with this stupendous question of regulating the snow-fall,—with the prevention of snowfalls at unseasonable times. Has it dealt with it? Has Mr. Meighen himself ever given the subject a thought? Has he ever asked for a report on the subject? No and again No! Mr. Meighen says the tariff is the issue in this campaign. Is this not an issue also; a grave and important issue? There are many issues; I find a new one every time I open my morning newspaper; but few so important as this. But this government of usurers has sat idle. The snow may fall as it listeth for all Mr. Meighen and his associates care. They are too busy looking after their friends in 'big business'. Even the slimy trail of big business enters into this. The government knows and knows full well that early snowfalls are designed in the interest of the rubber industry. That one protected industry may further fatten on the sufferings of the people it is willing to tolerate snow whenever it comes. Is it not time to end the reign of privilege and usurpation? (Cheers).
