The Premier spoke in favor of Mr. Wright's sub-amendment, saying that the railway engineers were the best sons who were demanding the best place for the connecting link. It was wanted the line to run through their own districts. While we all believe that the Hills-borough bridge should be replaced, we cannot look for any great chang-es at present, he said. The one thing that had not been definitely settled was the question whether this bridge is to be rebuilt or not. He understood, at any rate, that it was not the policy of the Minister of Railways to replace it within the next three years. He did not think any Government could be expected to make a definite statement as to what they were going to do beyond that period. The plans as to the branch line, however, have been definitely made and he did not think it would be wise to suggest another course at this time.

was another reason why the Federal Government should pay the whole sum, Ottawa first heard of Mitchell's wrongful activities, and, if they had then at once notified the Provincial Government and stopped his salary, the damage would not have been done. Another reason is that a member of the Privy Council introduced the man to Premier Bell. He recounted the story of Mitchell's dealings.

Mitchell was a regularly appointed official under the great seal of the province. It is most unfortunate that this little province with its small revenues should have to pay this money, when the Dominion is so well able to do it. He had interviewed Hon. Mr. Robb, but had been unable to obtain any satisfaction.

This business had given the Province a lot of bad advertising. Hon. Dr. Grant said he had always been in favor of paying this amount. What the leader of the Opposition had said was proof that this Province was at least responsible for part of the amount. Mr. Stewart had had a conference with Mr. Robb on the matter, and the Finance Minister had seen no merits in his case as against the Dominion Government. Since that was Mr. Robb's attitude, the Government should be satisfied to pay at least half of the amount.

care a certificate signed by the Provincial Health Officer to the effect that they are free from active tubercu-losis or other communicable dis-eases, also a certificate of vaccina-tion and no student shall be admit-ted without such certificates. Those intending to marry must furnish to the issuer of licenses certificate of the birth of the par-ties to the intended marriage un-less special circumstances are shown which such certificate of birth cannot be pro-duced. Any City or Town within the Province shall have power to vote, or lect, receive, appropriate and pay all sums of money required for the following purposes: The aiding by way of grants, con-cessions or otherwise, the Canadian National Institute for the Blind, or other organizations now formed, or which may hereafter be formed, for the purpose of assisting, training or employing adult blind, or partially blind persons, who have legal settle-ments within the Province of Prince Edward Island. The bill was reported agreed to with amendments. The House adjourned at 6:15 p.m. until 10 o'clock this morning.

THE MARKETS

MONTREAL, April 18—Wholesale butter prices in Montreal continue to go lower today, and values droppe over a cent per pound. Sales were made at 41 to 42 cents per pound for New Zealand, and first western made eastern townships number one pasteurized. As the advanced the market dropped to 41 cents. The volume of trading was small and receipts amounted to 735 boxes. The cheese market remained unchanged with western number one colored quite at 19 1-2 cents per pound. Receipts were 190 boxes. Egg prices also were unchanged. Jobbers sold to the retail trade at 33-34c. for fresh extra, 31-32 c. for fresh firsts, and 29-30 cents for fresh seconds. Receipts were 3,661 cases. The grain, potato and poultry market were quiet and prices were unchanged. Beans and peas continued steady.

OTTAWA, Ont., April 18—The local egg market is firmer and dealers are now quoting country shippers for ungraded eggs, delivered, cases re-turned extras 26-28; firsts 24-26; seconds 21-23. Prices to retailers are: firsts 32, firsts 30, seconds 27. Live fowl are scarce here and prices are advancing with the Jewish pasover at hand. Dealers are quoting 26-26 cents per pound live. Ontario country prices are holding steady. Receipts are heavy and continue to show an increase. At Parkhill and Forest dealers are quoting producers extras 24, firsts 20, seconds 19. Paying prices at Chatham are extras 24-25; firsts 22-23; seconds 18-19. At Harrison paying prices are extras 23, firsts 21, seconds 17.
