**TO TESTIFY IN PILFERING CASE.**—Mr. J. J. Dunphy, special agent of the Police Department of the C. N. The proceedings closed with the singing of the National Anthem.

Militia and came to camp in Charlottetown annually with the Montague Company for training and was well known among most of the Charlottetown boys. He expects to return West shortly.

 Son of Mr. Colin McDougall, Charlottetown, formerly of Morell. Left here with first reinforcements of 105th Was in fighting at Amiens and Arras. Wounded in chest and right leg at Arras.

Pte. J. D. Campbell  
 Belongs to Elmira. Left with 105th. Transferred to 26th Btn. Fought in all battles from Vimy to Cambrai and Mons. Wounded at Arras.

Pte. D. Peters.  
 Belongs to Rocky Point. Enlisted in 1917 in Forestry Battalion and has been engaged since in forestry work in South of France.

Pte. D. Livingstone.  
 Belongs to Clyde River. Was with the 28th Railway Battalion. Spent four months in France.

Pte. A. A. McNeill.  
 Belongs to Auburn, Lot 36. Left here with 105th. Was badly gassed and was buried by shell explosion.

Pte. Fred Harper.  
 Is the son of Mr. Charles Harper of the P. E. I. R. Enlisted in the Railway troops and was twice wounded. He is now the picture of health and his many friends will be delighted to see him home again. Particulars of other returned men will appear later.
