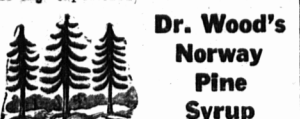

we were engaged in. 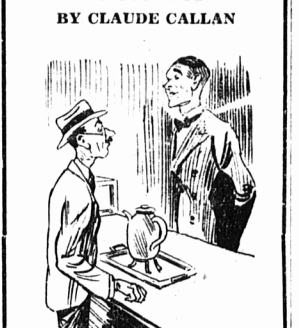
