WASHINGTON, Oct. 14—(AP)—Prospects for a settlement of Labor's "family row" received a setback today when the 10 rebel unions suspended by the American Federation of Labor decided to sound out the possibility of reinstatement before negotiating for peace.

John L. Lewis, President of the United Mine Workers and leader of the unions suspended for "insurrection," told reporters they had postponed action on the Federation's peace proposal pending clarification of the re-instatement issue.

### NEW ADVANCE

Government sources joyfully claimed victories on land and sea, but at the same time anxiety mounted as unconfirmed reports said a flotilla of German torpedo boats was anchored in Spanish waters along with 12 submarines.

Dynamite-throwing Asturians tonight were reported blasting their way into the insurgent stronghold of Oviedo, on the far northern front. The war ministry asserted the miners made fresh advances, cornering the insurgents.

(Dispatches from Saint Jean de Luz quoted government sources as saying Socialist forces killed or wounded 1,000 insurgents in fighting near Oviedo. An insurgent relief column marching to the Bay of Biscay city, it was reported for the time being abandoned its drive to relieve the insurgent garrison.)

Other government advances were reported in the Toledo sector. On sea, government submarines reportedly sank two insurgent troopships near Tangier, off Spanish Morocco. Many bodies of victims were washed up.

Inhabitants of Madrid tonight dined well, with official government thanks going out to Soviet Russia for food which arrived when rationing of all food in the capital had become necessary.

—**ISSUES VIRTUAL**—Russian charges, Oct. 10, it was announced officially that no date for the next session would be set until after Italy, Germany and Portugal had time to reply to the accusations in writing.

The Tass (official Soviet) news agency this week declared Germany had indicated she would feel "free to act" if Russia should denounce the neutrality pact.

Informed circles in Moscow have expressed belief that Russia would not revocably bolt the pact unless the committee refused to consider additional safeguards against Spanish intervention by powers sympathetic to the insurgents.

—**VIRTUAL ULTIMATUM**—LONDON, Oct. 14—(AP)—Russia's second demand for action to isolate the Spanish civil war was viewed here tonight as a virtual ultimatum to European powers.

The Soviet Government sent a note to the International Non-Intervention Committee which demanded it be convened this week to act on Moscow's charges that Portugal, Italy and Germany were violating the Non-Intervention accord.

Ivan Maisky, Soviet Ambassador to Great Britain, called on the Earl of Plymouth, Chairman of the Non-Intervention Committee and was understood to have requested a meeting this week.

The Soviet Ambassador, was said to have taken personal leadership of Russia's charges in order to emphasize that his nation was not bluffing in its demands for a showdown.

### CIRCULATES COMMUNIQUE

Lord Plymouth tonight circulated the Russian Communiqué to other members of the Non-Intervention Committee, but did not accede to Russia's demand that the committee "immediately" be reassembled.

Informed persons said there was little likelihood the representatives would be reconvened this week.

It was reported that Lord Plymouth told the Soviet representative he preferred to follow the course agreed upon at the last meeting—to do nothing until the accused nations had time to reply to the charges.

Less than a week ago the Soviet charged the three Fascist nations were supporting the Spanish insurgents and threatened to withdraw from the "hands off Spain" agreement unless the alleged offenders obeyed the pact.

Maisky was understood to have told Lord Plymouth they considered a week was ample time for the accused nations to make written answers.

It was not known whether the Ambassador had presented new evidence to support the Russian charges but it was understood he had offered proposals for making Non-Intervention airtight in the future by joint action.

### Greater Milk Advertising Urged

ATLANTIC CITY, N.J., Oct. 14—(AP)—Lynn Summer, New York advertising authority, told the International Dairy Convention today the milk industry should make greater use of newspaper advertising and play up the beautifying qualities of milk.

"Almost every claim for health and beauty that ever has been made falsely for a patent medicine could be truthfully made for milk," he said.

### Mrs. Wallis Simpson Files Divorce Suit

LONDON, Oct. 14—(CP)—Ernest Simpson said today his wife, Mrs. Wallis Simpson, has filed suit for divorce.

The case has been set for hearing before Justice Hawke at the Ipswich Assizes, opening Oct. 27, said Simpson.

He asserted the case would not be defended. Beyond that, he declared, he had no statement to make. Simpson is a commercial broker.

Legal sources pointed out Mrs. Simpson will seek her divorce on grounds of adultery, the only method by which it can be obtained in England.

The proceedings will be placed on the "undefended" list, with Simpson not contesting the charges.

If the divorce is granted, the former Baltimore woman will be freed from her second unsuccessful matrimonial venture.

She was divorced in 1927 from Lieutenant Earl Spencer, whom she married in 1916. Mrs. Simpson has been much in the public eye since she was a guest of King Edward on his summer cruise in the Mediterranean and subsequently was a guest at Balmoral Castle.

Mr. and Mrs. Simpson moved to separate quarters today. She took up residence in a house about a mile from Buckingham Palace while he went to live at his club.

Attempts at a reconciliation between them were made in July, when they met in Paris. It was understood friends urged Simpson to accept an invitation to join King Edward's cruise party. He decided, however, merely to make a business trip on the continent. Then he returned to England and awaited his wife's arrival.

The Commission, Mr. Sinclair states, had understood that there was very little unemployment among war veterans in this area. Since his arrival, however, he had been informed that the problem had grown to formidable proportions since the depression and that about 150 veterans of the Charlottetown area are unemployed at the present time.

The Commission will probably recommend the appointment of an honorary local committee to assist in the task of re-employing veterans of this area.

**Functions of Commission**

The functions of the Commission, Mr. Sinclair explained, are as follows:

To carry out as soon as possible an investigation to ascertain the extent of unemployment among veterans in Canada, and classify those who are unemployed according to physical and mental capacity or incapacity to undertake gainful employment in restricted and unrestricted occupations, and in any other categories, which, after the investigation, the Commission may consider applicable;

To investigate and report upon methods at present utilized for the purpose of providing employment for veterans, particularly handicapped and disabled veterans;

To investigate and report upon proposals leading to the development of further agencies and schemes to provide for a speedy absorption of as many veterans as possible into employment;

To investigate and report on the possibility of re-establishing gainful occupations handicapped and disabled veterans who are incapable of being absorbed into industrial employment, by the development of small holdings, community centres, and by such other methods as may be deemed practicable.

### French Wheat Supply Below Expectations

PARIS, Oct. 14—(CP Cable)—France, it is expected, will need more overseas wheat. The French crop has not met expectations. There is the further necessity of preventing a spectacular rise in the cost of living as a result of devaluation of the franc.

One of the objects of the trade talks between the Canadian and French Ministers was to ensure that in any increased imports of overseas wheat, Canada would have a fair share. Prime Minister Mackenzie King, it is understood, received this assurance.

On the other hand, French farmers' organizations are very actively campaigning against any increased importation which would have the effect of lowering the internal price.
