McNaughton Statements Discussed By Members In House of Commons



J. R. FRASER recently appointed General Storekeeper, Atlantic Region, Canadian National Railways, with headquarters at Moncton, N. B.

Mr. McNaughton: I was at a basic training centre within the last couple of weeks. In talking with the men over the course of a half year of age as an example. He is a young lad just out of school and is very soft. He is taken into the basic training centre. From there he goes to the advanced training centre. As I understand it the syllabus of training is twelve weeks. I do not think twelve weeks are sufficient.

Mr. Gillis: There is one other point that I am interested in. I can understand the remustering of men who have had considerable military training in other branches of the service and are hardened up. I am concerned about the syllabus of training for service personnel with those of a boy eighteen and a half years of age as an example. He is a young lad just out of school and is very soft. He is taken into the basic training centre. From there he goes to the advanced training centre. As I understand it the syllabus of training is twelve weeks. I do not think twelve weeks are sufficient.

Mr. Ross (Souris): Are Canadian forces being reinforced by nationals other than Canadians? Mr. McNaughton: No, and they never have been.

Mr. Ross (Souris): These are the men who are being trained, and I think they should be cleared up. Mr. McNaughton: If the non-member would like to give some further explanation I shall be glad to do so. The Canadian Army overseas which is now commanded by General Crerar, is made up of Canadian corps and a number of Canadian divisions. In that respect the British are in command and possibly more, and they have their own British divisions. Then there are Polish divisions as well as other divisions which go to make up that first army. That army is made up of units and formations which are very well trained in addition to our own units. Each of those commonwealths has its own casualties, Canadian reinforcements their own and always has.

Canadian Reinforcements Mr. Ross (Souris): The Canadian units are reinforced entirely by our own men. Mr. McNaughton: Absolutely, and always have been.

Mr. Ross (Souris): There has been a lot of discussion about that point. Mr. McNaughton: I was so much concerned about that point that I asked our public relations officer to issue a press statement which would be generally descriptive of what was going on and which would be purely for public information.

Mr. Ross (Souris): You have been considerably discussed in the House of Commons by the Prime Minister as the builder and the first commander of the Canadian army. Mr. McNaughton: I was the first commander of the first Canadian army.

Mr. Ross (Souris): You never had any doubt at any time that the army was over-expanded and that it would be any difficulty in reinforcing it? Mr. McNaughton: The army was designed on the basis of carrying on a war of long duration.

Mr. Ross (Souris): There has been considerable discussion today about the percentage of reinforcements overseas that would be composed of those troops? Mr. McNaughton: Again I must say that I am not skilful in deciding what figures should be given out and what should not be given out. It would be possible for me to give that information when I give the other figures.

Mr. Ross (Souris): That will be satisfactory, although you might be able to give it approximately. If those volunteer troops were mustered, how long would it take to train them properly as infantry ready to go into action? Mr. McNaughton: They would never be up to the infantry level because they are in the pioneer corps owing to their being low in certain pulmonary figures.

Forestry Corps Mr. Ross (Souris): What about the forestry? Mr. McNaughton: In the early part of the war the Canadian forestry corps included a great many who were eventually transferred to the infantry.

Mr. Ross (Souris): Are there any there now? Mr. McNaughton: Only a comparatively small number. Most of the Scottish woods have been cut down. There are some forestry people with the expeditionary force on the continent.

Mr. Ross (Souris): How long would it take to train these men? Mr. McNaughton: As a matter of fact the forestry corps in Scotland formed an important part in the war.

Mr. Ross (Souris): I would like to see the boy when I was overseas. I did. I had him come up from the hospital to see me. I had the boy in the case of pressure—short-cut training, to put it bluntly. I went over his training with my myself first and then he was given particularly his weapons training. It sounded as though he had had apparently good training both in Canada and in England. Then I sent for his papers. His record of training was such as would make any director of training proud.

The record showed his basic training in Canada, the hours that he had spent on each particular subject, then his advanced training, his Bren gun, mortar, tommy gun and all other weapon training with good reports as well on the rest of the syllabus. It gave the number of hours of training, the different weapons and so on. It also gave the refresher training in England. It was as complete a record as I ever saw. This was a report of his training and it was very much gratified with it. I then asked the boy how old he was. He said he was eighteen and a half years. That was in July. I said: "What did you say your age was when you enlisted?" He said: "I told you I was nineteen." I said: "Did your mother say anything about your enlisting?" He said: "No, I went home on embarkation leave and she was sorry but she did not make any objection. He had been wounded at eighteen and a half. He will not be nineteen until December and of course I gave instructions that he was not to return to his unit before that time.

A Particular Case But that was a clean case. I just happened to get the name; I got the boy; I got the age and I got all the documents, and it was a perfect situation, except for the fact that the boy would go in six months after he enlisted. That is all that could be said about the case. I know there are other cases. I have investigated quite a number. Generally if you look up the individual record you will find that the training has met the standards, and from the point of view of the requirements of the training regulations and the procedure which is laid down everything has been regularly observed. I know there are other cases where a man has been trained for four months only. I should like to see that for my own information. Can I have the figures on that? Mr. Gillis: I should like to be sure about the syllabus of training for the new personnel coming in. Is it sixteen weeks? Mr. McNaughton: The basic training is eight weeks, and the corps training runs from eight weeks in the infantry to sixteen weeks in the armoured corps.
