The community of Brookfield lost one of its most beloved citizens in the passing of Mrs. Lucy Ann MacLeod, the widow of the late Mr. Roderick MacLeod, in her 61st year. Mrs. MacLeod died in the early morning hours of July 27th, 1935. During the previous winter she had not been in her usual state of robust health, and at the beginning of July she deemed it necessary to call in medical assistance. Neither she nor the members of her family regarded her condition as critical, however, and those who visited with her were touched by her cheerfulness and courage. The shock was all the greater, therefore, when she died so suddenly and almost without warning.
