Electric Rates Are Reduced; Other Questions Disposed Of At Town Council Meeting.

The regular monthly meeting of the Summerside Town Council, held last night in the Town Hall, His Worship Mayor J. F. Arnett presided. Councillors Wedge and McNeill were absent.

The Town Clerk read a letter from the Minister of Public Works regarding the application of the council for repairs to Queen's Wharf. The letter stated that the needed repairs to 250 feet of the wharf would be made and thus provide the fishermen with suitable wharf accommodations.

Councillor Morrison brought in a resolution which was adopted by the council that all veterans of the Second World War be exempt from poll tax for the year 1946. Councillor Morrison also being adjusted with all possible speed and an automatic switch had been installed for the use of the public garden.

A resolution brought in by Councillor Morrison was also adopted unanimously by the council. It was to reduce the power rates up to 90 kilowatts per hour 7 cents, from 100 to 200 8 cents, from 200 to 300 9 cents, from 300 to 400 10 cents, from 400 to 500 11 cents, from 500 to 600 12 cents, from 600 to 700 13 cents, from 700 to 800 14 cents, from 800 to 900 15 cents, from 900 to 1000 16 cents per hour. All over 1000 17 cents per hour.

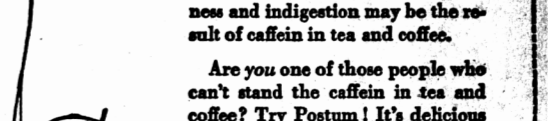

Also in the far North is James Jones, a naval veteran who has a trading post at Inch-tuch-tuch, N.W.T., and owns another at Aklavik.

Teamwork on the part of the Canadian Legion, North Saanich branch, B. C., and the Citizens' Rehabilitation Committee, has solved the housing shortage for

at least 30 veterans of this war... The group purchased a lot of army huts from War Assets Corporation, which were sold in lots of 200 each. Major General C. R. Pearce, V. C., assisted in putting the deal through for the veterans.

A comprehensive survey into the housing conditions in Canada is well under way and valuable data being collected in this respect, according to David B. Mansur, head of the Central Mortgage and Housing Corporation, when interviewed by officials of the Canadian Legion, Dominion Command.

One of the greatest problems in deciding how many housing units are really needed is whether young couples are doubling up with their relatives on account of the shortage, or whether in some cases they are doing so because it is financially expedient, said Mr. Mansur. Through experience they had found that there was a far greater demand for two bedroom houses than those built with three,
