MONDAY

WEDDING BELLS—A very pretty wedding was solemnized at the Presbyterian parsonage, Charlotteown, on Wednesday, Dec. 16th, at 10 o'clock when Mrs. Mary Buchanan, daughter of Mr. and Mrs. Kenneth McLeod, Springton, was united in marriage to Mr. Percy MacIntyre, North River. The ceremony was performed by Rev. W. H. Winchester, pastor of St. James' Presbyterian Church. The bride looked winsome in a dress of brown satin with accessories to match. She wore a rat coat, the gift of the groom. Following the happy couple drove to the home of the bride's sister, Mrs. Hugh Coles, Milton, where a reception was held for the immediate relations of the contracting parties. A large crowd of happy guests assembled to do honor to the newly wedded couple wishing them much happiness for the future after which a social evening was enjoyed.

Between twelve o'clock Saturday night and 5.30 Sunday morning a series of daring robberies, believed to be the work of two young men who are now under arrest, occurred in the city.

It is for the fact that His Worship Mayor Prowse is a light sleeper and that he had the initiative to follow the traces the thieves are believed to have made in new files now after leaving his residence. It is probable that the parties now in question would still be at large. The thieves entered the houses of a number of prominent citizens in no case was actual "break-in" effected, the culprits merely making in where doors had been unlocked.

FUNERAL SERVICES—The funeral of John McNevin was held Thursday afternoon from his late residence 35 Villa Street. Service of the hour was held at 1.30 by Rev. Dr. E. H. Ramsay and Rev. N. Brown who also conducted service at the grave. The funeral was under the auspices of the Masonic Grand Lodge of which the deceased was a Past Grand Master. The pall bearers were: Judge Coffey, Messrs B. W. LePage, M. L. D. Wayne, James Tait, H. Howatt, and E. T. Higgs. Masonic service was conducted by Senator John E. Macdonald, Grand Master of the Grand Lodge while the Oddfellows service was conducted by Hilbert Macdonald, Noble Grand and Frank Macdonald, Chaplain. Besides his immediate family Mr. McNevin leaves to mourn two brothers, Nell McNevin, Charlotteown and Daniel McNevin in California, also two sisters, Mrs. Prowse, Magnolia, and Mrs. Philip Bridges, Charlotteown.

Leaving her two small and only children playing about the house when the full bloom of health and happiness, Mrs. Herbert Currie, Charlotte, had the heart-breaking experience of returning twenty minutes later to find the house a mass of flames and the children wrapped in the burning building, where they perished before assistance could reach them.

The tragedy occurred on Friday, after preparing the noonday meal, Mrs. Currie went to the barn to call her husband, leaving their two children, Chester and Ada May, aged four and three years respectively in the house. On arrival at the barn she found her husband endeavouring to move a wagon into the building. The task being a heavy one, she gave what assistance she could. She was thus occupied about fifteen or twenty minutes. On arriving back at the house, she and Mrs. Currie found the incense of flames and the fire having made such headway that it was humanly impossible to save the children. When the fire, with the

assistance of neighbors, was finally subdued the charred remains of the two children were found among the debris.

Coroner Morrissey of Tignish was notified and proceeded to the scene of the tragedy and after being informed of the circumstances decided that an inquest was unnecessary.

The origin of the fire is unknown. It completely destroyed the house with all its contents.

The Guardian joins with the people of the Province in tendering sincerest sympathy to the bereaved parents.

TOURIST OUTLOOK BRIGHT—Proprietors of summer hotels and boarding houses are already receiving a number of enquiries for accommodation for next summer and quite a few definite reservations have been made. The deceased was about as usual on Saturday in apparent good health, until suddenly stricken.

An issue of \$150,000 five and one-half per cent. twenty year highways improvement debentures of the Province of Prince Edward Island has been sold to Messrs. Griffiths, Fairclough and Norsworthy, Limited, Toronto, at a price of \$93.50. This issue is made under authority of the Act 18 George V, Cap. 2, passed in the year 1928.

The price received compares favorably with that secured for the recent issue of the Province of New Brunswick and with the anticipated price for the forthcoming Ontario issue of \$25,000,000.

DAIRY MEETING—The annual meeting of shareholders and patrons of Emerald Dairymen Association was held on Wednesday, 20th inst., with a fair attendance. President McDonald presided, opened the meeting by referring to the depressed market conditions, and the expenses incurred in operating the factory. The Secretary read minutes of last annual meeting, and also a statement of the expenses of last season, which were on motion adopted. The old board of directors were reappointed for the ensuing year, viz., L. C. McDonald, President; Geo. H. Mayne, Everett Haslam, W. H. Deignan, Marshall Hughes, W. G. McKenzie, Joseph P. Hughes. It was decided to hold a meeting of the board at an early date to consider the advisability of operating the factory during next season, with the expectation of manufacturing expenses being lessened, and tenders for milk drawing &c. called at an early date.

Following is the report of the Grand Jury submitted to the Court after their visit to Falconwood Infirmary and other institutions. To His Lordship and Chief Justice and associate Judges:—We the Grand Jury hereby submit our report to this honorable court. We have endeavored to carry out your instructions delivered to us. We have visited the different institutions and found them in good conditions under the present circumstances.

The Falconwood Infirmary we found in a very clean condition, but under existing circumstances is extremely overcrowded. Trusting that these conditions will be remedied in the near future, we feel assured that the relatives have no occasion to worry. The patients in the small building known as the Convalescent Home are also well looked after, comfortable and warm.

We also visited the refrigeration and cold storage room now under construction, which when completed will be a wonderful acquisition to the culinary department. We strongly recommend that the fire protection be improved by adding at least six fire extinguishers and new fire hose for the fire protection system in the building. And also that a water gauge be installed in the lower tank, which will show from outside view the amount of water contained.

We also recommend an electric pump at the base of the tank connected with regulation sufficient quantities to any building on the premises. We further recommend that fire extinguishers be supplied the jail.

We believe that the time has arrived when the laws pertaining to vehicles on the public highways be lodger.

revised and made more stringent and lights placed on every moving vehicle.

In closing, we would recommend that a stricter supervision be maintained by the management of all institutions and the attendants report when going on and off duty.

We concur with your Lordship regarding the creating of public interest in the general welfare of the inmates along with the social lines of life, making their confinement more pleasant.

Trusting that in future, recommendations of the Grand Jury will receive more consideration than they did in the past, respectfully submitted.

The city's financial affairs, its unemployment relief programme, and activities in various departments during the past year were reviewed at considerable length at the annual meeting of the City Council last night.

His Worship Mayor Prowse presided, all the Councillors being present. The annual reports of the Mayor, the Health Officers, City Engineer, Water Commissioners, School Trustees, and the chairmen of the various committees were read and adopted without amendment.

Complimentary remarks were extended to Mayor Prowse upon his successful leadership by Couns. Foster and Holman in moving the adoption of His Worship's address. Regret was expressed by both speakers at the announced retirement of Mayor Prowse from civic affairs after ten years' valued service on the Council.

In moving the adoption of the Finance Committee's report, Coun. Foster said that despite adverse press criticism he found that compared with other Maritime centres Charlotteown, financially, stood at the top of the list. He referred also to the difficulty of collecting civic taxes during the past year, and in conclusion commended The Guardian's editorial statement of Monday as a fair summing up of the financial situation. The adoption of the report was seconded by Coun. Kennedy, supported by Coun. Holman.

WEDNESDAY

PROBATE COURT—Hon. H. L. Palmer, Judge of Probate, held a session of the Probate Court in Summerside on Tuesday and would up two estates and passed accounts. Mr. H. H. Strong, K. C., and Mr. T. A. Campbell, K. C. were the lawyers.—S.

The Caledonian Club concert at the Prince Edward Theatre last evening in celebration of the Burns anniversary was attended by an audience whose appreciation of the entertainment was most enthusiastic. Produced under the patronage of His Honor Lieutenant Governor Dalton and Mrs. Dalton, and His Worship Mayor Prowse and Mrs. Prowse, the program was one of the finest and most enjoyable given in this city for some time.

The local artists, reintroduced by Mr. Alexander Campbell, noted actor of Invergorry, Scotland, and Master Harold Sutherland, Nova Scotia's champion boy piper of Westville, N. S., gave a performance the individual excellence of which showed conscientious practice and attention to detail, and was a highly creditable to all concerned.

The Prince Edward Island Ayrshire Breeders held their annual meeting in the Agricultural Hall, Charlotteown yesterday afternoon, with the president, Senator J. E. Sinclair, presiding.

Following the reading of the minutes of last year's annual meeting, the president, in his address stated that he was glad to note the fortunate situation which prevailed among the Ayrshire Breeders in the Island. During the past year the number of breeders as well as the number of cattle had increased and it was gratifying to note the progress in these respects. Senator Sinclair urged that particular attention be paid to the weeding out of undesirable stock and that systematic breeding be carried out to build up the herds. This, the president contended, would enable the Ayrshire Breeders to have quality herds which would be readily saleable when the opportune time arrives.

Senator Sinclair urged that if possible a consignment sale be held this year which would assist to keep the Ayrshire breed in the limelight.

AUDITOR'S REPORT
The Auditor's report, submitted by Major MacRae showed that a satisfactory balance of \$66.65 was maintained on the right side of the ledger.

MR. BOULTE'S PROPOSITION

In a press interview in Halifax before leaving by the C. P. R. steam or Montreal on Saturday, Mr. J. W. Boulter, Secretary of the Potato Growers Association, stated there was a possibility of this Province purchasing fertilizer from Great Britain instead of from the United States. Over 30,000 tons, he stated, are imported annually to the Island. If the fertilizer were purchased in Great Britain he felt it would be a strong inducement to the British Government to remove the embargo on Canadian potatoes.

PRESENTATION—The United Church, Belfast, is grateful to Rev. J. M. MacLeod of Charlotteown for the presentation of a fine Pulpit Bible and the new Hymnary of the United Church of Canada. The presentation was made on the 24th inst. by Miss Mima Moore and Miss Annie Smith on behalf of the donor, Rev. J. R. Skinner, Pastor of the Congregation gratefully acknowledged the gift, and spoke kindly of Mr. MacLeod's services to the congregation. While the presentation was being made, the congregation showed their appreciation and gratitude by standing up, and at the close of the service, they went up to the pulpit, and examined the two books, each with the inscription: "Presented to the United Church, Belfast, by Rev. J. M. MacLeod."

SUPREME COURT—Yesterday morning at the Supreme Court Frederick J. Lambe, convicted on a charge of rape was sentenced by Chief Justice Mathison to ten years in Dorchester penitentiary. The prisoner when asked by the Court had nothing to say, and received the sentence without emotion.

A witness, William Reddin, was heard by the Court before the sentence was passed. The witness testified to the previous good character of the defendant. The hearing of the appeal case of Theodore George versus the City of Charlotteown was then resumed before Judges Arsenault and Saunders. Mr. J. J. Johnston, K. C. for the appellant further contended that the charges should have been directed against the corporation and not against the manager. The case was then resumed by Mr. Donald MacKinnon, K. C., also counsel for the appellant. Mr. K. M. Martin, counsel for the respondent contended that the By-Law in question was not made on moral grounds and not contrary to the Lord's Day Act but was simply a regulation to provide for particular conditions in the City. In reply to the contention of the appellant's counsel that the operation of restaurants was an act of necessity within the meaning of the Lord's Day Act the respondent's counsel submitted that on hours which covered the hours of necessity the restaurants were allowed to remain open. A point arose on which the Court decided supplementary briefs should be submitted. Judgment was accordingly deferred. The Court adjourned until March 14.

THURSDAY

The Hillsboro Harbor is fairly well filled with ice at present. The steamer made her last trip on Thursday Jan. 21. The ice-boat is now in operation, being manned by Messrs. Augustus McMahon and Artemus MacKinnon. Heavier frosts is almost a necessity now for residents on this side of the river, even though prices are low a considerable amount of hauling remains to be done.

Mr. Boulter, who is now en route to England in connection with the urging of the removal of the British potato embargo, states in his report his attitude that under no circumstances should the industry in this country be endangered by allowing European potatoes entry to Canada.

Following the afternoon discussions and evening addresses, the election of officers for the ensuing year took place and resulted as follows:

The afternoon session opened at 2 p. m. Owing to the absence of Mr. J. W. Boulter, Secretary of the Association, the minutes of the last meeting held on January 27, 1931, were read by Mr. W. L. Brenton, Provincial Dairy Inspector and adopted by the meeting.

An interesting and informative review of the past year's work was then presented by the President, Mr. John A. Dewar, of New Perth. Mr. Dewar's address is given below.

The financial statement of the Association was then presented by Mr. Brenton and adopted. The report showed receipts for the year of \$1,164.45 and a balance on hand of \$115.51.

The following committees were then appointed by the President:

Resolution:—Messrs. Peter Brodie, J. B. Clay and Roy McLean.

A report thoroughly covering the field of dairy work was presented by Mr. Brenton, Dairy Superintendent.

Mr. F. T. Morrow, Dairy producer grader, gave a comprehensive review of butter and cheese grading giving details of grading methods and statistics of production. He stressed the necessity for producing quality. The statements showed a total of 5,287 boxes of cheese graded, the average score being 90.020 as against an average score of 92.131 for all Canada. 3,034 boxes of but-

Prospects of a better potato market in 1932 due to anticipated decrease in acreage this year were noted in a report on the potato marketing situation prepared by Mr. J. W. Mr. Boulter, who is now en route to England in connection with the urging of the removal of the British potato embargo, states in his report his attitude that under no circumstances should the industry in this country be endangered by allowing European potatoes entry to Canada.

An increase of 8,819 dozen eggs handled in 1931 over the previous year, the total amounting to 1,504,863 dozen, the largest amount handled since the organization of the Prince Edward Island Co-operative Egg and Poultry Association in 1914, was reported by the directors at the annual meeting of the Association yesterday. Membership in the Association also showed an increase last year of 643 new members. The gross turnover for the year amounted to \$361,704, a figure which was considered very creditable in view of the low price of eggs and other agricultural commodities.

"We look to the future," the directors stated in their report, "with faith and confidence. One swallow does not make a summer, neither does a period of low prices and depression, whatever the underlying causes may be, mean that we give up in despair and throw our past efforts into the discard." The annual meeting of the Association was held yesterday morning and afternoon in Prince of Wales College Hall, with the President, Mr. J. R. Munn in the chair.
