GUERRILLA WARFARE

Now Being Carried on by The Boers.

BULLER ASKED BOTHA To Surrender—Boers Have Plenty Guns But are Short Of Stores.

Apparently the Boer guerilla warfare is on. SOME FIGHTING LEGISLATORS.

Parliamentary returns show that 28 Commons and 36 Lords are with the troops in South Africa.

BULLER AND BOTHA ARMISTICE.

Gen. Buller reports that on June 2nd he met Botha and called on him to surrender the big guns, go on their farms and await Lord Roberts' decision, and Botha asked time to consult the Burghers.

So an armistice was granted at Botha's request.

PLENTY GUNS BUT SHORT OF STORES.

The Boers opposing Buller have 23 guns and their only line of retreat is in the direction of Lydenberg, while their supplies are not likely to last more than six weeks.

SOME CANADIANS ON FURLOUGH.

The Canadians at Shorncliffe Camp have been granted a furlough and many of the men are now with relatives and friends throughout the country.

THE LOCAL LEGISLATURE.

SATURDAY, June 9.

House met at 11.30. Hon. Mr. Gordon arose to a question of privilege. A member of the Legislature stated yesterday that a Conservative had offered him \$350 if he would vote against the Prohibition Bill. Mr. Gordon moved a resolution asking for a committee of the whole house to investigate the matter. He thought the alleged would-be briber should be brought to the bar of the House.

Mr. Shaw seconded the resolution. Mr. Pineau reiterated his statement of Friday on the matter.

Mr. A. A. McLean emphasized the necessity of bringing the matter up by way of investigation.

Mr. J. A. McDonald agreed with Mr. McLean's views.

Hon. Mr. Farguharson stated that the member from Tignish was now in his seat in this legislature. Notwithstanding the sneers of the opposition that member had conducted himself as a gentleman in this parliament.

He affirmed that Mr. Pineau had never stipulated for one dollar, directly or indirectly, nor had he recovered any promise, in considering of the same and taken in this House.

The accusations to the contrary come with poor grace from the members of the opposition. Why did they not go on with the previous investigation as they had been challenged to do. No but they drag in this charge on the very day of prorogation. The member for Belfast would rather see his grandmother's ghost than have an

advocating 'temperance' principles and temperance reform. During recess and during the present session the Leader and the Liberal Government of the Province had been charged with legalizing the liquor traffic in the city of Charlottetown. Personally he had always been an abstemious and he felt that the Government had been wrongfully charged. The conditions which existed when the present Government enacted the tax act of 1899 had never been fairly and squarely placed before the people and hence the Government was condemned. With regard to the state of affairs when the law was passed, all know that it was free rum, brought about by the vote of the city of Charlottetown, a state legalized by the people and by the people's votes. Consequently by the vote a free liquor traffic was made possible and which

ment is in power in Manitoba. The Conservatives of this Province had voted for Prohibition and they would be rewarded by the people.

Mr. Birch then commenced to speak in endorsement of Mr. Gordon and Mr. Prowse but Mr. Peters rose to a point of order and said that at the third reading of a bill discussion was out of order. The bill was then passed unanimously.

The closing proceedings of the Provincial Legislature were largely attended Saturday afternoon in spite of the rain.

After his arrival and taking his seat in the Speaker's chair His Honor, Lieutenant Governor McIntyre delivered the following speech:

Mr. Speaker and gentlemen of the Legislative Assembly:

As your Legislative duties are now concluded, I have much pleasure in acknowledging the diligence with which you have devoted yourselves to the work of the Session, and I must congratulate you upon the important measures which you have enacted, and confidently trust they will, under the blessing of Almighty God, contribute to the prosperity of this Province.

The Act to prohibit the sale of intoxicating liquors within the Province is an advanced step in legislation and will, no doubt, conduce very largely to the moral as well as the material benefit of the whole community.

I thank you for the liberal provision you have made for carrying on the public service, and I assure you the moneys will be disbursed with the strictest economy.

RUSSIA SECRETLY AIDS THE BOXERS.

On motion of Mr. Peters the House went into committee with Mr. Forbes in the chair, on the bill to diminish unnecessary delay and expenditure in the Court of Chancery. Reported agreed to and rule being suspended the bill was passed.

Mr. S. E. Reid said that as intimated at the second reading of the Prohibition Bill he wished to make a few remarks. It was always with some reluctance that he addressed the House, but on the present occasion the subject was an important one. It was the most important Bill that had been introduced to the Legislature for many years. He was a prohibitionist, first last and always, and as such he considered the Bill now about to be read for the third time, a decided step in advance of any measure received by the temperance people and should meet with the cordial endorsement of that section of the press that had been in the habit of

was an actual license to sell. Before the voice of the electorate decreed free rum the Scott Act was in force. The Government added a restriction by saying to the liquor seller "we will tax you and you must pay the tax or quit the business." During the session of 1890 the right of prohibition by Provinces was not brought up. More light had been thrown upon the subject since then and he believed the Privy Council had decided that prohibition by Province was possible. To-day he was proud to say that he had a hand in, something to do with the bringing about of the present measure which the Hon. members were asked to vote upon for the third time to make it law. While he was proud to be the instigator of the measure he was prouder still to be able to vote for it. He was also happy to belong to a party and support a Government that presented such a bill to the Legislature and he was confident if this Government were still in power when the provisions of the bill are put in force the people of the Province of Prince Edward Island will have the best law they ever had to restrict the traffic. He regretted that hon. members on the other side of the house had taken up the time of the House and attempted to obstruct the passing of the bill. He had always believed in Prohibition. Failing Dominion Prohibition he had always contended that Provincial Prohibition should be enacted. Failing prohibition, all restriction possible should be enacted. He then quoted from an article by John B. Finch in support of his contention.

Mr. McLean took strong exception to Mr. Reid's reference to the Opposition when he stated they had attempted to obstruct the passing of the bill. He claimed that the statement would go to the country through the press and that the statement had been made to place the Opposition in a false light before the electorate. The Opposition had offered important amendments which were vital to the bill. He then asked Mr. Reid to retract the statement made against the Opposition.

Mr. Reid said that what he stated in his remarks was true. The members of the Opposition had taken up the time of the House in obstructing the passing of the Bill.

Mr. Reid then referred to Mr. Geo. E. Foster's inactivity on the temperance question and condemned the Royal Commission.

Hon. Mr. Gordon said he could see the reason Mr. Reid took such ground. He wished to state that the Opposition were as anxious, and more so, to place a prohibitory law on the statute books. He personally was as anxious and so were the Opposition. The amendments introduced would have made the bill a strong one.

Mr. A. P. Prowse said he regretted Mr. Reid's remarks. A Conservative Govern-
