related by marriage to one of the accused. They were excused from their duties by the court.

It was then agreed by counsel for the Crown and defence that the ten remaining jurors would be allowed to act on being re-sworn and that they would proceed with the remaining two names on the panel. Both of these were challenged by the defence.

The court then instructed Sheriff John McFadyen to go out and select twelve men from whom the two necessary to complete the jury, would be chosen. Before the noon recess the balance of the panel was excused from attendance until 11 o'clock Thursday morning.

When the twelve additional jurors were brought in, after a recess of an hour and a quarter, seven were challenged by the defence and three were excused. The two jurors, Ralph Jenkins and George Sutherland, both of Charlottetown, were selected.

The jury clerk has as follows: Ralph Jenkins (foreman) Charlottetown; George Sutherland, Charlottetown; Jerry Adams, Sea View; William O'Shea, James Doyne, North River; Robert A. York, Hector Darrach, Clyde River; Joan MacDonald, Rice Point; Gordon M. Crockett, West Bay; Wood A. Alexander, William Molyneux, North River; Wendell Morrissey, Union Road.

Attorney General Campbell and Mr. St. Clair appeared for the Crown, and Mr. Lester P. O'Donnell for the defence.

Mr. Trainor in opening the case to the jury emphasized the seriousness of the charge. He explained the meaning of murder as laid down in the Criminal Code. He said that evidence would be presented that Peter Trainor, who lived alone and conducted a grocery business, was found dead in a storeroom at the back of his store. Doctors would give evidence relating to the extent of the injuries suffered by the deceased. There were 22 wounds in all, the most serious of which were the spinal column and went two-thirds way through the neck. Police-men would give evidence showing that Lind was caught in a jump from an upper window of the house and Phillips was arrested upstairs after a struggle. There was also evidence to be given regarding the clothing of the accused.

would probably be merely a mopping-up operation.
The time limit of three months was based on climate and weather conditions and the state of Russia's transport system. Fall rains would tend to bog down the whole campaign.
The Nazi high command, it was noted, chose a time when the crops of the Ukraine are green and difficult to destroy by fire. Later in the season grain fields might be burned by the Russians to prevent the Nazis from gaining any immediate increase in their food supply from that region.
Should the Nazi invasion succeed in a month, it was believed that time might remain for an all-out attempt to conquer Britain this year.
Whatever the speed of the German triumph in Russia, it was estimated that at least six months would be required to repair the ravages of the fighting.
In Poland it was noted the German army was careful to spare roads, bridges and other useful facilities wherever possible. Whether they can follow this policy in Russia depends on the resistance encountered.

Recruits wanted In R.C.N.V.R. Division here
A new complement of 47 seamen and stokers has just been completed and the men are now receiving training at the R.C.N.V.R. barracks in Charlottetown. Recruiting for these ratings is continuing, and satisfactory numbers are being interviewed daily.
There is, however, a demand for a considerable number of desirable recruits in the various trade branches and qualified men will be taken on active service immediately.
Chief Motor Mechanics, aged 21 and motor mechanics in the same age group are needed at once. For the former rank three years apprenticeship as a machinist is required, as well as experience in repairing internal combustion engines. In the latter class men with three years experience in motor repair shops or garages, repairing engines are included.
Senior Petty Officers and Leading Stokers are also required. Men with experience as stationary electricians and running hoists, or engine room fitters, utilizing high pressure steam are needed in these classes.
Engine Room Artificers, particularly fitters and turners, aged 21 to 40, are required and there are also openings for qualified cooper-smiths and engine smiths in this branch.
Sick berth attendants, cooks and writers are also needed. Junior bank clerks and experienced office workers are suitable in the last group.
All these classes of tradesmen are urgently needed by the navy at present in order to carry on the program of the rapidly growing Canadian Navy and interested men should report at the R. C. N. V. R. Division in Charlottetown, or write stating qualifications, and an interview will be arranged.

AGRICULTURE
On upgrade Rotarians told
Agriculture is out of the long dark years of depression and afterwards, was the gist of remarks made by guest speaker Mr. W. J. Reid, of the Department of Agriculture, addressing the Rotarians yesterday.
Thanks to the bacon contract with the British Food Ministry Canadian hog production increased 43 per cent in 1939-40, and made a further jump of 50 to 55 per cent in 1940-41. This contract was a godsend and without it, agriculture would have been in a very bad way. The year 1939-40 was one of the worst agriculturally known to the oldest inhabitants.
Today, said Mr. Reid, the picture is greatly changed for the better. Because of the interplay of unusual factors, ordinary cycles of production have been disarranged with a favorable reaction on agricultural production and prices.
Mr. Reid cited the price of butter as one of the bright spots in the new outlook, and also gave a personal prediction that Maritime cheese would bring good prices for at least this year.
Mr. Reid's survey of agriculture was most encouraging, and he voiced the hope that farming would never again be treated as the poor relation among Canadian industries.

Horse disease Breaks out In Saskatchewan
REGINA, June 23—(CP)—An epidemic of equine encephalomyelitis, horse disease sometimes known as sleeping sickness, threatens Saskatchewan and both farmers and scientists were rallying their resources today for a bitter battle against the disease.
Agriculture Minister J. G. Taggart issued a statement advising farmers to have their horses vaccinated. He said the outbreak had not yet reached serious proportions but warned farmers to be on the alert.
The Agriculture Department has received reports of only five deaths from the disease so far, all in the Elfrors district 30 miles east of Saskatoon.
There were outbreaks of encephalomyelitis among Saskatchewan's horse population in 1935 and 1937, and a serious epidemic in 1938 killed 15,000 horses.

days and Sundays, cannot be counted as "waiting days" between registration and the first benefit day.
A person is not considered unemployed if he continues to earn more than \$1 a day and the job which brings in this money would ordinarily have been carried on in Spain, in any employment and outside regular working hours.
Benefits are not payable during periods of illness. Those who leave their jobs voluntarily without good cause or who are dismissed for misconduct are disqualified from receiving immediate benefits.
Benefits can be obtained if unemployment is due to a strike, but only if the applicant can prove that neither himself nor any of his grade or class of workers employed at the premises prior to the stoppage of work were taking part in financing, or directly interested in the dispute which caused the strike.
The worker may collect benefits if work gets slack and he is working only a day or two each week.
When a dispute arises over payment of a claim, the case will be reviewed by the insurance officer of the district and may be allowed or disallowed by him.
Where there is a question of disallowance of a claim on the grounds of participation in a labor dispute, dismissal for misconduct or quitting a job, the claim goes to a court of referees consisting of representatives of employer, employees and a chairman appointed by the Government. Beyond the court of referees, appeal may be made to an umpire, whose decision is final.

The body of 18-year-old Willis MacKenzie was recovered from the waters of Fortune river, 40 miles from Charlottetown yesterday. He lost his life in a bathing accident there Sunday afternoon.
The young man was a former resident of this city and was working at Fortune during the lobster fishing season. He was in bathing in Fortune River during low tide Sunday. Several, scarcely more than children, were the only witnesses. They said when MacKenzie had almost reached a buoy marking the channel he appeared in difficulty. He grasped for the buoy but missed it and sank at once not to reappear.

He pointed out, however, that President Roosevelt had full authority under the act to extend lease-lend aid to all countries defending themselves against aggression.
Diplomatic matters expected that Russia would not immediately request lease-lend aid but instead would seek release of frozen Russian assets in the United States and permission to buy and export vital defence materials.
As to the government's policy on exports of defence materials to Russia, Mr. Welles said that requests for licences are all considered in the light of defence requirements in this country and in accordance with the general defence policy of the government. Thus it was considered likely that Russia would be allowed to purchase whatever materials could be spared.
The American government is seeking more complete details, Mr. Welles said, before President Roosevelt can announce the neutrality requirements by issuing a neutrality proclamation.
