CONCLUDING SESSIONS OF PRESBYTERIAL

Mrs. W. E. Aitken, St. Peter's, Elected President—Sessions Held At Trinity United Church.

The P. E. Island Presbyterial of the United Church of Canada met for its annual session Jan. 20th, in the Memorial Hall, Charlottetown. The meeting of the Executive was held at 11 o'clock. The first regular session was held at 2 o'clock with a large number of delegates present from various societies throughout the island. A service of worship was led by Mrs. W. A. Thompson, Charlottetown, with Mrs. Hammond Kelly presiding at the piano. Then Mrs. Baker, Mrs. Matheson, Mrs. Paterson and Mrs. Newsome each led in short prayer.

Mrs. (Rev.) George Miller then came forward, and on behalf of Trinity W.M.S. extended a very hearty welcome to the visiting delegates. Mrs. J. F. Easton, of Hampshire, then made a very fitting reply to this address of welcome.

Miss Elma Inman then took the chair, and read the names of the Resolutions Committee and Press Committee—namely—Resolutions, Mrs. H. Johnson, Mrs. Harrison McFarlane and Mrs. Walter Shaw, Press Committee—Mrs. Clara McQuarrie, Mrs. Frank Deacon and Mrs. J. F. Easton.

A Nominating Committee to receive names for a delegate to go to Summer Training School at Berwick was named as follows:—Mrs. Hazen Howard, Mrs. Fred Watson and Mrs. Heath Vesey. The Question Box was then introduced by Mrs. Baker, of O'Leary.

Miss Inman then called on the Secretaries of different departments. Mrs. E. R. Woodside, Recording Secretary, gave her report, showing 1272 annual members and 354 life members in our Presbyterial. Literature Secretary, Mrs. Frank Deacon, then gave a good report, explaining she was filling the office formerly held by Mrs. John Profit, Freetown. Mrs. J. D. McFarlane, DeSable, then brought in a very encouraging report of an increase of subscriptions to both Missionary Monthly and World Work.

dangerous practices, should be taught children in the public schools. He was not saying that as an excuse for the accident.

In order, it was pointed out, that the jury should fully understand the duty the Court proceeded to explain the law regarding manslaughter.

The indictment was for manslaughter, that was culpable homicide not amounting to murder. That was the unlawful or blameworthy killing of some person. The killing of a person was unlawful when it resulted from some unlawful act or from the omission of an act without lawful excuse, to perform or observe some legal duty or both combined.

A duty was imposed on the driver of a motor vehicle to use all reasonable care to avoid any danger. But an accident might occur where there was one or two conditions: first, where the driver was guilty of a momentary lapse from duty. Such a momentary lapse from duty did not constitute criminal. Or, second, there might be an error of judgment on the part of the driver. An error in judgment was not an excuse in a civil action for damages for injuries but it was not considered a criminal act. A situation might arise where there were several things to do and only a momentary lapse from duty through an error of judgment. The law did not consider that error criminal and worthy of punishment.

Therefore if what happened in Mrs. Thompson presided at the Memorial Service, and Mrs. Hocking gave the address. At the close of this service the Sacrament of the Lord's Supper was observed. The ministers taking part were: Rev. Hugh Miller, Rev. A. E. McKenzie, Rev. H. Pierce and Rev. J. M. McLeod.

At 10.30 another session convened in Hearty Memorial Hall, presided over by Miss Elma Inman.

A discussion took place as to best time for the Presbyterial gathering. A motion was then put to the meeting, that for 1937, we have our Presbyterial in June. This motion carried. It was also moved and seconded and carried, that the summer rallies be continued.

the case before the jury was an error in judgment it would not amount to criminal negligence. Speed in a motor car was only a relative thing, the Court told the jury. What might be considered excessive in one case would not be in another. It depended entirely on conditions that had to be met. A perfectly safe speed on an open road in the country would be excessive through a village.

Manslaughter was a crime, the person who committed it a criminal, that was one that came within the provisions of the Criminal Code.

Before a person could be found guilty as a criminal he must have committed a crime.

Those who were trying the case had a duty to perform. First there must be a favorably shown and on the other hand a person must not be found guilty because there was a feeling that there was a much reckless driving. A person not guilty must not be punished simply as an example to others. Each case must be tried on its own merits.

So far as the evidence was concerned he did not propose. His Lordship said to review it at any length as that had already been done by the Attorney General and Counsel for the defense.

If the accused was right in saying that he was at Duffy's lane when he saw the child and if he was travelling at the rate of 30 miles per hour then in the 75 feet he had to travel before he struck the child he had only one and one half seconds in which to make up his mind. That's the test of the good driver, he instinctively does the right thing. His Lordship said. It was possible in this case that there was an error of judgment. What was to be considered was whether in the circumstances Phillips was driving at a reasonable rate of speed. There was no evidence except his own and two facts, one that when he struck the child she was pitched over the other that he struck the bank with considerable force. Both things might happen, however, at the rate of speed the accused said he was travelling.

The question of brakes had come up but the Court considered that they did not enter into the matter at all. The accused said he did not apply brakes and whether it had been better to apply the brakes or to swerve was what the driver had to decide in that one and a half seconds.

It was an offence against the statutes to go with defective brakes; but if an accident happened when brakes were not a factor in the accident then brakes were not a factor in the case. The only way brakes would enter the case was if they should have been applied and were not. But there they have been an element of criminality entering into the case before the accused could be found guilty, the court told the jury. There must have been such gross negligence as amounted to criminal disregard for the safety of the public or this child.

And lastly the court reminded the jury if after the whole consideration of the case there was a doubt as to the guilt of the accused then the prisoner was to have the benefit of that doubt.

In his opinion Mr. Justice Arsenault said the accused was either guilty of manslaughter or guilty of nothing. There was a provision, an amendment to the criminal code, which had to do with manslaughter cases arising out of the operation of a motor vehicle, but it seemed so uncertain that he felt that it might be better for all concerned if it was not referred to a person guilty of the lesser offence when the person was not guilty at all or of finding a person guilty of the greater when he was guilty of the lesser. As the defense had said the burden of proof was on the Crown. The accused claimed it was an accident and it was for the Crown to prove otherwise.

"No Enthusiasm" In Pictou County Over Ferry Scheme

The following comment is from the New Glasgow Evening News of Jan. 20:

"Scant attention is being paid in Pictou County to this Wood Islands-Cariboo car ferry proposition that was recently announced in the newspapers as one of the moves to bring about better business between the Island and the mainland. Feeling in Pictou County is pretty much of a 'pooh-pooh' variety; our citizens cannot work up any enthusiasm for it for the simple reason they do not believe it will ever take definite shape.

"For one thing it is hard for the average Pictonian to put any faith in the Cariboo end of the scheme—tidal waves are heavy there and why should the good old harbour of Pictou be passed up?

"But that is where the average Pictonian is wrong. The possibility of a ferry becoming a definite business is becoming more certain day by day.

"The Islanders are deinitely for it. That much can be gleaned by a study of their newspapers which have carried editorial comment and news stories of meetings favoring completion of the plan. They are frankly for the Cariboo terminal because it allows a 12-mile water jump.

"The idea behind it all is to market farm products and bring back cheap coal from the pit head. The average farmer has his own truck and with a short water passage, will be enabled to reach mainland markets in Pictou County, Halifax and Cape Breton. Instead of taking back an empty truck, he will pull into one of our mines and load up with coal.

"That is where Pictou County swings in to benefit. We lose of course in that our farmers will have a still harder job to compete in local markets."

INCREASE IN POTATO YIELD

OTTAWA, Jan. 21—Total potato yield in Canada in 1936 was 39,034,000 cwt. compared to 38,700,000 cwt. in 1935. The Dominion Bureau of Statistics reported today in its estimate of field crops during the past year.

acreage was estimated at 496,000 acres with average yield 7.7 cwt. per acre. Average price was \$11.3 a cwt. and total value of the year's production \$444,841,000.

Quebec led the provinces in potato yield with total of 12,336,000 cwt. at an average price of \$1.08 a cwt. Ontario was next with a total of 8,700,000 at an average price of \$1.35 a cwt.

New Brunswick was third with 5,623,000 cwt. at average price of \$1.05 a cwt. and Prince Edward Island produced 3,941,000 cwt. at average price of 86 cents a cwt. Nova Scotia produced 1,957,000 cwt. at average price of \$1.13 a cwt.

Production in western provinces was: Manitoba 1,006,000 cwt., Saskatchewan 1,635,000 cwt., Alberta 1,816,000 cwt., British Columbia 1,999,000 cwt.
