Ottawa, Ont., March 13—Of the \$71,796 reparations paid Captain Freeman Hatfield for the loss by enemy action of the schooner Gypsum Queen, his counsel, Senator Hance J. Logan of Parrsboro, N. S. received \$6,400 for himself, he testified before the Harvey Commission yesterday. This was made up of \$2,500 expenses and \$3,900 which Senator Logan received from his client for 390 shares of preferred stock of the Maritime Coal, Railway and Power Company. Senator Logan had taken the case without fee other than his expenses, he said, but had needed money and disposed of those holdings to Captain Hatfield who was looking for good investment.

Later he had met Captain Hatfield in Montreal and the latter had entrusted him with \$28,500 for investment in Canadian securities at the discretion of the witness; Senator Logan testified.

He had invested in Montreal tramway bonds, Montreal Island Power bonds, and Beauharnois Power Corporation bonds to the extent of \$22,000 and forwarded the bonds to Captain Hatfield in the United States. A letter from Captain Hatfield acknowledging these securities was filed. He was asked to invest the remaining \$7,000 or forward it to the Captain.

and Parrsboro, N. S., Saint John, N. B., and New York, and all last week set again in Ottawa.

Senator Logan, resident of Parrsboro, N. S., where the Gypsum Queen was built and former home of Captain Hatfield, was the Counsel for the claimants in the Gypsum Queen case. He was called by his Counsel, L. A. Forsyth, K. C., now of Montreal, but also a native of Nova Scotia, to give the commission a complete narrative of his connection with the claim.

The witness, who though nearing seventy years carries his more than six feet of massive height as erect as a skyscraper, swore that he had accepted the case of his penniless old friend, Captain Hatfield, without retainer and received only his expenses; that he had not been guilty of the slightest irregularity in securing information as to the registry of the Gypsum Queen; and that subsequent reports of changes of registry existent at the time the claim was made, and an affidavit held in England allegedly made by Captain Hatfield in 1915 to the effect that his ship had foundered in a storm, "astounded and paralyzed" him when brought to his attention after payment of the claim.

Evidence given before the commission at Parrsboro, N. S., by John S. Henderson, shipping master there, and his assistant Miss Pettigrew, was branded as "incorrect" by the witness. He refused to call it perjurious although Peter White, cross examining, insisted that if the witness was telling the truth his fellow townspeople had deliberately perjured themselves.

with the present programme are being issued by the police authorities and are from police authorities alone and when Col. Lindbergh has a message to communicate to the press he will do so through the means of this bulletin and in each instance it will be specifically stated that the message comes from Col. Lindbergh.

"Statements on these bulletins under any circumstances are from Col. Schwarzkopf, speaking for the police authorities alone.

"Classification of the fingerprints of Betty Gow and Henry Johnson have been sent to Foreign countries and also to the international fingerprint exchange at Vienna. These were followed by copies of the fingerprints being sent by fast mail. No reports have been received as yet.

"Col. Lindbergh has not left his estate at Hopewell at any time since the kidnapping and is at the estate now.

"Continuous investigations are being conducted and numerous leads have been traced down without disclosing any definite information of a concrete nature leading to a solution of the case."

Definite announcement was made that Col. Lindbergh had spent the 12th day since the kidnapping at his bleak hilltop home, but the whereabouts of the secret emissaries of the Colonel, who are making a private hunt for the baby was as much of an impenetrable mystery as ever.

Morris Rosner, the undercover man, who said yesterday he possessed definite knowledge the baby was safe and would be returned, was absent from his New York apartment, presumably in connection with the "delicate" work he said he was carrying on at that time.

Likewise, there was no word of the activities of Saly Spilane and Irving Eitz, the underworld intermediaries appointed by the Lindberghs a week ago today.

The police also discarded from the official search Salvador Tomaselli, who was not further identified, and Dominick Puero, a former Brooklyn grocer, who lived near the Lindbergh estate.

"His (Puero's) absence is accounted for," said police, "by the fact that he is employed in Brooklyn and visits with his family over the week end."

In eliminating "two gangs," from the inquiry Col. Schwarzkopf said:

"Since the issuance of Bulletin No. 5 (timed 10 p.m. Saturday) four investigators have returned from trips in Brooklyn and North Jersey after completing a check up on two gangs supposed to be connected with the case. While the information seems to be reliable, nothing was found to indicate that the men named could in any way have been involved. They have been eliminated."

Meantime, Henry (Red) Johnson, seaman suitor of Betty Gow, Lindbergh nursemaid, was described by Deputy Police chief Brek of Newark as cleared of participating in the kidnapping, Johnson, who had been questioned since he first was detained at Hartford, Conn., a week ago last Friday, still faces deportation for illegal entry into this country in 1927.

Permitted to talk to reporters for the first time last night at Newark, Johnson made the surprising statement that he believed the kidnapping to be an "inside job." In the same breath, Johnson exonerated all members of Lindbergh household and refused to amplify his expressed opinion.

Brek said he was convinced Johnson had telephoned Miss Gow at the Lindbergh home in Hopewell from an Englewood, N. J. drugstore at 8.47 p. m., the night of the kidnapping and that Johnson visited an Englewood confectionery at 9.30 p. m. the same night.

Johnson said he met Miss Gow last August when the yacht of Thomas W. Lamont on which he was a sailor anchored off North Haven, Maine. At that time Miss Gow had the baby at the Dwight Morrow summer home near North Haven.

When the Lamont yacht later was off the New Jersey Palisades, he met Miss Gow, who then was at the Englewood home of the Morrises. Johnson said he had engagements with Miss Gow two or three times a week at Englewood, but he never had been to the Lindbergh home at Hopewell.

He admitted to reporters that he had entered the United States in 1927 by jumping ship when a Norwegian-American liner was docked in New York. He has hopes now, he said, of making his own way back to Norway and returning later to establish residence in this country. He already has applied for citizenship, he said.
