There again we had most glorious weather. I had not visited the Island since 1896, and even 17 years had brought a most wonderful change in the Island. The old wooden business houses had given place to very handsome stone buildings, and whereas formerly palings used to surround the yards of the houses, now they all have been removed and beautiful lawns put in, so that in driving through some of the streets you might almost be driving through the parks of a country town. Here we spent a few days, going back to Montreal."
