Rev. Dr. S. D. Chown presided, and the court came to the decision that it had no jurisdiction, because the charter of Wesley College was so broad that the college board had the power of dismissal. The court, Dr. Chown stated, did not, for this reason, go into the merits of the case.

Charges had been made by Dr. Smith that the discipline at the college was not what it should be, and that the conduct of certain of the students was improper. Smoking, and even drinking, within college precincts was mentioned. Differences that arose following these charges led to the dismissal of Dr. Smith, and an avowal of confidence in Principal J. H. One Sermon Quite Sufficient

OTTAWA, Sept. 11.—Lack of education in the Bible was declared the weakest point in the armor of the Church, not only in Canada, but in other countries, by Rev. S. P. Riss, D.D., professor in the Wesleyan Theological College, Montreal, in an address before the evening session yesterday of Ottawa district in Eastern Methodist Church.

"A generation is growing up whose knowledge of what the Bible contains is of the very slightest. Half the ministers' texts might as well be taken from Plato as from the Bible."

Dr. Rose was of the opinion there was too much preaching. That was one reason why the Bible was not better known. One sermon a day was sufficient for any minister and people. The other service should be one of instruction. Ministers were prone to announce flippant texts.

"There is something radically wrong in our Church educational system that we send out teachers and preachers without knowledge of what is fundamental. Young men coming into our colleges know little about the Book. You cannot blame the public schools, nor hurl epithets at the state, nor say the home is at fault. It is the Church."

Rev. J. H. Arnup, mission secretary of Toronto, spoke on the foreign missions of the Church. An especially fine type of young man was offering himself for the mission fields now, he said, and the missionary outlook was very bright.

It was decided to have an educational Sunday the third week in February; to make October 8 in August Sunday for the mission program, and December 10 anniversary Sunday for mission collections.
