The Abegweits and Saint Dunstan's scheduled to meet this afternoon are, figuratively speaking, now waiting for the whistle which will send them away in the 1927 local football inaugural. These teams in the past have provided thrills aplenty on the home gridiron. Good natured, but keen rivalry has featured every meeting, therefore today's opener should be hard fought and interesting from start to finish.

Bruno In City

Frank Bruno arrived in the city last evening and looks in the pink of condition for his coming mat struggle. He appears much heavier than Patterson, but weight does not signify to any extent any advantage. Bruno is a clean-cut and likeable champion, four straight games to win the World's Series. They had the punch and they had the balance.

Once again the honesty of baseball and the World Series was established. The suspicious-minded and the doubters are silenced for the moment, but they will break out again on the slightest provocation. The Yankee Stadium was empty and silent on Sunday last instead of being jammed with paying customers. An attraction worth over \$200,000 went to waste because the players went out to win their share of the spoils as quickly as possible. Fully half a million dollars were tossed off by the series ending in four games instead of going the limit of seven. The cry of sordid commercialism in baseball is reduced to a husky whisper. All is not sham. Ed. Barrow will testify that, as much of the money in for the fifth game is refunded and before Monday all who bought tickets will have received a refund. His may be a mournful job, but in a way, it is a happy one for baseball.

Robert L. Ripley says that George Pipgras, who pitched the Yanks to their second victory in the series, in such an effective manner, is to baseball what "Reprisal" is to racing. In 1921 he cost the owners of Madison, S. D., Club just 60 cents. Reprisal cost his present owner a nickel, a half of a dime. These are facts, not fiction.

"Fastest Human" Will Try to Come Back

It seems as if Charlie Paddock who has been running for fourteen years and who held thirteen world's sprint records, would have enough in the running racket—at least would be slowed down to such an extent that he couldn't be considered dangerous now against a strong field.

Strange to say, Charley is not through. Neither does he think he is so terrible slow. Far from it, if one will only take note of his plans for next year.

The smiling young man who is generally termed "The Fastest Human," wants to make Uncle Sam's 1928 Olympic team and he wants to break Roland Locke's mark in the 220 before he calls it enough.

Paddock once held the record for the 220 that Locke now holds. That then was his 14th world record; and he prized it highly as he does the other ones. But Locke came along in 1926 and covered the 220 yards in 20.5 seconds to shatter Paddock's mark.

From his home in Pasadena, Calif., comes word that Paddock is going to start an intensive training campaign in February for a place on the United States Olympic team. Nothing, says Paddock, is going to interfere with his siege of training.

Not over the man who has been keeping up with the best of them for fourteen years, must seem an "old man." In years Paddock is still young, having celebrated his 27th birthday last August, but as a runner he is stamped a veteran.

Paddock has created 32 records in his career, 14 world records and 13 of the latter still stand. His marks cover distances ranging from 50 yards to 300 meters for turf as well as regulation tracks. Between 1921 and 1924, he ran the hundred 11 times in 9-6 seconds.

Paddock created his 9.5 mark for the hundred on May 16, 1926, just two years after a pulled muscle during the Olympic games and caused many predictions to be made that he was through.

But he's not through yet—and "The Fastest Human" hopes to prove it next year by again being a member of Uncle Sam's Olympic team, and perhaps setting a new world mark for the 220 yards.
