Pte. Joseph Wilfred Blacquire of Summerside was killed in action in Italy on August 30th, according to word received by his wife on Saturday. He is a son of Mr. Archie Blacquire, 207 St. James Street and the late Mrs. Blacquire. His wife is the former Mary Lillian Arsenault of Egmont Bay.

Pte. Blacquire, who was about 24 years old was in the army about two years and served in Canada and Newfoundland before proceeding overseas shortly before Christmas of last year. Before joining up he worked with R. T. Holman, Ltd. A brother, L. Corporal Medius Blacquire has been in the army since the fall of Hong Kong. There is one brother, Pte. Reginald in Aldershot, N.S., and a half brother in the Royal Canadian Mounted Police. Mrs. Blacquire has three sisters, Julia, Mrs. Cyrus Poirier, Summerside; Edna, Mrs. Andrew Leclair, Summerside; and Bella, Alfred Arsenault, Toronto.

Good News For Island Sportsmen - Game observers report bright prospects this coming season for loon hunters. The duck crop is especially the best for a number of years. Black ducks are abundant in all sections of the province and blue-winged teal are plentiful in certain favoured sections are scarce in others. The newest species of duck to favour this province with its presence, the ring-necked duck, has extended its range and in a few localities is more abundant than either the mallard or teal. Few sportsmen are interested in Woodcock and Wilson's snipe but who who choose to hunt these sportsmen will find the Woodcock in particular, frequenting the coverts in abundance.

Upland game birds have had an exceptionally favourable breeding season after a not too severe winter. The Ruffed Grouse (Native part) which breeds in the mountains last fall it was hardly worth one's time to hunt them, has made a remarkable comeback and large and vigorous coveys are once more present in the hardwood and alder swales. Very few of last season's hatch survived the cold unseasonable rains of the month of June. Ring-necked pheasants are plentiful and have extended their range until all of Queens county south of the Hillsboro River is well populated with this handsome game bird, with a considerable overflow moving into Kings county.

It is the Hungarian partridge, the gamest and most sporting of them all, that has really gone to town this season. A reasonable favouring winter and an average breeding season is all that little fellows need and unless a hunter is the owner of a good hunting dog, the wily Hun has things his own way. To give some idea just how many Hungarian partridges are present in the province, in some localities Frank Acorn, prominent in local circles for his interest in hunting and sport of all kinds, took two of his setters out for an airing one afternoon a week ago, and along a 5 mile stretch of roadway in exactly ten minutes of hunting time, they flushed 157 Huns, several of the coveys he held 36 birds. "Duck" is an old hand at the game and knows where to hunt and when to hunt, and in addition is the owner of several of the finest hunting dogs to be found this side of Kentucky. "Duck" states that he found this particular concentration of partridge within a 15 minute car drive from the city and if there are any doubting Thomases he is willing to cook a comfortable side bet and "take 'em out and show 'em."
