A wide circle of friends will regret to hear of the death of Mr. Thomas Hopgood, which occurred at Malpeque on Feb. 28th. Mr. Hopgood was born in England in May 1834 and emigrated to this country with his parents when three years of age. They settled at Ferry Farm Lot 16 and twelve years later moved to Cascumpec. On April 1st, 1856, Mr. Hopgood married Elizabeth Craig of Malpeque and by his marriage had nine daughters six of whom are still living:—Mrs. Charles Johnson, Alberton, Mrs. G. B. Rankin, Medford, Mass.; Mrs. P. I. Leard, Brookline, Mass.; Mrs. H. Souther, Hingham, Mass.; Mrs. W. W. Myers, Hingham, Mass.; Mrs. S. Myer, Somerville, Mass. Mrs. Hopgood predeceased him by twenty-four years. In 1897 he married Margaret Ellen Brander and moved to Malpeque where he resided at the time of his death. Besides his sorrowing widow and daughter he leaves to mourn, two brothers, Richard in Revelstoke, B. C., and John in Cascumpec. One daughter, Mrs. Johnson was with him at the time of his death, to whose home at Alberton the remains were taken. The funeral took place from there to Cascumpec on Friday Mar. 6th. Mr. Hopgood was a faithful member of the Methodist Church and many a pathway was made easier and brighter by his Christian example and guiding hand.

On February 19th, after a painful illness of five months, which he bore with Christian fortitude, Captain William H. Boates of DeSable passed to his eternal rest in the glorious paradise of God. He was a generous kind-hearted man whose whole life was spent in faithful devotion of duty. "Be thou faithful unto death, and I will give thee a crown of life," and "Faithful unto death" seemed to have been the life long motto of him, who has gone to enjoy the reward of his faithfulness in the blessed Paradise of God, where all is joy and light, and rest and peace, there to be forever with the Lord. The deceased was in his 76th year and leaves besides a sorrowing wife, a family of four sons and eight daughters to mourn the loss of a kind and affectionate father, and a loving and devoted husband. The deceased was for many years a consistent member of the Established Church of Scotland, having been while quite a young man, converted under the teachings of the late Rev. Donald MacDonald. He was waited on in his last illness by his pastor, Rev. James MacDougall, who also officiated at the funeral. The funeral, which was largely attended took place on Monday, February 23rd, to Argyle Shore Cemetery. The pall-bearers were, Neal Shaw, Kenner Holm, Malcolm MacPhail, Derrick MacKinnon, David Holm and John Tennant.

ACCIDENT AVERTED.—Mr. Solais Pineau of Toronto, when out "sparring" his Happy George last Monday evening, had a narrow escape from being seriously injured. He was going along at a fairly good clip, when his sleigh overturned, throwing him out on the snow. He, however, did not relinquish his hold of the reins, although he was dragged a considerable distance before he succeeded in bringing his horse to a standstill. Luckily, however, neither Mr. Pineau, nor his horse is much the worse for their experience.—Z.

Yesterday afternoon, His Lordship the Vice-Chancellor (Hon. R. Fitzgerald) handed down his written decision in the application for writs of prohibition against Mr. Arthur F. McQuaid, Stipendiary Magistrate for King's County, to restrain him from further proceeding in the cases brought under the Prohibition Act against Drs. Allan and Grant and J. D. Knight, all of Cardigan.

In a lengthy judgement, His Lordship held that a writ of prohibition could properly issue out of the Court of Chancery, that it was a duty of all superior Courts to restrain inferior Courts from acting without any jurisdiction or in excess of jurisdiction. The learned judge further held that the present application was not brought for the purpose of ousting the magistrate from his office, because of a new permission having been issued from the Governor-in-Council reappointing him to the office; that as the objection to the jurisdiction of the magistrate was taken at the proper time, before the magistrate himself, as a de facto magistrate, he ceased to be such when this objection was taken and consequently that any further proceedings were done without colour of office. Accordingly, His Lordship ordered that the writs of prohibition in the five cases in regard to which application was made be issued, directed to the said Stipendiary Magistrate, prohibiting him from further proceeding in these cases.

Mr. J. J. Johnston, K. C., was counsel for the applicants, and Mr. W. S. Stewart, K. C., counsel for the magistrates.
