

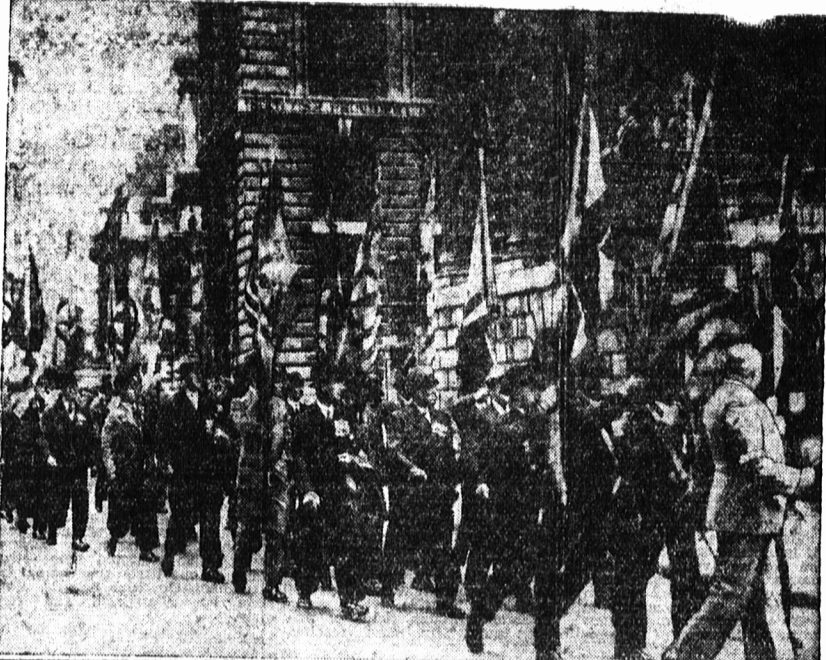
# BRITAIN PUSHES PEACE EFFORTS IN SPAIN

## BRITISH ISLES ARE LASHED BY GALE

### DAMAGE IS REPORTED IN MANY PARTS

**Small Shipping Hard-hit By Violence Of Storm.**  
Small shipping has been hard-hit by the violence of the storm. The British Isles were swept by a storm that lashed the coast and caused heavy damage in many parts of the country.  
At Brighton, Eastbourne, Dover and Folkestone the wind reached a velocity of 50 miles an hour. Many fishing vessels in the vicinity of Hastings were feared lost. Several S.O.S. signals were heard during the night.  
At the race course at Epsom Downs where only yesterday 800,000 people viewed the Derby, bookmakers' stands were blown down.  
**Roads Blocked**  
Across Southern England roads were blocked by fallen trees. The railway between Chingford and Liverpool was blocked for two hours by a tree that fell squarely across the tracks.  
At Southend and Plymouth last night coastguards made repeated rescues of small ships and pleasure vessels caught in the storm.  
The liner Queen Mary could not enter the harbor at Cherbourg where 270 passengers waited to board her. They were lodged on tenders for the night.  
The German steamship Marie Leonhardt of Hamburg, plunging through heavy seas in the English Channel, found the drifting wreckage of the yacht Ymbryn owned by Colonel Hanafin of Guernsey. One man was picked up and another was believed to have been rescued.  
Another yachtsman, Frank Lewis, 64, of the Sussex Yacht Club, died of exposure after being rescued from the yacht Merlin in Portsmouth Harbor.  
Floods were reported in North Wales, where at various points more than a foot of water was covering streets and roads.  
The storm flattened every tent in an army camp of 800 soldiers at Manorbier, Wales, but a balloon lost from the mooring raised show tents at the Royal Counties agricultural show at Bournemouth.

## BELATED LOAN POLICY SCORED IN COMMONS

### Bill Should Have Been Introduced Months Ago Charges Bennett.

(By The Canadian Press)  
OTTAWA, June 2.—Widened a dissenting vote but in the face of a sharp attack on the government for delay in introducing unemployment measures by Conservative Leader Bennett the House of Commons today passed Finance Minister Bennett's bill to authorize low interest loans to municipalities for self-liquidating projects through second reading.  
The bill provides for a maximum of \$30,000,000 to be divided between municipalities on the basis of their population and bearing interest at two per cent which is the same as the bill. Conditions are that the proceeds be used to finance projects which will benefit themselves and that the provincial governments undertake to guarantee repayment of principal and interest.  
**Asks For Suggestions**  
Mr. Dunning said if any amendments could be suggested which would make it unnecessary for the legislatures to be called in special session he would be glad to accept municipalities or guarantees by provincial governments he would welcome them.  
"In the second day of June and this House has been in session since January. It sat during the month of February, March, April and May. The government either had a policy or it had not. Its duty was to have a policy," said Mr. Bennett.  
"Frequently in days gone by I have listened to appeals by members of the House for amendments. I have never seen any amendments of the people because it was alleged that a policy was not forthcoming. On the second day of June we have introduced into this House to deal with unemployment in Canada a bill which is so framed that unless action is taken by the legislatures of the provinces it will not be effective."  
Mr. Dunning said he was not so but Mr. Bennett insisted it was and continued:  
"I have heard a year, month after month, week after week and day after day during the years from 1930 to 1935 complaints were heard from this side of the House, criticism, bitter and remorseless, were launched against the government of the day and it was said to be the delay in dealing with these matters."  
"Now we find this government on the other side of the House introducing what the Minister of Labor described the other day as the policy of 'Reckless expediency' in unemployment. That policy is to be part housing, part self-liquidating loans and part something else."  
"The House has been introduced a bill which would have had when the House met why did they let the legislatures of the nine provinces proceed with their own unemployment? Why did they let the legislatures that are to give the guarantees with respect to unemployment come and go without taking any action? Let them answer that."  
"The bill was wholly inadequate and fell short of meeting the needs and demands of the people, in the opinion of Hon. H. H. Stevens (Quebec). It was not improved if it was as far as it went but warned the government it was playing with fire" if it did not do something about unemployed single men this session.

## New Border Violation Is Charged

(By The Canadian Press)  
BERLIN, June 2.—(Deutsches Nachrichtenbüro (German official news agency) tonight reported a new border violation by a Czechoslovak gendarme airplane.  
In a dispatch from Annaberg, Saxony, the news agency said the plane first appeared over Koenigsvalde, five or six miles from the border on the German side.  
The craft was reported later over the nearby border points of Saerstein, Hammer-Oberwesenthal and the Oberwesenthal before heading back toward Czechoslovak territory.  
This latest report in a series of border violations which have been charged by both Germany and Czechoslovakia came after high Nazi political circles laid out the neighboring republic's doorstep full responsibility for peaceful solution of their differences.  
"The first magnitude today is that the Czechoslovak army in cooperation with the Sudeten Germans," these sources said.

## Russia Drops Opposition To Withdrawal Plan

### Many Difficulties Yet Faced By Non-Intervention Body—Franco Apologizes To Britain.

LONDON, June 2.—(CP)—Withdrawal of foreign fighters from the Spanish civil war drew nearer reality tonight, after nearly two years of dispute among Europe's major powers.  
If the plan works out, Great Britain will throw her diplomatic power into an attempt to bring about a truce in Spain.  
(In Paris, Jose Antonio Aguirre, former president of the Basque Republic, admitted the possibility of mediation by outside powers in the Spanish war. Aguirre said he expected to have a statement on the matter "within five or six days.")  
Soviet Russia, at a meeting of the Nine-Nation Non-Intervention Subcommittee, agreed to the proposal for sending commissions to Spain for removing 10,000 volunteers from each side as a sign of good will.  
Remembering many previous disappointments in the efforts to obtain agreement on withdrawal, the British Foreign Office warned against undue optimism over today's development.  
**Situation Brighter**

## Japan Acts Swiftly To Meet Demands Of United States

WASHINGTON, June 2.—(AP)—With a swiftness astonishing in modern diplomacy, Japan gave in along most of the lines today to United States demands for restitution of American property in China and return to American businessmen and missionaries to their former posts.  
Japan began to act within a few hours after the receipt of the strong American note announced yesterday and delivered Tuesday.  
Her first step, announced in a telegram from American Consul General Frank Lockhart at Shanghai, was to agree Tuesday to the return to Nanking of American missionaries formerly resident there. Lockhart said 10 passes had been issued for this purpose.  
The second step was the restoration Wednesday of the two high schools of the American Southern Baptist Mission in the Chapei district of Shanghai.  
The third step, reported in a telegram from Ambassador Grew at Tokyo, was the announcement made today by the Japanese Foreign Office that Japan is sending an interdepartmental committee to visit the Japanese-controlled area in central China.  
**Sino-Jap Armies Still Deadlocked**  
SHANGHAI, June 2.—(Friday)—Under cover of artillery fire, a Japanese relief column today began crossing the Yellow River at Chengliukow Ford north of Lanfeng in an effort to rescue the beleaguered forces of Lieut. General Kenji Dohara, Japan's "Lawrence of Manchuria."  
Chinese, advancing from Lanfeng, reported their encircling columns were driving toward the bank of the Yellow River.  
(A Peiping dispatch quoted a Japanese Army spokesman as admitting that Dohara was bottled up, but saying his troops were attacking the surrounding Chinese determinedly.)

## GOVERNOR OF JAMAICA DIES

Sir Edward Denham Succumbs In Hospital.  
KINGSTON, Jamaica, June 2.—(CP)—Sir Edward Denham, Governor of Jamaica, died in Government Hospital today, aged 62. He was understood to have died in following an operation last night for an intestinal obstruction.  
C. O. Woolley, colonial secretary, will take over Sir Edward's duties temporarily.  
News of the Governor's death was received with great regret throughout the colony of which he had been governor since 1934.  
He was to have gone to England on vacation in May but postponed his holiday in view of the serious labor disorders in Jamaica.  
A hospital bulletin at 1:30 p.m. today said his condition was "weak." Meanwhile the Colonial Legislature met and passed a resolution regretting the Governor's illness and adjourned sine die.  
The assembly had scarcely dispersed before his death was announced.  
The operation Tuesday was to adjust a twisted intestine. It was in itself successful, but the twisted portion of the organ developed a toxic condition which spread through his system.  
He will be buried at sea tomorrow at his own request, H.M.S. Ajax, British cruiser summoned from Bermuda last week when labor troubles in his own island grew serious, is expected to be the funeral ship.  
Sir Edward came to Jamaica in 1935 after a successful career of administration in other parts of Empire. Among colonies in which he held office were Mauritius, Kenya, Ceylon and British Guiana.

## Spanish Armies Are Locked In Combat On Coastal Front

HENDAYE, France, June 2.—(AP)—Crack Spanish government and insurgent troops fought steadily today along the Teruel-Mediterranean highway without scoring appreciable gains.  
Government dispatches said the insurgents lost 1,200 dead from midnight to noon along the 10-mile battle front from La Puobla De Valverde, 12 miles southeast of Teruel, east to Mora De Rubielos. Advice from the insurgent side said Government losses were "enormous."  
The central air force of Government General Jose Miaja, aided by bombers from Catalonia, flew over the quindron and 17 bombers were captured by the insurgents have conquered to the Mediterranean to attack the enemy.  
High-flying Government fighters also crossed the corridor from a base behind Tortosa, on the coast, to machine-gun insurgent supply and troop columns moving toward the front from Teruel.

Their study will be confined to ground work for some time, and Miss Walters said when they were thoroughly familiar with the details also flying squadron would start lessons that would make them efficient pilots.

Claims Dismissal Was Due To Pressure From Globe And Mail.  
TORONTO, June 2.—(CP)—Arthur W. Roebuck, "outcast" Liberal member of the Ontario Legislature former power commissioner and Attorney-General, told a legislative inquiry today he was dismissed from the cabinet in 1937 because he would not sign a power contract with the Beauharnois Light, Heat and Power Company.

Musto, whose ribs were fractured, was the last to come up from the mine. He walked out unaided and that accumulated gases were ignited either by miners' lamps or sparks from motors.

## Army Of Searchers Fail To Find Trace Of Kidnapped Boy
