Diary of Columbus Is Reported Found

MOSCOW, Oct. 3.—What is believed to be a diary kept by Christopher Columbus has been discovered in archives in the Kargopol museum in North Russia.

The book is bound in parchment with a design of sea shells and weeds around a seal suspended by a long string.

The text describes Columbus' journeys and is profusely illustrated. The following German inscription is on the title page.

"Notebook of Christopher Columbus from myself for my son, Diego, August 3, 1492."

The question of the book's authenticity and the manner in which it reached the Kargopol museum is being investigated.
