TRAIN RAN INTO BURNING RIDGE

BERLIN, Sept. 10.—Prince Philip Zu Eulenburg, whose trial on charges of perjury with the cost of transport suspended on July 17th last, is suffering from repeated attacks of fainting, with intense and agonizing nervous symptoms. The physicians in attendance on the prince are obliged to administer morphine to him continually and his condition now is one of almost complete collapse. The prince, since the abrupt adjournment of his trial on account of his ill health, has been confined in the police ward of Chicago Hospital, where he is under the strictest surveillance. It is impossible to forecast when the trial will be resumed.

WHY CANADA IMPORTS GOLD

OTTAWA, Sept. 11.—According to the agents in this city of several of the leading Canadian banks, the shipment of gold coin from this centre to Canada are being made as regular exchange transactions. It is pointed out that New York exchange at Montreal is at a great discount, and, consequently, remittances in cash can be made materially cheaper than by sending the exchange. It is said that while the gold if being shipped in the regular course of business, a large part of it will probably be used for crop-moving purposes. Another reason for the heavy outward movement of gold to the Dominion is found in the fact that recent Canadian municipal loans which were placed in London are now being drawn against by Canadian bankers in New York. The total shipments to date approximate \$10,500,000. It is the general opinion among Canadian bankers that further shipments will be made, and in some quarters it is estimated that the movement is likely to reach \$20,000,000 or upwards. The Canadian banks are in an extremely strong position, and their cash holdings are said to be considerably larger than in former years.

SUN WORSHIPPERS WORSHIP THE COIN

BOSTON, Mass., Sept. 10.—A bill in equity was filed in the Essex Superior Court yesterday by Mabel M. Dutton, against Mrs. Ellen M. Shaw and others of Lowell, asking for an injunction to prevent Mrs. Shaw from turning over any part of her property to Mrs. Adelia A. Mallett, or a sect in that city known as Sun worshippers. Mrs. Mallett is also named as a defendant. The bill alleges that efforts have been, or are being made to induce Mrs. Shaw, who is said to be worth \$50,000 to transfer her property. Mrs. Shaw is the widow of Frank Shaw, a former hotel owner. A petition for a relief has also been brought in the Probate Court by the plaintiff in the equity suit.

WANTS BATTENBERG ON BULGARIAN THRONE

SOFIA, Bulgaria, Sept. 10.—A newly established paper, called Patriot, leaves suppression by advocating that the son of the first Prince of Bulgaria, Alexander Battenberg, be made successor to the present incumbent of the throne, Ferdinand. Prince Ferdinand has several sons and a daughter by his first wife. A few months ago he contracted a second marriage with a Princess of Roumania. After resigning the Bulgarian throne Prince Battenberg went to Austria, taking service in the army. Later in order to marry the woman of his choice, he gave up princely title and assumed the name of Count Harteman. BRITAIN'S DEFENCE AGAINST NAPOLEON

Book by Messrs. Rose and Broadley Will Contain Hitherto Unpublished Letters.

LONDON, Sept. 10.—Messrs. Holman Rose and A. M. Broadley, both experts on the subject of Napoleon, have collaborated the preparation of a comprehensive work entitled "Dumouriez and the Defence of England Against Napoleon." We are told that nearly the whole of the contents of the book are absolutely new. Seven letters of the great French strategist, which have been able to throw new light on certain obscure parts of the history of the maid of Orleans. He fancied he had refuted many old and new imputations against the intelligence and greatness of the martyr, and this will suggest that chivalry as ever, he is her champion up to the present time historians against certain critics.

MEXICO, Sept. 10.—The great oil well fire near Tampico, Mexico, has just been extinguished, after burning for two months. It took six giant centrifugal pumps ten days pouring mud and gravel into the opening before the orifice could be blocked and the flames smothered.

A NEGRO MURDERER LYNCHED BY A MOB

OXFORD, Miss., Sept. 10.—Lawson Patten, a negro, who late yesterday killed Mrs. McMillan, a white woman, at her home, was taken from the jail by a mob and lynched. The killing of Mrs. McMillan was unusually brutal. Patten delivered a message to Mrs. McMillan from her husband, who is serving a sentence in the Oxford jail, and lingered about the place. Mrs. McMillan attempted to frighten him away with a revolver, but he grasped her and disarmed her. He then cut her throat. The woman died a few minutes later. Patten fled, but was later captured, after exchanging shots with a posse, during which he was badly wounded. A mob began to form shortly after he was brought to jail, and despite the pleadings of the county officials, battered the doors of the jail, and securing Patten and hanged him to a telephone pole.

WOMAN'S NERVE FAILED HER

OMAHA, Neb., September 10.—Dr. Fred Rustin's death was the result of a suicide pact with Mrs. Rice, the who has been held in custody for the past five days. This is the statement made by Mrs. Rice to the Omaha police force. The statement was read before the coroner's jury yesterday. According to it, Dr. Rustin and Mrs. Rice agreed to die together. Dr. Rustin went home to carry out his portion of the compact and did so. Mrs. Rice's nerve failed her and at the last minute she decided that she could not carry out the compact. Four times during the night she telephoned Dr. Rustin's home to tell him of her decision, but during those hours the man was sitting outside his home on the porch and did not receive the message. Mr. Rice purchased a bottle of laudanum and one of morphine with which to carry out her part of the agreement, and these have been found in her room.

MADAME ALBANI SINGS AT CHURCH

LONDON, Sept. 10.—Mme Albani sang to a crowded congregation in St. Mary's Church, Somerset Town, England, one Sunday recently. Little children brought in from the streets to hear her, sat on the church steps. Working women and workmen—some in Sunday clothes, but many in the toil-stained garments of every day—crowded the aisles and the wide open doors of the church were round the porch to catch a few notes from the great prima donna. The crowded congregation in that man's church hung as breathlessly on her singing as ever did an audience at Convent Garden on the Albert Hall, and the children listened enraptured as the glorious notes of "Angels Ever Bright and Fair" thrilled through the church. The mayor and council of St. Pancras were present in state, and Rev. Dr. Collinson, after preaching an eloquent sermon on charity, accompanied Mme Albani on the organ.

PRISONERS BROKE JAIL

AMHERST, Sept. 10.—A serious accident occurred at Aulac yesterday. Mrs. Mamie Wells and Mrs. Hazen Chapman were endeavoring to cross the railway track in front of a fast approaching train. The engine struck the rear wheel of the carriage badly shattering it and throwing the ladies violently to the ground. Mrs. Wells had two ribs broken and her shoulder dislocated by the fall, and also sustained several bruises on the face and body. Mrs. Chapman was severely bruised, but no bones were broken. If it had not been for the presence of the mind of the engineer, who applied the brakes, both Mrs. Chapman and Mrs. Wells would have been killed instantly.

SEVEN SAILORS SERVING A YEAR YESTERDAY, STILL FREE

CAMPBELLTON, N. B., Sept. 10.—The seven sailors who were sentenced on Saturday to one month in jail escaped from that institution today. They were sent to pile lumber in the yard of the prison and, it is alleged, seized the opportunity to make a break for liberty. They have been seen in Campbellton, and no attempt is stated, is being made to apprehend them. Considerable mystery attaches to the affair. The Sheriff of Dalhousie, called up on the telephone, denied any knowledge of their escape. The crowded condition of the Dalhousie jail has made the escape an unlooked for blessing.

PRINCESS IS SENT TO EXILE

ST. PETERSBURG, Sept. 10.—Convicted of being a member of a revolutionary group organized for the purpose of changing the existing form of Russian social life, Princess Alexandra Tchernisky, a beautiful and accomplished descendant of an ancient royal family, and said to be distantly related to a former Czar, was sentenced today with 45 followers to spend a long period of exile and penal servitude in the wastes of Siberia. The Princess and five of her disciples will serve sentences of 15 years each. Ten of the others were sentenced to 12 years; five to 18 years; five to eight years; five to six years; one to five years and nine to three years.

STEAM TRAWLERS MUST KEEP OUT

OTTAWA, Sept. 10.—A special from Ottawa to the Chronicle states that fishing on inshore waters. The matter was within the bays and harbors or within the three mile limit of Canada, has been taken to safeguard the in-ell.
