TO UNRAVEL THE MOYSTERY OF TANG

Action for \$10,000 Entered in Montreal Court to Decide what the Tango is.

(Canadian Press) MONTREAL, Nov. 26.—The Superior Court of Montreal will be called upon to decide what the real Simon Pure Tango dance is and as to whether one teacher may restrain or bar a rival from teaching the latest form of Terpsichorean exercise.

THE OCEAN RATES ON THE ATLANTIC

OTTAWA, Nov. 25.—The report of H. L. Drayton, chairman of the Railway Commission, who went to England to investigate ocean rates as affecting Canada, was made public today. The investigation, as he had asked for, covered passenger as well as freight traffic. In addition to discussing the matter with the Imperial authorities, he met the representatives of the different lines that are in conference with each other and heard a statement of their position. As a matter of fairness to the companies, he states, it is only due to them to point out that the expenses of carrying on business had very largely increased so that a certain advance would undoubtedly be reasonable if the previous rates only afforded fair returns to the operating companies.

BOARDS OF TRADE STATE ITS POSITION

To the proposition of Mr. Drayton, the Board of Trade replied that they had carefully considered the arguments and suggestions advanced by him. They pointed out that the out-of-cooperation in a joint inquiry was made in a letter by Lord Urewe to the Government of Canada in 1910, but met with no response from that government until the present, but on the 10th of April 1912, in pursuance of a resolution passed by the Imperial Conference of 1911, on the motion of the Canadian Prime Minister, a joint Royal Commission was appointed in whose terms of reference the question of shipping freight was clearly included. The question of shipping rates was also raised at the Conference by the Prime Minister of Australia.

P. E. ISLAND ATHLETES IN INDOOR CHAMPIONSHIPS

OFFICER KILLED THE WRONG MAN

PRINCE RUPERT, Nov. 27.—A foreign prospector was killed near Skeena crossing by special Constable Edgar, who suspected him of being a fugitive from justice concerned in the Hazelton bank robbery. The officer while guarding a bridge ordered the stranger to halt. The latter ran and Edgar pursued him a mile. Finally he fired, the bullet entering the man's heart. The victim was identified as a Swedish mine laborer though he was demented.

THE SITUATION IN MEXICO

(Canadian Press.) EL PASO, Nov. 26.—Villa's Army returning from its battle at Mesa began arriving at Juarez shortly before noon. The men are in good spirits and well supplied with ammunition which they captured from the Federals. Fifteen captured Federal field pieces and fifteen machine guns were brought to Juarez at the same time that the Rebel army commenced coming. A troop review which was in the nature of a triumphal parade was at once started, and reviewed by General Villa from his automobile.

ARTILLERY LEADS

Once again the Artillerists of P. E. Island have, in open competition, vindicated their superiority over the other branches of the heavy Artillery in Canada. On the results of the Heavy Artillery Competitions for Canada for 1912, which have just been announced, it is pleasing to record that in the competition which was conducted at Petawawa, No. 4 Battery of Prince Edward Island led Canada, No. 3 Battery, P. E. Island being second, Coburg, Third, First Montreal, fourth, and Second Montreal fifth. The totals respectively were 302.3; 278.5; 214.3; and 137.7. The results in detail for the Island batteries are as follows:

TO PROTECT ALASKA FISHERIES

(Canadian Press) WASHINGTON, Nov. 26.—Complaints against Canadian, Japanese and Russian fishermen invading Alaskan waters for halibut led Secretary Redfield to include in the estimates for the Department of Commerce an appropriation of \$100,000 for the purchase of one sea-going vessel, one light draft tug and six rapid motor boats to enforce the Alien fishing law. For additional employees he asks \$8,500,000.

U. S. GOVERNMENT VS. RADIO TELEPHONE

(Canadian Press.) NEW YORK, Nov. 26.—Granville T. Ivery, the first of more than one hundred witnesses from all parts of the country called by the government to testify at the trial of James Dunlap Smith, Samuel B. Darby, Leo DeForest, and E. E. Burlingame, charged with conspiracy to defraud the Investors' Wireless Telephone Stocks, was examined today in the Federal Court. The examination of Mr. Ivery, who is a director of one of the companies organized by the defendants, was resumed Friday. His opening statement to the jury gave the government's view of the case against the defendants.

RICHARD BARRY WINS LAWSUIT

(Canadian Press.) NEW YORK, Nov. 26.—Richard Barry, the writer, today won a suit to recover from Martin M. Mulhall, the Lobbyist's half of \$10,000 which he declared Mulhall received from the New York World for 3,000 confidential letters which served as a basis for the recent congressional investigation. Barry showed the written contract and said he acted as Mulhall's agent and editor.

NO KNOWLEDGE OF CONSPIRACY

(Canadian Press.) DENVER, Nov. 26.—The National District officer of the United Mine Workers of America, now in Colorado in connection with the coal strike, disclaimed any knowledge of a conspiracy in connection with the killing of detective G. W. Belcher. The conspiracy was charged in the confession of Louis Seaneanelli, made to the military authorities of Trinidad. International Vice-President Frank J. Hayes, in a statement said, "We do not know whether Louis Seaneanelli was a member of the union. Every local union is filled with detectives and we are not sure Seaneanelli was not one of them. We could not see or talk to him, and know nothing about him."

RESTRICT USE OF "HONORABLE"

OTTAWA, Nov. 25.—A despatch to the Governor-General from the Colonial Secretary, Right Hon. Lewis Harcourt, under date of November 3, sets forth the regulations in regard to the use of titles in Canada. It is provided that the title "Honorable" shall be used for life by Senators and by Privy-Councillors of Canada, i.e., past or present Federal Cabinet Ministers. The title "Honorable" is to be given to members of Provincial Governments only during tenure of office. The title will also lapse with tenure of office in the case of Speakers of the Federal or Provincial Parliaments or Legislatures. The Solicitor-General of Canada, Justices of the Supreme and Exchequer Courts of Canada and of the Provincial Supreme Courts are entitled to be styled "Honorable" during tenure of office, and may retain the title on retirement if personally recommended by the Governor-General for his Majesty's permission to retain the title.

GREATER SAFETY FOR INVESTORS

New York Stock Exchange to Encourage Safety of Investors and Integrity.

(Canadian Press) NEW YORK, Nov. 26.—The stock exchange through its governing board to-day announced that it is intended to co-operate in future, as far as possible, to bring about the adoption of uniform measures for greater protection to the investing public through more careful supervision and co-operation of organization. To this end it recommended greater publicity, fuller and more frequent reports of operations than has been customary with many corporations in the past. The exchange will appoint a committee which will make the subject a special study and in the language of the resolution, "increase the safety and integrity of American investments and at the same time afford every encouragement for legitimate enterprise."

200 GREEKS BACK FROM THE WAR

(Canadian Press.) NEW YORK, Nov. 26.—Two hundred Greeks who left this country at the outbreak of the Turko-Balkan war to fight their country's battles returned today. Many saw service in several engagements.

SUPREME COURT AT SUMMERSIDE

(Special by Phone.) SUMMERSIDE, Nov. 26.—In the Supreme Court at Summerside yesterday the case of the King vs. Alex McDonald, on a charge of receiving and concealing stolen goods (foxes) was taken up. After considerable difficulty a panel was secured. Mr. McQuarrie, K. C., opened the case for the Crown. The witnesses examined for the Crown were Messrs James E. Birch and Charles Bennett, owners of the foxes. Their evidence was mainly about the loss and subsequent return of the foxes which they identified as belonging to them. Messrs George Barbour and Charles R. Burke told of the finding of the foxes at the prisoner's home, and also the explanation made by the prisoner at that time. Mr. Holson Goff told of seeing a masked man driving up the winter road towards McDonald's on the night previous to the discovery of the foxes by the prisoner.

GIRL DRUGGED AND ABDUCTED

(Canadian Press) FAIRFIELD, Maine, Nov. 26.—Lois Piper, the pretty 18-year-old daughter of Kingsbury B. Piper, vice-chairman of the Democratic State Committee, who mysteriously disappeared from her home here on the night of November 17, was found by her distracted father in Portland this morning, having arrived on the steamer, Governor Dingley, from Boston. The girl told an amazing story of having been drugged and held prisoner in Boston by White Slavers who, Monday night, were frightened by the hue and cry which had been raised in due to setting her at liberty. Lois says she met a light-haired woman in a moving picture theatre in Waterville, Me., on the night she disappeared. The woman gave her candy which made her ill and she started for the street. Outside were two men in an automobile. Too ill to protest she was taken in and whirled away. She dimly remembers a railroad journey and being in Portland Monday afternoon. She came to her senses and found herself in a room in Boston. She is unable to say in what part of the city. She heard her captors say: "It's getting too hot for us"; and they directed her to take the Portland boat giving an assumed name, and not leaving her stateroom until morning. Owing to her drugged condition she is unable to describe the woman and two men who were her captors.

\$20,000 EARNED BUT POOR OUTLOOK

Mrs. Emeline Pankhurst Left United States with Plenty of Money but Expects Jail.

(Canadian Press) NEW YORK, Nov. 26.—Mrs. Emeline Pankhurst, England's militant suffragette, sailed home to-day taking with her \$20,000 collected during her recent lecture tour in this country. She will devote the money to the cause of woman suffrage in England. Mrs. Pankhurst said on her arrival at Plymouth she expected arrest and jail to serve the remainder of her sentence uncompleted because of her hunger strike.

YOUNG CHILD BURNED TO DEATH

A terribly sad fatality occurred at Point Tryon on Monday last when little Blanche O'Reilly, aged five and a half years, was so badly burned that she lived only a few hours. About 9 o'clock, while the inmates of the house were absent, with the exception of the child's mother who was in bed, the little one got out of bed and went to the kitchen. A spark from the stove evidently caught in her nightdress and when her mother, alarmed by the child's screams, came to her assistance she found her enveloped in flames. The mother did what she could to smother the flames, and in doing so received severe burns, but before she finally succeeded the child was terribly burned all over the body. Dr. Boyer of Crapaud was at once sent for but when he arrived he saw that the case was absolutely hopeless. The little one lived till ten o'clock at night her suffering mercifully relieved by unconsciousness during the last few hours.
