LONDON LETTER

The Office of the High Commissioner for Canada in London, Week by Week.—19th Nov., 1926.

International Clubhouse for University Women.

H. J. H. the Duchess of York yesterday unveiled a Commemorative Tablet at Crosby Hall, Chelsea, the future educational settlement and Club House for University Women engaged in Research Work. As a result of the Committee's recent appeal, a residential wing is now being built, and word has reached the High Commissioner for Canada that the Canadian Federation of University Women has decided to contribute \$5,000. One room in the Club House will be called "Canada" and preference in the allocation of this room will be given to a Canadian woman studying in London.

In Memory of Canadian Soldiers.

The Canadian public and more especially the relatives and friends of the Canadian soldiers who are buried in Brookwood Military Cemetery, Surrey, England, will hear with interest and appreciation that the Victoria League, Working, has written the High Commissioner for Canada saying that a special Service was held in the cemetery at 12 noon on Armistice Day when the Chairman and members of the Working Urban District Council attended. The Victoria League also laid a wreath on the Stone of Remembrance in honor of the soldiers from the Overseas Dominions.

The High Commissioner has also been informed that on November 11th each year a deputation visits the graves in Wandsworth Cemetery of Canadian soldiers who died in the Third London General Hospital, Laurel and poppy wreaths are placed on the graves. The deputation consists of Colonel Sir Bruce Bruce-Porter, K.B.E., C.M.G., the famous physician, Miss Barton, Principal Matron, Miss Holden, Matron, Mr. Butcher, and Mr. Lee, representing non-commissioned officers and men.

Canadian Apples in Demand.

Further parts of the Menin Gate Memorial Register have just been issued by the Imperial War Graves Commission. These parts contain the names of missing Canadian soldiers, under the letters "T" to "M." Copies of the Register have been forwarded by the High Commissioner for Canada to Ottawa for reference purposes.

Canadian Buffalo Arrive in Scotland.

Two Canadian Buffalo reached Glasgow last week on their way to Edinburgh. The animals arrived in good condition and will, no doubt, prove a valuable addition to the Edinburgh Zoo.

Canadian Store Cattle Arrivals.

During the week ended November 10th five consignments of Canadian Store Cattle arrived in the United Kingdom, the number of animals landed being 2443.

Trade Enquiries.

The High Commissioner's Office has been informed by the Canadian Trade Commissioners in Great Britain that they have received the following enquiries for Canadian goods during the past week:

VALET WHO POSED AS THE VICEROY.

How Lord Curzon's valet became a hero to his master is described with a fine sense of humor in a chapter of "Leaves from a Viceroy's Notebook," the manuscript of which was found among Lord Curzon's papers after his death, which has been recently published.

Voluntarism notes for half a dozen books on widely different subjects were found, and this collection of essays was intended by Lord Curzon to form the sequel to his "Tales of Travel."

It resembles some of his more entertaining experiences in India, Annam, Korea and other lands, and contains the comic history of a furious quarrel between Sir Hudson Lowe, who was Napoleon's gaoler at St. Helena, and the general who succeeded him, over a table that belonged to Napoleon. Lord Curzon discovered the correspondence among the Government records at St. Helena.

Lord Curzon's valet attended him on his vice-regal travels, and occasionally took the vice-regal honors with great distinction. His performances, "spontaneous and unprovoked," writes Lord Curzon, "were a source to me of incessant surprise, mingled with the most profound admiration."

"Possessed of a fine appearance, an engaging manner, and unlimited effrontery, beautifully clad and equipped for any emergency, there was no situation with which he was not prepared to cope, and few from which he did not emerge in triumph. He was a little uncertain about his aspirates."

"But this added to rather than detracted from the novelty of his remarks upon men and things in general."

On one occasion the Viceroy and Lord Curzon arrived by sea on a visit to the native State of Cochin, in Southern India. Surf boomed on the beach, where there were enormous crowds awaiting to welcome the visitors, and Lord Curzon from the deck saw "dancing on the waves alongside a boat of wonderful construction with a figurehead in imitation of the swan-boat of Lochengrin, and with two State chairs erected on a platform at its back, under a painted and gilded canopy."

It was decided that the risk of an upset in the surf was too great for the Viceroy and Lady Curzon to use the swan-boat, and they waited awhile.

"A little later," says the Viceroy, "happening to look shorewards, I saw the swan-boat careering gaily towards the beach. On the two state chairs, smiling and self-possessed, sat my valet and the lady's maid, whom he had inveigled into the conspiracy; and from the shore we heard the loud huzzas that greeted their landing—I am sorry to say, without the ducking that ought to have been their lot."
