Mr. Duncan Palmer, Summerside, Dies Suddenly

Mr. Duncan Palmer, employed as teamster for the Town of Summerside died suddenly while at his work about 9.30 Monday morning. Mr. Palmer was loading sand into a truck in company with two other workmen when he became faint and sat down by the roadside saying he did not feel well. Dr. Tantoni was immediately called but Mr. Palmer had passed away before he could get there. Dr. W. B. Howatt, coroner, was called but did not think an inquest necessary. Death was due to a heart condition.

Mr. Palmer was 62 years of age and was born in Bedque. He came to Summerside when 18 years of age and engaged in trucking. He was a lover of horses.

Mr. Palmer joined the Summerside Fire Dept. over the years ago when it was divided in sections. He was on the East End Hose Dept. later when the east and west were merged into one. On the retirement of Chief Mathieson eight years ago he was promoted to assistant chief, taking the place of Mr. W. B. MacNeill who was appointed chief. He was held in very high esteem by the members of the Fire Dept. by the Mayor and Council and town officials, and also the general public.

Much sympathy is extended to his widow, formerly Amy Farrent, and his sisters, Mrs. M. H. Sudsbury and Mrs. James Crossman of Summerside and to his brother Nelson Palmer of Sydney, N.S.

The remains are resting at Percy L. Bowness' undertaking parlors. The funeral will be held on Wednesday at 2 p.m. from the undertaking parlors under the auspices of the Fire Dept.

EVIDENCE IN ARSON CASE CONTINUED

The case of the King vs Paul Harding charged with arson was continued when the Supreme Court resumed its sitting at Summerside yesterday morning. Chief Justice Mathieson presided.

Eric MacEwen, who was on the stand when the court rose on Friday afternoon for the week end recess, continued his evidence. He stated in cross-examination that he had driven a truck for Harding and at different times Harding had suggested to him the burning of the boat for the insurance. He burned the boat on the night of November 10th last week. Harding had given him gasoline for the burning in Charlottetown and charged with burning the boat. He admitted to burning the boat in a confidential talk with Sgt. Anderson of the R. C. M. P. He was brought up later on this charge and pleaded guilty and given a three year suspended sentence.

Frank MacEwen, brother of the last witness, was then the next witness and stated that he had worked for Harding and had driven a truck for him in 1934. Harding had suggested to him the burning of the boat, but he had not done so. He was not very particular about doing it. Witness then went on to say that when he was driving the truck for Harding in 1934, he was supposed to burn it. The truck was in his charge under the management of Harding's garage. Harding told him that he wanted the truck to be in his witness' name but he (witness) made no payment on it, although he had signed a bill of sale. Harding told him to insure the truck. The truck was insured for \$400. Harding paid the premium. He was instructed to get the truck shortly after they received the insurance policy. Harding told him to burn the truck, she was not paying and giving a lot of trouble. He took it out to Blue Shank Road and burned it. He was not sure if the truck was there or not. He saw it. Harding came after him and they drove in a round about way to New Annan. Harding told witness to finish his job witness poured some gasoline on the floor of the cab and set it on fire. He did not much damage was done. After the truck was brought to Summerside and dismantled in Harding's garage. Harding helped him take the engine hood and other parts of it upstairs. This was done to get the insurance. He signed a claim for the insurance. \$400 was received from the insurance company. The money was deposited to the account of Harding's garage. Witness did not get any of the money. The truck was afterwards put back on the road and later sold. He was a Royal MacKenzie customs officer at Summerside and formerly of Borden, was the next witness and stated that he had agreed to purchase the boat for \$950. The agreement was that he was to be credited with \$150. Harding owed him and to pay the balance as he could in monthly payments. He never got delivery of the boat. He went for it on two occasions and was told it wasn't working. About November he told Harding that he could not handle the boat in the fall and Harding said it was all right. His car was returned to him and Harding paid him \$50 on account of the boat but had signed application form. He did not pay the premium or receive the policy. The boat was insured for \$1025. The loss was made payable to Harding's garage. He was asked to sign statements of claim and later of cheque from insurance people.

Soviets Win 2nd Straight Game In Town League By Defeating Sunglos 6-4

HALIBUT MOLD.

Sixteen salted soda biscuits, 1-4 cups milk, 3 egg yolks, well beaten; 1 lb. halibut, 1 tablespoon grated onion, 1 teaspoon salt, dash pepper, 2 tablespoons parsley, minced; 3 egg whites, beaten stiff.

Method: Pour the milk over the biscuits, which have been finely crushed, and allow to stand 1 minute. Add the well-beaten egg yolks and the halibut, which has been put through the food chopper 3 times. Add remaining ingredients, and lastly, fold in the stiffly beaten egg whites. Turn into a well-greased mould, place on several thicknesses of newspaper in a pan containing
