FATAL MOTOR CAR ACCIDENT IN N. S.

WILFVILLE, N. S., Aug. 9.—One man is dead, another dying, a third seriously injured and two others badly bruised, as a result of an automobile accident here today. Kentville (N. S.); injured, Harry Huntley, Kingsport, Norman Campbell, Bruce Carroll and Horace Carl, Kentville.

The five were discovered about three o'clock this morning a few hundred yards from the Wolfville post office, near a curve in the road. They had been traveling at too great a speed to make the turn, with serious results.

Jekyll and Hyde Game Played by Woman

WEST PALM BEACH, Fla., August 6.—Coming quickly after her confession yesterday of the \$32,000 West Palm Beach post office robbery, the announcement today by Chief of Police Vestal in Orlando that Lena Clarke, postmistress here, had confessed the murder of P. A. Whitmore, who was found shot to death in her hotel room on Monday, has stunned this community, where the self-confessed murderer and robber has held the position of a most highly esteemed young woman.

Publication of the robbery confession left many friends clinging to their faith in the woman and with the one thought of finding the "man in the case" who had prompted her to such a deed. The murder confession has forced a reluctant admission of an astonishing tale of double life; the leader of church activities and the daughter of a retired clergyman, on the one hand and on a woman who has suddenly been revealed as a figure in "night life," who spent money lavishly and who had many troubles. Brotherhoods Unite To Resist Wage Cut

TORONTO, Aug. 8.—Four big Railroad Brotherhoods of Canada united and placed their resources to resist the wage cut which has gone into effect on Canadian lines. The Brotherhoods are the Railway Conductors, and the Order of Railway Telegraphers, Brotherhood of Engineers and Firemen, Brotherhood of Railway Trainmen. The Board of Conciliation has been applied for at Ottawa and a railway man named David Campbell, solicitor, of Calgary, formerly president of railway telegraphers is their representative.

Nurse Killed Lawyer on Busy Street

NEW YORK, August 9.—Ellis Guy Kinkaid, former city solicitor of Cincinnati and recently a practicing lawyer in New York, was shot to death today by Olivia M. P. Stone, a nurse, who said she was her victim's common-law wife. Kinkaid's real wife, whom he married in Cincinnati in September, 1918, was waiting for him in their apartment at 45 South Elliott Place, Brooklyn, within sound of the shots which killed her husband at 5:45 o'clock in the street only a few doors from his home.

The slayer was questioned for hours in the Clason avenue station, Brooklyn. After the hysterical that marked her early demeanor subsided, she insisted that she had shot only to cripple "the dog who ruined my life." She was not told that Kinkaid had died instantly, nor that any one of the five bullets that hit him would have caused death. She begged continually to "go to the hospital" to comfort him.

Kinkaid was about 54 years old. Miss Stone's age was estimated variously at 31 to 35 years. On the ground that she and Kinkaid had entered into a marriage by verbal unwitnessed contract in Atlantic City in 1918, while the lawyer was convalescing from an illness through which she had nursed him in the Cincinnati General Hospital, Miss Stone had brought an action for divorce against him in Brooklyn last June. It was on the calendar for this October term of the Supreme Court.

Though she knew of that action and of a long, frenzied pursuit of her husband by the nurse—a pursuit that had led him to abandon a big criminal practice in Cincinnati—Mrs. Kinkaid, who was Marie Louise Cromley, expert pianist, Miss Stone and told detectives she believed the woman was insane.

IN MEMORIAM

CECIL EDGAR MCGREGOR

The funeral of Cecil Edgar McGregor of French River on July 22 was attended by an unusually large number of people. The death wounds of the war are not yet healed. There are some still with us. Cecil McGregor enlisted with the 165th Battalion and left Halifax with it in Feb. 1916, while only 17 years of age. The training was too hard for his not fully developed constitution and he never reached the front. He died at St. Arzath on July 17. His mother has gone to see him once again before he passed away but his death took place before she reached the bedside. The deepest sympathy for his mother and sisters is felt by a large community. It was remembered that a year ago the mother had been left a widow by the death of her husband by accident.



WISCONSIN IDEA OF SOFT DRINK BARS

MADISON, Wis., Aug. 9.—Consumers of non-intoxicating drinks in Wisconsin must stand far enough away from the bar to be unable to place a foot on the rail or to set a glass on the counter in order to keep from violating the new state prohibition law according to an opinion today by J. E. Messersmith, assistant attorney general.

The opinion came at the height of a controversy over the exact meaning of a provision of the new law relating to bars, which, according to some officers, required the removal of all bars and screens.

MADRID, Aug. 7.—The column of General Navarro, which was besieged by the rebellious Moors on Mount Arruit has been annihilated, according to a communication received here from General Berenguer, the Spanish high commissioner in Morocco.

Rainmaker Signs Up On Another Contract

MEDICINE HAT, Alta., Aug. 9.—The farmers in this district still have faith in the powers of Charles M. Hatfield, the rainmaker. This was made manifest today when at a meeting of the United Agricultural Association it was decided to engage Hatfield's services for next year.

A new contract was agreed upon in which three inches of rain are allowed for natural precipitation during May, June and July, 1922, and Hatfield will receive \$4,000 an inch for every inch over three inches up to six inches. The maximum amount to be paid being \$12,000.

Although entitled to the maximum of \$8,000 under his contract for this year, the rainmaker reduced the amount by \$2,500, stating that in view of the somewhat disappointing results of this year's operations, he would be satisfied with \$5,500. He explained his partial failure as being due to the fact that the location chosen by the association at Chappries Lake was unsuitable, owing to the prevailing northwest winds in this district. Under his new contract he will choose his own site, and expects to locate about sixty to seventy miles northwest of this city.

By operating to the northwest Hatfield figures that the action of his chemicals will cause the clouds to discharge their contents in the Medicine Hat district instead of drifting into Saskatchewan before unloading, as was the case this year. The rain maker is still convinced that conditions in this district are favorable for his operations and with the knowledge he has acquired this year as to weather conditions and the trend of the atmosphere, he said he is confident he can produce more precipitation next year than called for in his contract.
