### Behind The Headlines At Ottawa

The session of the House of Commons has lasted much longer than anyone had anticipated when Parliament was opened. It was understood that some sort of agreement had been made by Prime Minister King and the leader of the official Opposition, Right Honourable R. B. Bennett, whereby there was to be a certain amount of co-operation between them in order to expedite matters and to permit an early prorogation of the House. The purposes of this agreement were to permit the Prime Minister and the other members of the Cabinet to work out the final details of Canada's preparations for the Coronation in May, and to hold the necessary conferences with important officials prior to the Imperial Conference in London.

However, all arrangements for an earlier prorogation have failed, and no person or party in particular can be blamed for this state of affairs, since it is due to a cause that has not been reported in the ordinary press despatches from the Capital.

It is a fact that the Members of the House of Commons have violated one of their own laws, day after day, by allowing speakers to talk more than the limit set by a rule of the House. This rule ordinarily is enforced very strictly by the Speaker and by the Members themselves, who do not hesitate to shout "Time" when any Member passes the time limit, which is forty minutes for every speech, except those by party leaders, Ministers, and Members who move "substantive" motions. But somehow everyone has been so interested in the topics that were the subjects of discussion in the House that this strict rule has been continually violated by the makers of the laws, and time and again, speeches by ordinary Members passed the forty minutes limit, and yet the unanimous consent of the Members allowed these representatives to continue until they had finished their speeches.

Whether one favours or not Governmental inquiries or Royal Commissions, there is no doubt that everyone in the Capital approves of one of these investigating bodies, and that is the Textile Inquiry.

The reason is a simple one. As a direct result of the operation of the Textile Inquiry, there is a good chance that the Dominion Treasury will be enriched in the near future by some very substantial sums of money, which in one case finds a large Canadian company owing the Government no less than \$468,000.

This Inquiry uncovered certain facts, and amongst them was that there are certain companies which have failed to pay the old business profit war tax, which was replaced about four years ago by the present corporation income tax, and now the Income Tax Department in Ottawa is a very busy scene, because the officials are exploring records and laws, and no person will be surprised if some big news items result from these extraordinary activities.

Even that is not the whole story behind this important matter, because there are strong signs in Ottawa that the disclosures of the Textile Inquiry may encourage the Income Tax Department officials to investigate the possibility of collecting past due taxes in other industries or lines of business in the Dominion.

In face of all efforts to keep certain matters as secret as possible, it is often quite difficult for the Government, or high officials, to cover up their plans and intentions, when these activities are observed by the more experienced Ottawa correspondent, who can draw pretty accurate conclusions from certain movements or tactics on the part of particular persons in the Capital.

### Religious Beliefs Clash With Patriotism

QUARRYVILLE, N. B. March 20 (CP)—Deadlock between twelve pupils and school officials in this Northumberland County village was expected tonight to continue indefinitely, with the children refusing to salute the flag and sing the National Anthem and with the officials consequently continuing an expulsion order against the twelve. Consensus was that the situation would remain unchanged unless the pupils agreed to obey regulations. One official termed the matter "unfortunate and purely local." No comment was made by the Provincial Department of Education.

Miss Muriel Freiger, the teacher, said today there had been no disorder in the school. After the expulsion a week ago last Friday about 35 pupils were left to continue classes in grade one to eight. The children expelled ranged up to 16 years old.

The situation came to a head after unsuccessful efforts of the school officials and parents of the children to reach a solution of the problem, allegedly precipitated by religious beliefs of the people concerned.

These beliefs were said to include opposition to patriotic observance and "man-made laws." Adherents of the creed, numerous in Canada and widespread in the United States, were said to be known here as "Russellites" and to have various other designations.

The situation is believed to be the first of its kind in New Brunswick.
