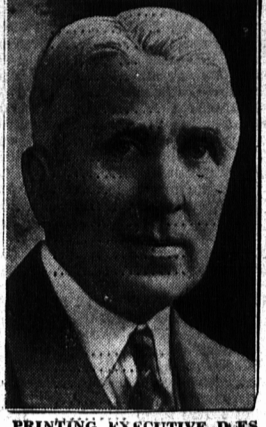
NON SUIT DISALLOWED

Case of M. P. Titus Vs. Town of Summerside Continued.

In the County Court at Summerside yesterday the case of M. P. Titus vs. the Town of Summerside was continued.

At the opening of the court the defendant was allowed to attend his pleas by adding one to the effect that there was no notice of action given pursuant to the statute. The evidence of Neil Durant was then continued for a short time. This concluded the plaintiffs case. Mr. E. H. Strong, K. C., attorney for the defendant moved for a non suit. Mr. Thane A. Campbell, K. C., replied and the remainder of the time up till 5 p. m. was taken up with argument, at the conclusion of which the Judge refused a non suit but reserved the points.

The defense then opened. The first witness examined was Hazen McDonald the officer that made the arrest. This witness was on the stand when the Court rose at 5:30 to resume the case on Monday at 10:30.—S

MANY CASES BEFORE COURT

Magistrate George M. Matthews Presides.

George M. Matthews, Magistrate of Prince County held court at Summerside on Friday. A case from Bedouin where a party was charged under the Fish and Game Act for having muskrat skins in his possession was dismissed and the defendant explained that he had not trapped the animals but had found them dead in the water wheel of the mill and had taken off their skins.

Edwin C. Johnstone who now claims Charlottetown as his home, was charged under the Customs Act and adjudged for judgment into this court was dismissed. This case was in connection with a keg of rum found on certain premises at St. Eleanor's. A second party had confessed that the rum was his and that he had placed it on the premises. Information was laid against him and his case came up before Mr. Matthews Friday afternoon. He pleaded guilty and was fined \$100 or three months in jail. The man was brought before the Magistrate again on a prohibition charge for having this liquor in his possession. He pleaded guilty to this charge and was fined \$100 or seven months in jail.

Six cases were heard where the parties pleaded guilty to the illegal consumption of liquor, and each party was fined \$10, or twenty days.—S

Facts About Cheese

A pound of whole-milk cheese contains about four ounces of protein, the body building element.

When cheese is eaten as the main diet at a meal which is finished with a light dessert, there is no cause for any digestive disturbance.

Cheese is one of the best muscle builders for older boys and girls, as well as for adults, and is entitled to a larger place in Canadian menus.

The cheddar type is practically the only kind of cheese made in Canadian cheese factories. In point of quality Canadian cheese stands absolutely at the top as compared with that which is exported by any other country.

If served in quantity, cheese may well replace more expensive foods in many meals and should be used in this way rather than as a supplement to them. The diet will thus remain well balanced and the cost will be considerably less.

Because cheese is a highly concentrated food, it should be combined and eaten with starchy foods, such as bread. The addition of vegetables and juicy fruits to the menu is advisable. Although cheese may be served without any further preparation, it can be used in cooking in many different ways. It does not lose its favour or nutritive value in cooking, but it should be borne in mind that cheese will be harder to digest if subjected to high temperatures.

The following letter from the Canadian National Silver Fox Breeders' Association on private sales, etc., contains information which will be appreciated by everyone connected with the fur industry here.

Since the regular London Auction Sales have been concluded Sales by private treaty are working out fairly well. In some cases the prices have not been quite so good as at the early auctions—especially in the case of low grade and medium quality off-colour skins. A good number of our skins left over from the October Auctions are being absorbed which leaves us a pretty clean sheet for this year's business.

Continental European conditions have brought about a price drop in nearly all furs and it is indeed surprising to silver fox ranchers to know that the private disposal of "bid in" silvers is progressing so favourably.

Some numbers have unfortunately quite a number of pelts yet unsold but generally speaking not much stale stock will be left over when the new take-off comes on the market and sales houses are expecting a reasonably good demand for December offerings. Although there was some decline in the prices of some classes of silver fox pelts, ranchers have good reason to be proud of the amount of business that has so well during years of stress, culminating in this year of European political disturbances.

By reports received from London Sales Houses we read that furs that were sold a week in the past almost without exception. Oppium and skunk have been neglected, as France and Germany are, at least temporarily, out of the market. Mink and muskrat are somewhat better, but the withdrawals have been considerable which means a large carry over to be offered on December and later sales.

The general view is that there has been a poor demand for red fox skins. Prices generally were low and withdrawals quite general. Cross fox in comparison with May sales.

In view of the trade in these and other furs we see that the silver fox pelt is in a class by itself.

The chief inspector of the Canadian National Silver Fox Breeders' Association reports that inspection has come along nicely and that with very few exceptions all will be completed at an early date.

Claude Smith, Charlottetown, recently spent a week in the vicinity of Alberton and Tignish tattooing foxes in some thirty ranches for the purpose of identification in case of theft. Claude says he saw some very fine foxes in many of the ranches he visited.

The Borden Silver Fox Show with between 300 and 300 entries will be held November 15th and 16th. The committee in charge are sparing no pains to have this show a bigger success than last year. There are classes similar to those of the recent show at Charlottetown and many attractive features including a banquet which will be held on Thursday evening, November 15th, at eight p.m. A new judging room has been fitted up in the Borden rink—where the foxes will be housed—which affords ample light for exhibiting and judging live foxes and seating capacity as well. Stephen Taylor of Little Shemogue, N. B. will be the judge.

Foxes will be accepted for entry up to ten a.m. November 15th and they may be either registered or unregistered. This will therefore give an opportunity to the various unregistered ranches to display their wares and meet the registered animals on the show table. No doubt many will take advantage of the opportunity.

The ever popular Tom Fraser of New York, representing the old reliable C. M. Lampton & Sons auction house of London, England, has been on the Island the past week and was an interested visitor at the exhibition every day. Mr. Fraser says a wonderful improvement in the breed. He has been observing foxes for many years in this province and surely knows it as few men. His father, the late Alfred Fraser, represented ranchmen here in war time and prior to the war and through him many of the consignments which brought tremendous prices on the London sales were negotiated.

Mr. Jacob Rottler of Paris, France, arrived here Thursday afternoon and was a visitor at the exhibition on Friday. It is his intention to spend some time buying Silver Fox furs at the office of B. Graham Rogers, Summerside.

Science Says Dust Causes Fine Colors

WINNIPEG, Nov. 9.—Even dust storms have their silver lining. Without dust, according to students of science, there would be no gorgeous sunsets, no colors and no twilight effects. There would be no blue sky and, what is more important to the agrarian, no rain.

Short waves of sunlight—those that bring the blue light—are scattered by particles of dust when they strike the earth's atmosphere. Above this atmosphere, scientists agree, there is black darkness—in spite of the fact the sun's rays are darting down through wastes of space.

When Auguste Piccard established an altitude record of 84,466 feet on his flight into the stratosphere, he reported passing into bluer air on his ascension. At the apex of his flight the ceiling above him was of such deep darkness he could see the stars at midday.
