Archiving For Meningitis Cure

BALTIMORE, Md., Dec. 30. (By the Canadian Press)—Three Boston research workers appearing here today before the convention of the society of American Bacteriologists charted a course that may lead to victory over the deadly influenza meningitis that attacks infants and young children.
The report described a specific serum treatment for the disease and said that its use by Dr. Ann Knutner, assistant pediatrician at the Johns Hopkins hospital, in twenty four hours completely destroyed infection in a child treated there this year.

REBECCA WALWORTH HAS SKIPPED

BOSTON, Mass., Dec. 30.—An extradition hearing at the State House was thrown into confusion today as it was discovered that Rebecca Walworth, 17, the central figure in a marriage tangle, had disappeared from the hearing room. Police throughout the state were called upon to join in a search for her.
Miss Walworth was listening to representatives of the state put forth their claim for her father, Reginald Walworth, of Wilmington, Del., and John Marshall, 37, of Elkton, Md., who were charged with abducting her. She was seated with her mother, Mrs. Maimie Walworth of Manchester, Conn., with whom she was reunited at the State House after a separation of several years, when she explained she was going to a rest room. She failed to return.
The father and Marshall were arrested Christmas eve at the home of Marshall's father in Danvers. They were arraigned in Salem Court yesterday and ordered held in \$1,000 bonds each until Jan. 11. Miss Walworth was held in \$200 as a material witness. All supplied bail and went to the hearing at the state house today.

TORONTO, Ont., Dec. 30. (By the Canadian Press)—"Bobby" Rosenfeld said today he would decline an invitation to participate in the Canadian trials at Montreal next month for the Jewish Olympic games in Palestine in March, 1932. A report from the Quebec City said the Toronto woman athlete had been asked to take part in the trials.
"I could not go as a competitor," said Miss Rosenfeld, "because I do not care to get back into active training. If I was going to do this, I would train for the world Olympic games next summer. I have no desire to get back into competition."

Gandhi had threatened in London to go through another "purgatory of suffering."
As he sat in a circle of members of the Congress party working committee to report today on the round table conference, he was told by Vallabhai Patel, president of the Indian Nationalists, that "you can't change the heart of the enemy by suffering."
"As for me," Patel said, "I shall fight the British Government until I die."
In his search for the best path for India to follow, however, Gandhi throughout his trip from London sought the guidance of his "inner voice" rather than the advice of others.
"My faith in truth and non-violence has become strengthened by my European visit, if there was room for any further strengthening," he said.
"I have no further end to serve in this life."
From the tense, introspective expression on his face, it was apparent that he was struggling with his "inner self" to find escape from the responsibility of plunging India afresh into civil disobedience, the non-payment of taxes and the boycotting of British goods.
