**CHEAP CLOTHES ARE AN EXORAVAGANCE**  
Elsa Schiaparelli, Parisian dress designer who is in New York, avowedly to obtain some rest, see some shows, and do a little shopping in the city's five-and-ten cent stores. Mme. Schiaparelli reported that Parisian women were now wearing suits not only for morning and afternoon wear, but also in the evenings. She said she had designed two evening suits, embroidered with gold, or pearls, lined with vivid colors, equipped sometimes with tweed jackets to match and sometimes with tweed or fur capes. "Anything new in lingerie?" she was asked.

"Less and less of it," she said. "I feel lingerie is passing out, because so few women can afford the upkeep. To maintain beautiful lingerie you must have a very good maid and they are few. It is very sad."

Mme. Schiaparelli believes women would do well to limit their wardrobes to a comparatively few garments, all of superior quality. Her idea of a sensible basic wardrobe for an average business woman or housekeeper who wishes to look "frantically smart" on a modest income, would include the following:

One fur coat.  
One tweed suit.  
One black or dark blue suit for town.  
One silk dress of good plain material, for afternoon wear.  
One woollen dress.  
Two evening gowns, one with a jacket, "not too décolleté," the other dressy.

Four pairs of shoes; one for sport wear, one pair of plain walking shoes, one pair of dressy black shoes, one pair of pumps, and two pairs of evening shoes.

"That would do for nearly every woman who hasn't too many social calls—far rarer plain-living women," Mrs. Schiaparelli said. "It's absurd to have quantities of clothes, cheap ones. It's not an economy."

Schiaparelli was dressed in a carbon-blue tweed suit, and an unluckily beaver hat designed after the bushy of the English Guard type. Her eyelashes were tinted bright blue.

### Commercial Travellers' Annual Meeting

HALIFAX, Dec. 11—Membership in the Maritime Commercial Travellers' Association had increased to 1,515, it was announced tonight at the 55th annual meeting of the organization, attended by the largest delegation from New Brunswick in years.

Too often the careless placing of lighted candles has resulted in painful burns, and even death to those participating in the Yuletide festivities. "Santa Claus" has been the victim in innumerable cases.

"Tiny electric lights now are most used in decorating the Christmas tree, and that reduces the fire danger materially. If candles are to be used in the decoration—and they undoubtedly lend an effect not to be obtained by the electric lights—they should be placed on the mantel and in other secure locations where contact with their pretty flames is not likely to be made.

### FREE STATE MOVES FOR INDEPENDENCE

**De Valera Said no Break With Empire Planned.**  
(A.P. by Guardian's Special Wire)  
DUBLIN, Dec. 11—In the only land where tonight Edward VIII still was King, the Irish Free State parliament pushed to final passage a bill abolishing the office of governor-general.

Thus, the Free State made itself further independent of Britain although President Eamon de Valera made it clear there would be no break from the Empire.

De Valera planned to present to the Dail tomorrow legislation confirming the accession of King George VI, but without that legislation tonight Edward VIII was technically King.

Henceforth, under the bill passed tonight, the King's name will be used only in the conduct of foreign affairs of the Free State.

Governor General Donald Buckley was expected quickly to sign into law his own official death warrant, passing to De Valera and the Speaker of the House the duties he had performed in the name of the King.

A vote carried 71 to 53 today on a government motion to invoke rigid rules to hasten passage of the constitutional measure.

To the crowded special session of the Dail, De Valera proclaimed: "This is a matter which affects ourselves alone."

Opposition attacks were led by W. P. Cosgrave, leader of the United Ireland Party, and William Norton Lee, Labor, but President De Valera said he was determined to complete action tomorrow.

Lee held the legislation was "being rushed through with indecent haste."

To Cosgrave's question whether De Valera intended to sever all relations with the British Commonwealth and whether he had consulted other members of the Commonwealth, the Irish President replied he had informed the British Government but had not had time to consult the Dominion Governments.

"Canada, Australia, New Zealand and South Africa have agreed to certain action in the present position," De Valera said. "But the Free State Government was not prepared to give assent to the idea that the British Parliament could legislate for the Free State."

The Free State would remain in the Commonwealth, De Valera said, but would limit its use of the King's name to foreign affairs, and the continuance of the monarch's name in accrediting Free State ministers would be dropped, he indicated, if other autonomous Dominions did likewise.

**Takes Final Stroll Around Fort Gardens**  
LONDON, Dec. 11—(CP-Havas)—Bareheaded and with a terrier at his heels, Edward VIII took a last stroll today through his much-loved gardens at Fort Belvedere.

The close guard maintained around the abdicating King in the last hours of his reign was already relaxed. Watchers were able to come close to the grilles and gates and through the sun-pierced fog they saw the ex-Monarch, dressed in knickers and jacket, taking his last stroll at his country retreat.

Even from a distance, watchers could sense the melancholy mood of this last walk.

Edward stopped for a moment at the swimming pool where it had been his custom to take a daily plunge.

He seemed to be engraving the memory of happy hours to take away with him. He gazed up at the battlements and towers of the castle.

In those days there were no poles at the gates. The barriers opened in response to an automatic mechanism when the whimsical, fun-loving couples drove up to pass a few days with their friend the King. During the summer nights neighbors or passersby could clearly hear the songs and laughter through the out-flung windows of the brightly lighted castle.

These parties shocked none of the neighbors, all of whom loved the King for his democratic ways. The groups at the gates yesterday and today made no effort to check their tears as the baggage-laden cars, with the insignia of Edward Rex erased, shot out Londonward.

### Royal Bank Appoints New Director

**NORMAN LAWRENCE LEACH OF WINNIPEG, IMPROBANT FIGURE IN GRAIN TRADE.**

MONTREAL, December 11—The appointment of Mr. Norman Lawrence Leach of Winnipeg, as Director of The Royal Bank of Canada, is announced by the Bank's Head Office today.

For the past 30 years Mr. Leach has been closely identified with Canada's grain trade and the commercial and industrial life of Winnipeg. At one time he was President of the Winnipeg Grain Exchange and today holds high executive posts with a number of important grain companies.

Mr. Leach was born in Toronto, in 1876 and educated there. He settled in Winnipeg in 1906 on his appointment as General Manager of the National Elevator Company, Ltd., and in 1927 joined the Searle Grain Company, Ltd., of which he is now President. Mr. Leach is also President of Searle Terminal Ltd., Vice-President of the Home Grain Company, Ltd., and Vice-President of the Northern Elevator Corporation, Ltd. He is a Director of the Grain Insurance and Guarantee Company and a member of the Winnipeg Advisory Board of the Royal Trust Company.

**Comments "News" Handling By The Press And Radio**

OTTAWA, Jan. 11—If Canadians required any confirmation of the wisdom of the public service system of radio broadcasting in this country, they have had it in emphatic manner through the historic events of the last 10 days.

Gladstone Murray, general manager of the Canadian Broadcasting Corporation, stated in an interview here today:

"Nothing could have been more injurious to the interests of the nation or, I would judge, more distasteful to the people themselves than a flood of irresponsible rumors and reports and unconfirmed commentaries on the critical situation at the heart of the Empire, to which they might have been subjected in the absence of organization."

"I would like to pay tribute to the admirable manner in which the news of the situation was handled by that fine news gathering agency, The Canadian Press, which co-operated in providing brief but reliable broadcast bulletins for Canadian listeners."

"My personal opinion, supported already by a considerable body of listener opinion, is that the high-light in the whole field of commentary on the abdication of the King and the succession of his brother was the broadcast on Thursday night of our own Canadian C.B.C. commentator, Dr. H.L. Stewart, who was heard from Halifax. His was a model, indeed a classic commentary, distinguished by compactness, good taste, choice of language and understanding of the situation."

"The Canadian Broadcasting Corporation had no thought, in connection with this greatest of news stories, of trying to achieve a competitive position in giving the news to the public. It did not seek 'spoils' nor did it attempt any censorship."

"I thought only to give reliable information to the public as quickly as possible, and it accomplished this through the co-operation of The Canadian Press and through arrangements with the British Broadcasting Corporation, the National Broadcasting Company, the Columbia Broadcasting System, and the Mutual Broadcasting Company."

**Flags Will Be Flown From The Masthead**

OTTAWA, Dec. 11—Flags will be flown in the usual way tomorrow when accession of the Duke of York as King George VI is proclaimed. Government officials said today.

At the time of the proclamation for King Edward VIII flags were at half-mast owing to the mourning period for King George V. For a few hours they were raised, then lowered again.

### SCOTLAND IS PROUD OF NEW QUEEN

(By Thomas T. Champion Canadian Press Staff Writer)

LONDON, Dec. 11—All Scotland today reflected pride that one of her daughters has become Queen consort. Scotland certainly will claim the Duchess of York as a daughter, even though her birthplace was Walsdenburg in the pleases and vales of Hertfordshire, England.

Perhaps the feeling through the north country today harmonizes best with the comment of an old Scottish woman, when Queen Victoria's daughter, Princess Louise, in 1871 married the Marquess of Lorne, afterwards ninth Duke of Argyll.

"The Queen will be a proud woman with her daughter marrying an Argyll," said the old woman.

The House of Argyll possesses a lineage almost every whit as distinguished and as lengthy as the Royal House itself.

So it is with the family of the "Little Duchess"—the gracious lady who today became Queen Consort. Royal blood in fact flows in her veins. Robert II of Scotland, a grandson of Robert Bruce, bestowed the Thanedom of Glamis on John Lyon, who married the King's second daughter, Lyon.

Founded the family from which the new Queen Consort's father, the 14th Earl of Strathmore, is descended.

Some grim incidents are contained in the family history. Janet Douglas, widow of the sixth Lord Glamis, was burnt for witchcraft at Edinburgh in 1537. Six years later the unfortunate woman's innocence was acknowledged.

Sir Walter Scott, who stayed at Glamis, tells of the secret chamber, the entrance to which is by law or family custom known only to three persons, the Earl, the heir to the earldom, and a third person selected by them. Even today the legend exists of a dark family secret locked in the breasts of the trio being revealed to the heir when he comes of age.

Historic truth shows that the association of Glamis with the murder of Duncan by MacBeth is merely Shakespeare's poetic license, even though some parts of the present castle stood in MacBeth's day.

year ago. Immediately after completion of the over-sea broadcast of the proclamation ceremonies in London, Prime Minister Mackenzie King will go on a coast-to-coast network to read the Canadian proclamation, followed by Justice Minister Ernest Lapointe reading the same document in the French language.

Concluding with the firing of the Royal Salute of the King in London a series of 21 guns, will be fired by a battery stationed on Parliament Hill in Ottawa, at approximately 11:05 a. m.

Following the cabinet session tomorrow morning the Clerk of the Privy Council, S. J. Lemaire, will proceed to Rideau Hall to obtain the Governor General's signature.

At the same time he will administer the oath of allegiance to Sir Lyman D. DuRoi, Chief Justice of the Supreme Court of Canada who will in turn administer the oath to Lord Tweedsmuir and to Mr. Lemaire. The Clerk of the Privy Council will then return to the Privy Council chamber where he will administer the oath of allegiance to the members of the Government, following the proclamation proceedings.

As soon as may be convenient new oaths of allegiance will be administered to all servants of the Crown, a procedure that will extend over many months. In the meantime by virtue of the order-in-council to be issued tomorrow, all these officials will function legally.

Secretary of State Fernand Rinfret has written all Lieutenant Governors of the provinces advising them of this procedure and it is generally expected the same course will be followed by the provincial authorities.

Flags on all Dominion buildings will be flown at the masthead tomorrow from eight o'clock in the morning until sunset. From the carillon in the Peace Tower will come the strains of the National Anthem at 11 o'clock. A. S. T., the actual time of the proclamation in London.

There is no mourning period so the flags will be flown from the masthead.

Lodge, Edward was driven back to Fort Belvedere—the secluded lodge where in the twilight of his reign, he, alone, worked out his solution.

**Lavishly Cheered**  
Huge crowds gathered in the darkness outside the old castle which towers above the countryside from a hill overlooking the Thames.

Lavishly they cheered him in farewell. Before he finally left Windsor, Edward personally said good bye to old servants and royal retainers many of whom he had known since he was a child.

Edward's reign of less than 11 months passed into history at 1:32 p. m. (9:52 a. m. AST) Dec. 11, 1936, and his brother, Albert, became automatically King George VI, Sovereign of some 500,000,000 subjects in a realm covering almost one-third of the globe.

In action swift for all its solemnity, Parliament required only two hours and two minutes to end the reign of Edward VIII and to give the 42-year-old man freedom to marry the woman he loves.

The first voluntary abdication bill in the long history of the British Empire was passed into law with only five members of the House of Commons voicing opposition.

The House of Lords accepted Edward's abdication and his brother's accession in just six minutes—six minutes to write perhaps the most amazing annual of the world's biggest Empire.

**Meet Today**  
Both Houses will meet again at 2:45 p. m. Saturday (9:45 a. m. EST) to take the oath of allegiance to the new Sovereign after King George has taken his vows as King in historic St. James Palace at 11 a. m.

On Monday, the new King's 14th day, he will send a message to Parliament in which leaders of the realm anticipate assurance from the new King that he will steadfastly use his high office in the advancement of the Empire.

Christened Albert Frederick George, the second son of the late King George V, the new King will reign as King George VI.

In a manner as expeditious as it was grave Parliament accepted the Abdication Bill and passed it on to the Dominion Governments all of which, said Prime Minister Baldwin, had indicated it would have their approval.

The Government was most concerned over the reaction in the Irish Free State, where President Eamon De Valera introduced into the Dail Eireann a bill abolishing the office of governor general and abandoning the use of the King's name in internal business.

Canada, New Zealand, Australia and South Africa, the Prime Minister said, would accept their third King within the year and would work with him in the interests of the Empire.

The Abdication Bill was formally presented by a three-man Royal Commission headed by Edward to act for him in the matter of giving up his Throne.

"The Demise of the Crown"  
Edward's formal abdication bill was presented to a grave-faced Parliament and passed through the necessary three readings.

Prime Minister Baldwin put the motion to a vote with the words: "This is the last bill which will be presented for Royal assent during the present reign."

The act was labelled: "The Demise of the Crown."  
It was not without minor opposition, however, that the bill was enacted into law.

James Maxton, Independent Labor party leader, first introduced a motion opposing passage after a speech in which he said the British monarchy was a "fool's paradise."

His motion was seconded by Campbell Stephen who asserted the only reason advanced for retaining the monarchy had been that it alone remained the link binding together Britain and her Dominions.

"If that is the case," he said, "the Empire is being held together by a very weak link."

"The dilemma of the King," he continued as the House rumbled impatiently, "arose because the King, like the rest of them, was a human being. The problems that have arisen in the present instance might well arise in the next few years."

"I know that the new Monarch is a married man. So was Mr. Simpson, and just as it happened with others it also might happen here."

The Commons speedily voted down Maxton's motion by a vote of 409 to five, and then passed the abdication bill without a record vote.

The Prime Minister and the members of Parliament then marched into the House of Lords to witness the final chapter.

The clerk announced receipt of the bill from the House of Commons and the Peers passed the first reading.  
Lord Halifax moved second reading.  
Lord Snell, opposition leader and Lord Mottistone, for the Liberal Party, pledged their support of the bill and it was moved through second and third readings in a matter of minutes.  
"Le Roy Le Veud"  
Thus, in four words of ancient Norman French ended the reign of Edward VIII.  
Here began the reign of King George VI and his Queen Elizabeth, herself born a Scottish commoner.  
And in this manner began the exile of a 42-year-old man from his home and countrymen so that he could become the husband of Wallis Warfield Simpson.  
After the former Duke of York takes his oath of accession in St. James, heralds will step out onto the balcony to create the fanfare for formal public reading of the document.  
Then, as always, the first act in the official start of a new reign will be the summoning of the Privy Council to proclaim the accession.  
They then will meet the King and immediately take their oaths of allegiance after which he will declare his accession and take another oath relating to the security of the Church of Scotland.  
At the same time the Houses of Parliament will be taking their oaths of allegiance.  
In centuries-old, colorful ceremonial will the public proclamation be made.  
Officers of arms, wearing the picturesque tabards, will assemble on St. James balcony in Priory court where, after trumpets have been sounded three times, the garter principal King of Arms will read the proclamation ending with a lusty:  
"God Save the King!"  
PORTSMOUTH, Dec. 12—(Saturday)—(AP)—Edward VIII sailed at 1:50 a.m. today from the land of his birth.  
The yacht Enchantress conveyed by the destroyer Wolfhound slipped from the harbor under scaled orders, bearing away the man who was King into voluntary exile.  
Because of the strict secrecy surrounding the departure and the darkness it was not immediately known whether Edward was aboard the destroyer or the yacht.  
Under a clear and starry sky amid the hundreds of lights of vessels in the harbor, the ships passed from the shores of England. The last seen of them was their deck lights fading in the distance.  
The yacht and the destroyer both lay in the harbor with steam up when Edward arrived at the navy yard by automobile earlier and went immediately to the residence of Sir William Fisher, commander-in-chief.  
Lieut. Col. Piers Legh, the former King's equerry, and Chief Inspector David Storer of Scotland Yard, Edward's personal detective throughout his reign and member of his domestic staff, accompanied him.  
There was a bustle of activity on the Wolfhound as luggage was rushed aboard.  
Naval authorities blocked approach to both vessels. They could be seen only from a distance.  
The yacht thought to be carrying Edward away from England moved slowly from her berth and passed through the narrow strip of water leading past the railroad jetty out into the spithead.  
CANNES, France, Dec. 12—(Saturday)—(AP)—Unverified rumors, circulated here early this morning that the former King Edward, who sailed from Portsmouth at 1:50 a.m., was going to the Free City of Danzig.
