FOREIGN TRADE CONVENTION

According to information received at the American Consulate Saturday from Washington, the National Foreign Trade Council, India House, Hanover Square, New York City, desires to extend to foreign business men contemplating a visit to the United States, and to Americans doing business in foreign countries, an invitation to attend the Ninth National Foreign Trade Convention, which is to be held in Philadelphia, Penn., May 10, 11, and 12, 1922.

Though this is not a government body, and the proposed convention is not to be held under Government auspices, and although invitations are therefore not extended officially by the Government of the United States, the plans of the Council are cordially endorsed by the Department of State.

In extending the invitation Mr. O. K. Davis, Secretary of the Council states the Convention is primarily a gathering of representatives of all phases of the international commerce of the United States from all parts of the country, for the discussion and consideration by business men of all the problems arising out of their daily transaction. Special study is given to markets abroad and PRODUCTS OF WHICH MAXIMIZE FACTORS IN TRADE with the United States. It is pointed out that it is therefore reciprocally to the advantage of the producers and distributors in foreign markets, as well as those of the United States, to meet at such a convention for the mutual interchange of views and information regarding market conditions, production, trade customs and regulations, and all matters affecting the free and profitable flow of commerce between them.

Catch of Sea Fish Valued at \$729,083

OTTAWA, Feb. 28.—There were 305,904 cwt. of sea fish valued at \$729,083 landed on the Atlantic and Pacific coasts of Canada during January of this year, according to statistics available today there the same period last year there were 178,698 cwt., taken with a value of \$648,522, the value given in each instance being the value of fish when first brought to land. The increase was due almost entirely to large catches of herring and halibut on the Pacific coast, the quantities landed of each being more than double that of the month of January, 1921.

On the Atlantic coast the catch of smelts was 36,911 cwt., compared with 27,272 cwt., in the same period last year. The catch of lobsters was slightly less than January, 1921, being 684 cwt., compared with 752. The total landed since the commencement of the new season was 1,579,956 cwt., compared with 7,088 cwt. during the same period last season.

On the Pacific coast 16,252 cwt. of halibut and 197,398 cwt. of herring were landed, compared with 7,956 cwt., and 80,992 cwt., respectively during January, 1921.

DIRECTOR IN CONSTANT FEAR

LOS ANGELES, March 2.—William Desmond Taylor, slain motion picture director, lived in constant fear of death by violence, according to statements made today by W. S. Underwood, held in the county jail on an embezzlement charge. Underwood declares Taylor frequently told him of his premonition that he would be slain, but never divulged the name of the person, or persons, he feared, and always declined to give the reason for his belief.

Edward F. Sands, sought for weeks in connection with the slaying, was in Los Angeles on the day following the crime preparing for a quick dash to Mexico, Underwood said. He added that he was a personal friend of both the missing man and the slain director, and that he attended a number of parties given by the latter.

Underwood was arrested some days ago at Topeka, Kansas, at the instigation of persons who he believed he was Sands. He was later held on a charge of embezzling funds from the Pacific Electric Railway Company. He is to be tried here on that charge.

Underwood declares that he met Sands at the corner of Seventh and Broadway on February 2, the day following the slaying. After a few words of greeting, he asserts, Sands said: "Well, I'm heading south. I probably won't see you again."

"Where are you going?" Underwood said he asked. "Either Mexico or South America," Sands is alleged to have answered.

Underwood made a statement which in substance is as follows: "Some weeks previous to the murder I was sitting alone in a downtown cafe, when Taylor and a party of friends entered and took the table next to mine.

"He was in a jovial mood, and within the next thirty minutes, observing that I was alone, invited me to join the group. I accepted.

"In the party was a number of women I recognized as having been on the motion picture screen—women that were known to the world over as actresses of the first degree. I will not give their names, because I do not wish to involve any of them in this unpleasant affair.

"These same women, however, I saw on numerous occasions when I was a guest at the Taylor bungalow on Alvarado Street. I have my own theory regarding the slaying and the connection of these people with it, but as to this angle I have nothing to say."
