preside as Circuit Judge. He was admitted to practice in the United States District Court at Grand Rapids, Michigan in 1873.

On October 10th, 1868, he was married to Olive Lyle, only daughter of John and Ann Lyle, and to them were born six children, three of whom are still living, May Carr Smith of Rice Lake, Wisconsin, Bessie Carr Hill of Ripon, Wisconsin, and Carolyn E. Carr who resides in Saginaw, Michigan. All are here to pay their last tribute of respect to their beloved father. He also leaves three grand children, Sidney and Olive Smith of Rice Lake, Wisconsin, and Elizabeth Ann Carr of Saginaw, Michigan.

Mrs. Carr died on October 25th, 1894, and in 1901 Judge Carr married, in Boston, Massachusetts, a former Detroit, Michigan schoolmate, Carrie Lavinia Nutting, who remained an affectionate and helpful wife to him to the day of his death and who survives him. He peacefully passed away at his home in Cassopolis, Michigan, on Friday morning, November the tenth at the hour of nine.

Judge Carr's public career was one of marked activity. Soon after his graduation from the law department of the University of Michigan he located in Cassopolis, forming a partnership with Hon. Marshall L. Howell and who a few years ago preceded him in death. Mr. Carr and Mr. Howell were former classmates at Ann Arbor. This partnership continued for a great many years and up to the time that Mr. Carr was elected Circuit Judge in 1899, and the firm of Howell and Carr was widely known and was recognized as one of the ablest and most efficient law firms in the state.

Mr. Carr's ability as a lawyer was very early recognized, and notwithstanding the fact that he lived and practiced law in a county where the political odds were against him, his sterling worth and his confidence that the people reposed in him overcame, many times, the opposition, and he was honored as the people's choice.

He was elected as Circuit Court Commissioner in November, 1870 and served in this capacity from January 1, 1871 to January 1, 1873. He served as Prosecuting Attorney from Jan. 1, 1883 to Jan. 1, 1887. He was the nominee of his party for Circuit Judge of the thirty-sixth judicial circuit comprising the counties of Cass and Van Buren in 1899, and although the district was normally Republican by a large majority, he was elected over his opponent, Benjamin F. Heckert by a plurality of 612 votes. Though defeated for a re-election, he carried his home county, normally Republican, by a majority of 893. He served as Circuit Judge from January 1, 1900 to January 1, 1906. His incumbency as Circuit Judge was distinguished by decision. When Judge Carr spoke, there was no doubt as to his ruling, or as to the meaning of what he said. The key note of his character was decisiveness. He had the confidence of his constituents and the courage to stand by them. He knew no compromise with what he considered wrong. Where others would have hesitated, vacillated or doubted, he took a firm stand. There was no middle ground. When policy and right conflicted, policy gave way. The right with Judge Carr was not subject to qualification. Right was right.

He was one of the organizers of the Cass County State Bank and was a director of this bank for a number of years. He was president of the Cass County Bar Association until about one year ago. He retired from actual practice several years ago and spent the last few years of his life in kindly counsel with his fellow attorneys and with his neighbors, friends and family. MRS. HELEN POWER

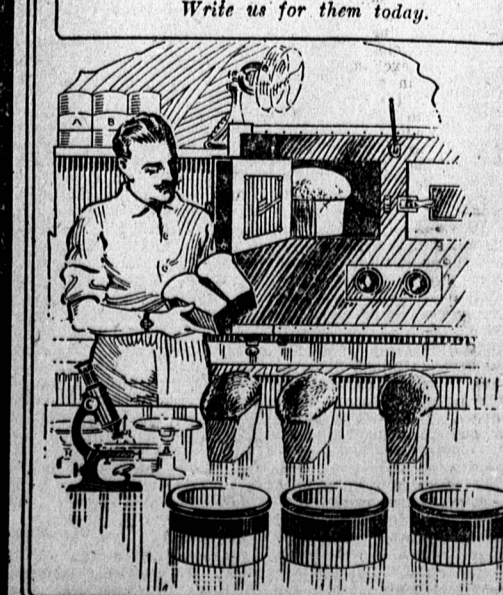

Hogs weighed at country points, fed as they have been, will not dress over 72%, organs in, for an average shipment. To country price must be added freight, buying expenses and shrinkage of 16 to 20 lbs. per hog, all of which figures 11c per lb. at present price.
