PROFITABLE YEAR—The annual meeting of the shareholders and patrons of the Crapaud Creamery Co., was held in Crapaud Hall on Tuesday, Jan. 17th, 1933, at 2 o'clock in the afternoon with a large attendance. The reports of the year's business showed a make of 181,000 lbs., an increase of 46,000 lbs. over the previous year and one of the largest makes in the history of the factory. 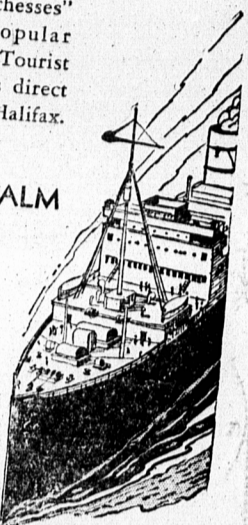
