being for the son to draw much attention. Probably the remarkable resemblance between father and son was something of a hindrance to the latter. Both carried themselves with a certain starchy. The monodie which they affected made them appear still more stand-offish. Even the monodie did not save them from being so near-sighted as to be unable to recognize acquaintances at any distance beyond a few feet.
There are old Parliamentary hands today, though, who remember vividly when Austen Chamberlain made his maiden speech in the Commons. With old-world straightway offered the comment that the effort to which the House had just listened would be "dear and refreshing to a father's heart". Facing Gladstone across the Table of the House was Joseph Chamberlain. For the only time in his long career Joseph Chamberlain was observed to be profoundly affected by a speech of one of his political opponents.
Sir Austen was Chancellor of the Exchequer twice. The first occasion was when his father resigned to conduct his campaign for Imperial Preference in the country, and when, as opponents declared, Austen "held the keys of the safe during his father's burglarious campaign". The second period in which Sir Austen was chancellor was in the Coalition Government of 1915, when he produced the Excess Profits Duty as a substitute for the Capital Levy proposed by the Labor Party. Of the break-up of the Lloyd George Coalition it is only necessary to recall that Sir Austen refused to believe the time had arrived for a break. The refusal left him with no place in the Boner Law Cabinet. When Premier Baldwin formed his second Cabinet, though, Sir Austen was brought in as Foreign Minister.

last November before a Conciliation Board sitting here under Mr. Justice A.K. MacLean. He claimed that from 1920 to 1935 the total annual payments in wages to railwaymen in Canada decreased 42 per cent. At the same time, he said, interest payments on railway debt increased 97 per cent.
"and railwaymen are aware," he added, "that 89 per cent of the Canadian Pacific Railway payments to bondholders goes out of this country."
The railways, he went on, are like a man who spends his week's pay in a tavern and then comes home to borrow money from his wife.

We represent the housewife. The railways squander their earnings in interest payments to foreign bondholders. Then they ask us to accept a 10 per cent cut in wages.
"The depression started in 1929. In the next year, 1930, the C.P.R. paid the biggest sum in dividends in the company's history. In 1931 when they were already asking us to accept wage reductions they paid another dividend."

The "strike ballot" submitted to 117,000 railway workers is intended to give the conference committee full powers to call a strike or take other action considered necessary in forcing the men's demands. Results of the vote may be given out at the Thursday meeting, said Chase.

HALIFAX, March 16—(CP)—A gale which reached a velocity of 38 miles an hour swept coastal Nova Scotia today, but no damage was reported. Heavy rain accompanied the high winds.
The steamship Belle Isle, arriving here from Newfoundland, reported encountering a strong gale all day.
"It was blowing a full gale about 50 miles an hour," Captain B. Kristianson said tonight. Visibility off the harbor was nil and we had to feel our way in."
Strong headwinds delayed the steamship Yarmouth four hours today on her regular run to Yarmouth from Boston.
Communication companies maintained services, although several wires "went bad" because of rain and wind.
