PORT ARTHUR, Nov. 26.—After making a trip of twenty-three miles over frozen trails to the Silver Islet fox farms, operated by the Cross Brothers, John Sandhill, George McKeloid, and Fred Hudson, used wire cutters to break their way through the netting, captured and killed nine foxes with a value as fur bearing animals of five thousand dollars and much more as breeders, according to evidence adduced at the trial of the three men today. Sixty Years Conflict With Liquor Evil in P. E. Island
A SERIES OF PAPERS REVIEWING DRINKING CONDITIONS AND TEMPERANCE EFFORTS AND ATTEMPTS UP TO OUR PRESENT DAY OF PROHIBITION ACT ENFORCEMENT
(By an Observer)
THE RED HEAT OF WARFARE

The adoption of the Scott Act was the signal for a battle royal between the defeated traffic and the victorious temperance forces, in which the genius and energy of both parties were taxed to the utmost. In the effort of the one to gain, and the other to maintain supremacy. For the temperance party the barometer of success had its low as well as its buoyant attitudes, yet in its lowest markings it never registered absolute failure. The liquor traffic, strong in organized, rich in funds, strong in the man power backing of thirsty mortals and chronic opens, and, like the tiger enraged by the loss of its whelps, more active in hostility by the threatened abolition of their right of punch and their daily grab. Law breakers and characters of the reckless and unprincipled type were then, as now, a notable attachment to their militant forces. Acting upon the false assumption that by violence they could silence the temperance party, they adopted every measure of lawless attack that their depraved minds could conceive, and their cowardly natures dared to carry out. Shaving of horses tails, setting fire to buildings, molesting individuals and sending anonymous letters, threats, were amongst their practices. These, instead of accomplishing the designs of the liquor party, had the opposite effect, of firing those under attack into more vigorous action and of arousing an outside popular indignation, diverting public opinion against the traffic, of which such outrages were the natural fruit. With plenty of wealth at their command they engaged the ablest lawyers to defend the fraternity in the courts, and carry test cases to the highest tribunals, in some instances to await Privy Council decisions in analogous cases of other provinces. Questions, even though hopeless from a legal standpoint, there was apparent flaw to give them grounds of action, would be carried into litigation, not so much to anticipate success, but rather to hold up the Act for a period, during which they would still have opportunity to ply their nefarious business.

In practically every effort, the liquor party in general, and all liquor party council decisions maintained the rights of the people to govern their own constituencies. These decisions put a quietus on frivolous appeals, and supplied a healthy backbone to our laws and a stimulus to our courts in their administration.

Following this, apparently again to gain breathing time, individual cases were removed, on frivolous pretexts, to the higher courts, with such frequency that the legislature was constrained to take away the right of certiorari in certain cases, in order to abate the nuisance. Then too, there was the effort, still practised, of getting after politicians and ruling powers, to choke off convictions, reduce penalties and unseat various members of the parliament in the cases the writer conversing with a noted offender, who obtained release from jail because "seriously ill with indigestion", heard him ridicule the newspaper item with the remark—"I was twice fined, first on account of a supper of the Act, or a belief in temperance, but I am an officer of the law, and will never shrink my duty. The case must go ahead, and it did, with a \$50 fine. The next two cases were against an illicit seller in Southport, who was twice fined, first on account of offences, but he had fewer of friends to protest, and it excited less interest.

For a year or two after it became law the Act had to depend for enforcement almost wholly upon private individuals, and segregated temperance organizations. With a strongly organized liquor party, their existence as grog dispensers at stake, in active contention at every stage, the demand for greater concentration became urgent. It was to meet this need, that P. E. Island Temperance Alliance—an affiliate of the Dominion Alliance—was formed.

On July 19th, 1881, at a meeting of temperance workers called from all parts of the Province, and representing temperance societies and citizens of all classes and creeds, the Alliance was organized, with a formidable personnel and a substantial social support. Frederick W. Hales, then Sec'y. of the Steam Navigation Co., was its first president and the Rev. G. W. Hodgson, Rector of St. Peter's, Sec'y. It demanded no pledge from its members, except diligence in obtaining and enforcing temperance laws. While total abstinence was desirable it was not a requisite to membership.

From that day to the present, this Alliance has been the central factor in every move made, either to secure legislation, or to enforce, of temperance law. Through it churches and societies have spoken, for all are parts of the composite of it as an active body, its strength it was further implemented by the formation of auxiliary branches known as County Alliances.

Another great force, cooperating in all efforts at social reform, was the Women's Christian Temperance Union, a national organization of which Francis E. Willard, a world wide renowned, was president, and of which in the Island branch Mrs. Dr. Richard Johnson was the energetic local president for many years, with Mrs. Judge Henley, and Mrs. Jas. Deshrisay, secretaries. If the efficiency of an association can be judged fairly by the amount of abuse heaped upon it by opponents, and it is often a good criterion, then the laurel wreaths of excellence were surely the reward of the W. C. T. U. It was an evident thorn in the side of the lawbreaker, in the press there were pious reminders by liquor advocates that they would be better at home looking after their erring offspring, or preparing their husband's meals, what they were so fond of poking their noses in other people's business, and on the street, amongst the more vulgar, "pot wollers" and more unmentionable epithets were applied. The Society and the Catholic Total Abstinence Union, the latter more provincial in character, were established as the fruit of his inspiration, in which he held office as Spiritual Director. The League of the Cross, the largest and most effective young people's temperance organization in the Province, with a present membership of about four hundred, was instituted by Rev. Father McElmeel during Bishop McIntyre's pastorate.

It will be seen from these activities that this great religious body, representing nearly half of our population, were fully alive to their moral obligation, and in their training, the fruits of their labors can not be measured to the limited vision of human judgement.
