but, of course, he like the rest on the other side, tried to make out that there was no surplus at all. He also saw in that book \$15,000 charged as a contribution to the Patriotic Fund. If that had not been charged there the surplus would have been \$10,000 plus \$15,000. There was also \$6,000 more of war expenditure, and another payment to Walter Lowe on a judgment recovered in 1914. If that had not been charged in the public accounts there would have been so much more of a surplus; but we chose to do the thing that was right and just and therefore showed a result on the whole \$28,000 less than could have been shown if we had liked to follow the technical course suggested by the Opposition. The only excuse the honorable gentleman has for his ignorance is the lateness of the night, and he ought to be in bed asleep. (Laughter.)

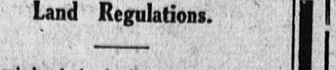
