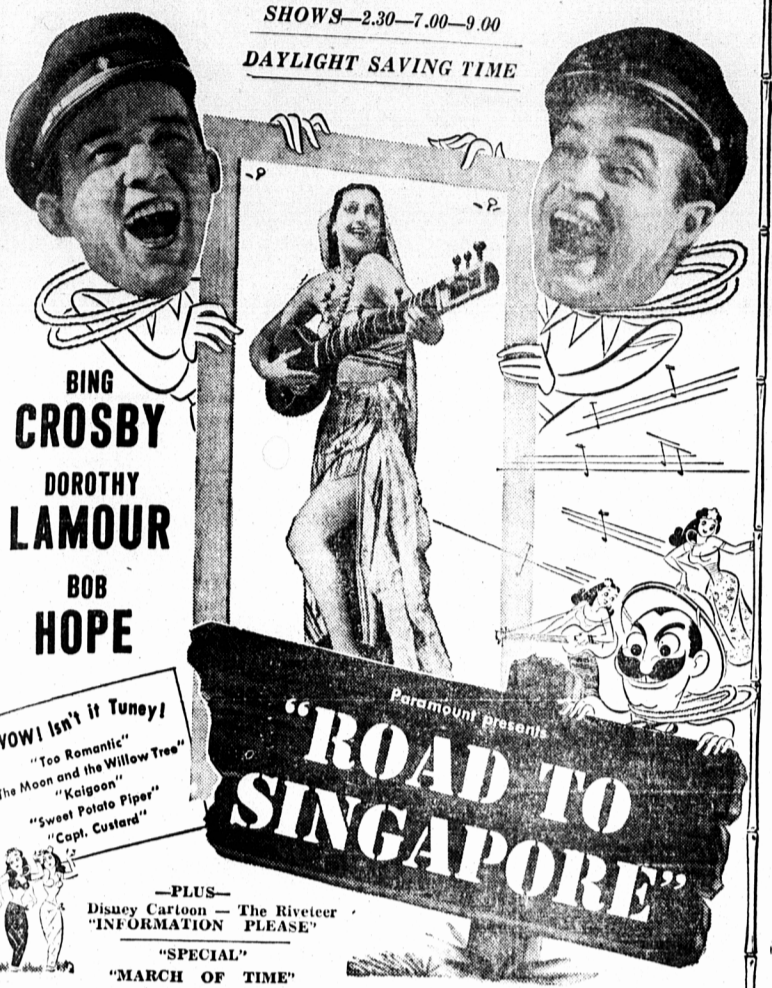

Later Col. MacKendrick showed Mr. Power around as well, and the Associate Defence Minister showed a keen interest in the vigil the Canadians maintain day and night.

Council Is Called

By United Church

Made up of 268 commissioners, consisting of an equal number of ministers and non-ministerial members, the General Council of the United Church of Canada will meet in August in Winnipeg, United Church, Winnipeg, on Wednesday, September 11, and will remain in session for at least one week.

Commissioners to General Council are chosen directly by the eleven Conferences of the Church, or elected by Conference on the nomination of Presbyteries. Both Presbyteries and Conferences are composed of ministers within their bounds and of elected representatives of local churches.

Among the matters to be discussed at General Council are reports of a special Commission on Ministerial Salaries; on recruits for the ministry; on the finances of the Church and on urban problems. The tenure of the Moderatorship will also be debated, as well as a special report of a Commission on Domestic and Industry. The War Services work of the Church and matters arising out of the commissioning of ministers to serve as chaplains will also occupy the attention of the General Council.
