GREAT ISSUES WILL COME BEFORE PREMIERS CONFERENCE

LONDON, Sept. 23.—More and more the question of how the various dominion governments regard the foreign policy of the empire is dominating international affairs and it is this that has really been the cause of the exceedingly important committal note issued after the Baldwin and Poincare meeting for both the British and French premiers are jockeying time first in order to gauge adequately empire opinion and second expecting that resistance in the Ruhr Valley will not be the policy of Germany after the end of next week.

Premier Poincare seems to be playing the winning hand but Baldwin is noncommittal and will probably make no important statement on the question of British foreign policy until he has consulted with overseas premiers at the forthcoming Imperial Conference unless he speaks in the Commons after his first meeting with the dominion statesmen.

The great question that the empire has to face is as to how Britain and the overseas possessions can become interdependent in the economic field and in the matter of naval, military and air defenses so that the whole question of Germany's military and industrial possibilities are inextricably interwoven into the imperial conference as are also the possibilities of French competition and complexities of the Near East.

The whole future of the British empire seems to be at stake at the conferences.

LONDON, Sept. 23.—Chancellor Stressemann has summoned the premiers of the federated states of Germany for a conference on the Ruhr situation which was announced today to be held Tuesday.

This is looked upon in political circles as presaging early action on the issue of abandoning passive resistance.

THE COSGRAVE CABINET HAS BEEN APPROVED BY THE DAIL

Ernest Blythe is Sole Addition to Former Personnel

DUBLIN, Sept. 23.—President Cosgrave today placed the make-up of his new cabinet before the Dail Eireann and received the approval of that body to his selections.

Kevin O'Higgins remains as minister of home affairs, and Richard Mulcahy as minister of defence, with Prof. John MacNeill as minister of education, and Desmond Fitzgerald as minister of foreign affairs. An important change is the abandonment by President Cosgrave of the portfolio of finance which he had previously held. To this post he named Ernest Blythe, previously minister of local government.

The only other business was the debate on the fiscal policy of the Government, in which Tom Johnson, the Laborite, made strong references to the unemployment question. Mr. Johnson admitted, however, that the electors had shown clearly that they did not desire that the Labor party should take the responsibility of criticising the Government's actions.

President Cosgrave then announced that the Governor General would issue a statement of the Government's policy on October 2.

The House passed the first reading of a bill for the establishment of courts of justice in accordance with the new constitution.

Mr. Cosgrave explained that the bill had been drafted to meet the country's needs and that obviously there would be some objections to it owing to the fact that actions at law were going to be made somewhat heavier.

SAYS K. K. K. HELD INITIATION IN WHITE HOUSE

CHARLESTON, West Virginia, Sept. 23.—That the Ku Klux Klan held an initiation in the dining room of the White House was the statement of Rev. Basil E. Newton of Oklahoma, representing the Klan Imperial Council, to a large audience of Klansmen and others last night during a celebration by the Klan of the opening of the Charleston Huntington Road.

We have 227 klansmen in the House of representatives, 22 in the United States Senate and we held one initiation in the White House, "he said" and you know what that means."

Dr. Churchman, a leading Klansman who was present nudged a newspaperman at this juncture and whispered "he forgot to mention five members in the Harding Cabinet."

LONDON, Sept. 22.—Europe as viewed from outside No. 10 Downing Street is a sad spectacle indeed, and is going from bad to worse, in the eyes of David Lloyd George who, in a 300 page book entitled "Is It Peace?", reviews the whole ambit of the present European problems, the Ruhr predicament, and comments thereon in the vigorous style, replete with sonorous metaphor, which is characteristic of his writings.

The book is an amplification of the former Premier's recent articles with a preface in which the author says it has not been necessary for him to revise any of the estimates of the various situations he has made from time to time.

He is convinced that peace has gone back, perceptibly and unmistakably.

Up to 1923, says the ex-Premier, each after the end of the Great War showed a distinct improvement over its predecessor, but the present year has been one of growing gloom and menace; the international temper is distinctly worse all round.

Lloyd George says Europe's patched-up peace pacts will leave the continent in a more precarious plight than ever, but he is still hopeful that the settlements will be left to the diplomats and not to the "gunmen."

The Ruhr situation particularly receives the ex-Premier's attention.
