### Willis, Malone Plead Not Guilty

(C. P. by Guardian's Special Wire) DALHOUSIE, N. B., Nov. 13.—When the joint trial of Ernest A. Willis and Edward A. Malone began in the Resigouche County Court today before Judge J. L. Ryan the accused pleaded not guilty to each of 16 counts alleging fraud, fraudulent conversion and theft of stocks, shares and bonds at Campbellton during the first six months of this year.

Two motions for defence counsel were denied by the court. W. E. McMonagle, Moncton, representing Malone, moved to quash the indictment on the ground it was too broad and gave too little information regarding the charges. A. F. N. McLaughlin, Campbellton, acting for Willis in the absence of Ernest Dornon Dalhousie, moved to have the accused tried separately and contended either might be prejudiced by a joint trial. James Friel, K. C., Moncton, representing the Attorney-General, said it was in the discretion of the judge to grant the request and added the crown was only concerned in putting all the facts before the jury.

### Island Born Doctor Dies At Dartmouth

(C. P. by Guardian's Special Wire) DARTMOUTH, N. S., Nov. 13.—Dr. M. A. B. Smith, 75, one of Nova Scotia's oldest and best known physicians, was found dead in his bed today. He had practiced medicine in Nova Scotia for a half century. He was a graduate of University Medical College of New York.

During his long lifetime he had been a Governor of King's College, his alma mater, professor of clinical practice at Dalhousie Medical School and a vice-president of the Nova Scotia Historical Society.

He attended a meeting of the local branch of the society just a few hours before his death.

He was a native of Milton, P. E. I., son of Rev. John Smith, an Anglican clergyman.

His wife, who survives, was the former Katharine Prescott of Bale Verte, N. B.

### Lighthouse Keeper Marooned

(C. P. by Guardian's Special Wire) WINNIPEG, Nov. 13.—Unaware the vessel which was to have brought them to civilization never will reach them, a lighthouse keeper, and his assistant waited tonight to be taken off Cox's Reef in the northern end of Lake Winnipeg.

Guardian of the light that warns vessels of dangerous rocks, Donald Sayre and his unidentified friend were feared to be running short of provisions. They were to have been picked up from the Barn Rock 180 miles north of here two weeks ago.

The vessel which was to have brought them to civilization at the end of their summer's work, was surrounded by ice somewhere in the north end of the 100-mile wide lake, far from the reef where the two waited hopefully.

city of beautiful women"—was formally annexed to Italy today while advance Fascist flank guards skirmished with the enemy.

General Emilio de Bono, commander-in-chief of Italy's African armies, arrived to take formal possession of the city in the name of Premier Mussolini and King Victor Emmanuel.

Wild shouts and fierce gestures of welcome greeted him from the warriors of Ras Gugsu, traitorous son-in-law of Emperor Haile Selassie. They were the first of the Fascist forces to enter Makale. De Bono was accompanied by Count Galeazzo Ciano, son-in-law of Premier Mussolini.

Makale is known to Eritreans as the "city of beautiful women" because a colony of Greeks settled here many years ago and intermarried.

In preparation for De Bono's visit, Gugsu's men swept and cleaned the sumptuous palace built for Gugsu's grandfather, Emperor Johannes. It had been littered and looted by evacuating Ethiopians who fled before the Italian advance.

Gen. De Bono went immediately to the palace, and surrounded by officers and local priests, formally annexed the city.

### Ethiopians Withdrawing

**ROME, Nov. 13**—General Emilio De Bono's Italian army lengthened its front in northern Ethiopia today, while Ethiopian forces in the south were reported withdrawing toward Harar.

The Fascist forces moved into the Desssa region, about 50 miles east of the captured city of Makale, while on the western end of the line they reached the Takkase River.

The Italian front in Tigre Province thus appeared to extend about 100 miles from east to west. In the southeastward advance from Eritrea into Ethiopia, through Aduwa, the Italians had moved about 100 miles.

Ras Nasibu, Governor of the Province of Harar, in which the important points of Harar, Jijiga and Direwada are situated, was reported in press dispatches from

### IN MEMORIAM

**MR. LESLIE ADAMS**  
The death occurred in the Prince Edward Island Hospital Tuesday after a three weeks illness of Leslie Adams, aged 56, a resident of North Wiltshire and a son of the late George Adams of Springbrook, New London. He leaves to mourn one brother, Bruce, in French River, and one sister, Mrs. John Stewart, of Brookfield.

### MR. RICHARD S. FARQUHARSON

The death occurred in the Prince Edward Island Hospital Tuesday evening of Mr. Richard S. Farquharson, aged 73, son of the late Hon. Donald Farquharson, former Premier of Prince Edward Island and later a Liberal representative for Queens in the Federal Parliament.

Mr. Farquharson was a veteran of the Klondyke, having spent two years there at the time of the gold rush. He also resided for a time in Western Canada before returning to Prince Edward Island some years ago to take a position in the Registry Office, the duties of which he faithfully and capably discharged.

He leaves a widow and two daughters, Doris, Mrs. J. Hope-Johnston, Calgary, Alta.; Beatrice, Mrs. Grant Neff, Pasadena, Calif.; also two brothers, Mr. J. A. Farquharson in Charlottetown, Mr. Charles A. Farquharson in High River, Alta. and two sisters, Mrs. Fred Blake, High River, and Panny, Mrs. (Dr.) F. E. Smallwood, in Charlottetown.

He will be laid to rest in the People's Cemetery, the funeral taking place this afternoon from the residence of his brother, Mr. J. A. Farquharson, 169 Prince Street, the service starting at 2 o'clock.

Mogadiscio, Italian Somaliland, to be drawing back his forces from the southern front in apparent preparation for a strong stand. The reports said Ras Nasibu was expected to concentrate his troops at Harar, the capital of the province and the second largest city in Ethiopia—Addis Ababa, alone being larger—or at Jijiga, 51 miles east of Harar.

**ADDIS ABABA, Nov. 13**—(G. P. Havas)—Ethiopian riflemen captured 1,000 Somalis and six tanks, and killed 12 Italian non-commissioned officers in yesterday's encounter at Anela, an official version of the Ogaden front engagement claimed here tonight.

The tribesmen hurled themselves into the teeth of an Italian onslaught, discharging a hail of machine-gun bullets, and spread panic among the ranks of the Fascist native troops, according to a government dispatch from Harar.

The battle ended in surrender of the entire Somali battalion, it was reported.

### PAIR ORDERED DEPORTED

**HELD IN CONNECTION WITH JEWEL THEFT.**

**QUEBEC, Nov. 13**—Deportation to England was ordered by Canadian immigration officials here today for the man and woman held here at the request of British authorities under suspicion of complicity in the \$20,000 jewel theft from the London home of the Earl of Portarlington, Nov. 3 last.

It is possible the couple will be sent back to the Old Country in the Athena, the ship from which they were taken in custody when it docked here last weekend. The Athena sails Saturday or Sunday.

The deportation order was announced on conclusion of an official enquiry into the couple's right of entry into Canada. The chief immigration officers at Quebec stated the pair were considered undesirable, the man because of his admitted police record in England, and the woman because of her supposed close acquaintance with him.

Record of the enquiry at Quebec will be sent to Dominion immigration authorities at Ottawa.

below. The enraged crowd threw stones at the windows of the British Consulate, and burned a police truck and an automobile.

Before the rioting the Wafdists passed a resolution withdrawing their party's support from Premier Mohammed Tefik Nassim Pasha. Leaders of the party were reported to have demanded his resignation.

The greater number of rioters were students. The government issued a statement late today, warning that grave dangers might face a disunited Egypt, and asking the populace to be calm. The students were urged to return to their classrooms.

Egypt was a British protectorate from 1914 until 1922. The country then was declared a sovereign state but under the terms of the constitution the right of defence was reserved to Great Britain.
