PROSPECTS FOR TOURIST TRADE NEXT SEASON

Are Bright—Presiden-
tial Report of Mr.
Justice Arsenault at
Tuesday's Annual
Meeting.

In his presidential report at the an-
nual meeting of the Tourist Associa-
tion Tuesday night, Mr. Jus-
tice Arsenault remarked that during
the last year, a milepost in the history
of the Association, summer hotels
and other facilities which are
necessary for the proper accommoda-
tion of tourists, and which have
heretofore been lacking, have been
provided at many places in the Prov-
ince. The Cliff Hotel has been re-
opened, the new Highlands Hotel at
Georgetown opened, cottages and res-
taurants at Cavendish and North
Rustico provided for summer visitors.
Purified cottages in proximity to
golf courses and sea bathing are still
in demand. Little has been done in
Prince County to cater to the tourist
traffic, as yet.

"The Tourist business," Judge
Arsenault stated, "has reached the
point where it has become the high-
est revenue producing industry in all
Canada, and it is a business which
several nations have recognized of
such importance that large sums of
money are being spent in National
advertising.

"Such advertising is being done by
the countries of France, Germany,
Italy, Switzerland, and South Africa.
The Federal government of the
United States is now contemplating
like National advertising and the
time has arrived when Canada must
do likewise or lag behind in the
race to attract, not only tourists, but
investors, in our great natural resour-
ces.

"Last year was formed at Montreal,
the Canadian Association of Tourist
and Publicity Bureaux. This Associa-
tion has as its members, representa-
tives from the Tourist, and Publicity
Bureau of all Canada, representa-
tives from our great transportation
companies and from other bodies in-
terested in the tourist trade.

Meeting at Winnipeg
The first annual meeting of this
new association was recently held in
Winnipeg, at which were present
delegates from the Provinces of Can-
ada. This convention held four ses-
sions, at which were discussed many
matters of importance, pertinent to
the tourist trade. The co-operation of
these different bodies with one an-
other is bound to have a very bene-
ficial effect. This association heads
the movement to induce the Federal
Government to enter upon a cam-
paign of National advertising at home
and abroad for the purpose of

(1) Inducing our own Canadian
people to become better acquainted
with the different parts of Canada
and to visit Canada first.

(2) To make known, at home and
abroad the beauties of Canada, its
agricultural and fishing industries, its
mines, its forest and water power,
with a view to their development.

(3) To feature Canada abroad as a
summer resort as a place in which
to settle permanently or to build a
summer home.

"The transportation companies of
Canada and the tourist organizations
are now spending about \$3,000,000
in advertising and publicity work,

which has resulted in a revenue to Canada
of about \$300,000,000 in the past year,
and it is confidently expected that a
yearly additional expenditure of
\$1,000,000 by the Dominion govern-
ment would largely increase that
amount.

"The Secretary, in her admirable
report, which I commend to your at-
tention, will give you fuller particu-
lars as to our local activities. We feel
assured that every dollar invested in
featuring our work is money well in-
vested, and which brings one hundred
per cent. return.

"In conclusion I have again to ex-
tend the thanks of this Association
to the Provincial Government and
to the City of Charlottetown for their
grants, to the citizens of Charlot-
tletown and Summerside for their
financial support, without which we
could not operate. Again we express
our appreciation of the support given
to our work by the press of this Pro-
vince.

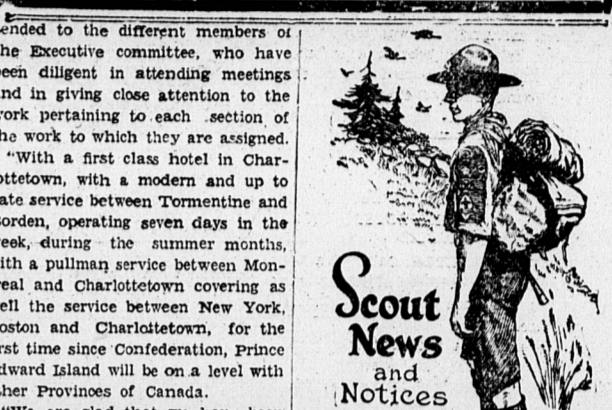

MONTREAL, Can., Jan. 7.—Ample
offerings of fresh eggs featured to-
day's dairy market here, with prices
slightly easier in spite of contin-
ued cold weather and snow. Quota-
tions—Top grades of Ontario fresh
eggs were a net 37 cents at 37 cents
for extras, 31 for firsts and 30 cents
a dozen for pullets, British Colum-
bia eggs were unchanged. The cold
weather and heavy snowfall is ex-
pected to keep up to a certain extent
the sources of supply during the
next few days, with a consequent rise
in prices. The butter, cheese and
cream markets were generally
firm. Butter was steady at 31-12
cents for pure Quebec cheese. Re-
ceipts were light with a good de-
mand for colored, making prices a
cent higher at 12 to 12 1-4, with
white a cent cheaper. Maritime
sources of potato supplies reported
little movement but prices were un-
changed locally.

OTTAWA, Ont. Jan. 7.—Canadian
egg markets continue weak and fur-
ther price reductions have been re-
ported today from a number of
Canadian markets. Toronto—1.0
egg market here is still declining.
Producers are making sales of Ontar-
io graded fresh eggs at extras 36 to
37, firsts 20 to 31, pullet extras 27
to 28, seconds 23 delivered in free
cases. British Columbia eggs on
spot are selling at extras 37 to 38,
firsts 30 to 31, pullet extras 27 to
28. Winnipeg—Paying prices to
country shippers for eggs dropped
slightly to extras 30, firsts 28,
seconds 22. Edmonton—There was a
drop in egg prices here yes-
terday. Dealers are now quoting

producers extras 20, firsts 18, sec-
onds 16. Two cars of fresh eggs
are being shipped east from here to-
day. St. John—Egg receipts here
continue to increase as the mild
weather continues. Dealers now are
paying country shippers for ungrad-
ed extras 34 to 36, firsts 30 to
31, seconds 23 to 24. The entire mar-
ket is very irregular, but retail prices
are gradually coming into line,
with wholesale levels, and an im-
provement in the situation is look-
ed for. Halifax—Receipts of local
fresh eggs on this market are still
heavy. Quotations to country ship-
pers are unchanged, but wholesale
prices to retailers are 4 to 5 cents
lower at extras 48 to 50, firsts
44 to 46, pullet extras 35 to 37, sec-
onds 33 to 35. Chicago—Spot 24 1-2
April storage packed 20 3-4.
