ANNUAL MEETING BOARD OF TRADE

(Continued from page three.) The institution was in a healthy state, financially and numerically. On motion of E. T. Higgs, Vice-President of the Maritime Board of Trade, seconded by James Paton, the report was adopted. The election of officers resulted as follows: President—R. H. Jenkins; Vice-Pres.—Hon. W. S. Stewart; Secretary—E. B. Miller, re-elected. Council—A. Pickard, Edwin Aitken, J. O. Hyndman, W. E. Bentley, H. V. Buntain, J. P. Gordon, James Paton, E. T. Higgs. On motion, Nelson Rattenbury was unanimously elected a life member of the Council, he being the third thus honored. W. H. Aitken and Horace Hassard having been elected last year. The former Board of Arbitrators was re-elected. Mr. Tidmarsh, the Chairman having given a very interesting verbal report of the year's work. The following new members were elected—C. H. Black; J. A. Webster; Prof. Ross; Thomas F. White; W. S.

Grant; J. J. Hornby; Ernest Seller; J. K. Ross; Gordon; Huggins; John Stanley; Joseph Barr; J. E. B. McCready; F. J. Holman. A letter from the Board of Underwriters was read stating that owing to the increase in City Taxes of fifty per cent, the companies have had to advance their rates five per cent, and unless the City will guarantee to procure a chemical engine there will be a further increase of five per cent on insurance within the city limits. The letter was discussed and was handed to the new Council for consideration. Excellent addresses on general questions affecting the province and city were given by Publicity Agent McCready, Hon. W. S. Stewart, James Paton, W. F. Tidmarsh, E. T. Higgs and the newly elected President, R. H. Jenkins. On motion of E. T. Higgs a vote of thanks to the press was passed for reports published of the Board's meetings and for general assistance in its work. This vote was happily responded to by R. McDonald of the Patriot and R. L. Cotton of the Examiner. A feature of the Board's work from present indications will be to pro-

vide for the tourist traffic of the coming summer. In this connection Mr. Tidmarsh gave some very valuable suggestions which it is quite probable the Board will act upon in the near future. SHELDON CREDITORS MUST WAIT TORONTO, Jan. 7.—Judging from present indications it will be a year at least if not longer before creditors of the estate of Charles D. Sheldon, the ex-widow, of St. James street, receive any dividends on the money they put into the "blind pool" which paid for a while, profits of forty and fifty per cent. According to Mr. Burnet, one of the curators of the estate, the payment of dividends depends on the progress made in the hearing of the Matthews case before the Supreme Court of Canada, in Ottawa. This test case involves the question as to whether \$13,000 taken out of the blind pool by a Mrs. Matthews a day before the ex-financier's getaway, is at present in the hands of the lawyers for the estate, Messrs. Chauvin, Baker and Wilson. They have not yet filed their brief for

hearing before the Supreme Court, but it was said this morning that it would be placed on the roll for hearing as soon as possible. However, the Supreme Court decides the question of the \$13,000 will matter but little to the smaller creditors, for even with the \$13,000 added to the money already held the highest dividend which can be paid will be two to two and one-quarter cents on the dollar.

JAMES C. TUPLIN'S RANCH

(Continued from page three.) made in 1910, when twenty-four skins brought an average price of \$1,385.00 per pelt, with one at \$540 (sterling) - world's record, another at \$530 (sterling). The market was tested by James Tuplin in 1911 with a skin which brought £480 sterling, and in 1912 Mr. Dalton tested the market with one skin which brought £410 sterling. The foxes now offered for sale are direct descendants of those whose pelts are now worn by the ladies of the Courts of St. Petersburg and London, and Berlin, and the leaders of the fashions of Paris. Lamson's present report on the fur market states that the demand for black fox pelts is greater than ever. Say in three or four years the business is brought to a halt basis, it would be necessary in order to get a good return on the investment to keep over one year's litter, in order to have more breeders. By holding the young for one year, the ranch would have say thirty pairs of foxes, producing, at a conservative estimate, ninety pelts a year, which at \$1,000 each would amount to \$90,000. Expense of running the ranch would not exceed \$5,000 a year. The result, \$85,000 available for dividends. While any proposition claiming such large returns as this does, must certainly be classed as a speculative venture, we honestly believe that the chances for the realization of all we claim are as good as anything we have ever seen, and all the estimates we have given have already been exceeded by actual results.
