

Abegweits And Crystals Draw Old Rivals Battle To 2 All Tie In Fast Game At Summerside.

The much talked of game between the Crystals and Abegweits resulted in a two all tie after sixty minutes of fast hockey here last night. The first period opened fast, but as play centered in the middle area, the goalies had an easy time. Hickey Nicholson gave Eady several anxious moments, but Harold was equal on all occasions. At seven minutes, Walter Lawlor scored on a pretty solo run neatly fooling the defence by faking a pass to Squarebriggs. Jackie Kane made several nice rushes but was never in a position to net the puck. Abegweits easily had the edge of play in this period.

The second period opened with Crystals carrying the play to the Abegweits during the first ten minutes. This period was somewhat faster than the first. Squarebriggs showed the red light at fourteen minutes when he slammed Lawlor's rebound past Eady to make the score read 2-0.

The Crystals came out for some goals in the third period and forced the play for the balance of the game. Jimmy White, Chick Gallant and Montgomery showed up real well in this session. Monty drew sighs from the fans when he missed an open net after outskating the whole Abegweits team, but the fans got a chance to cheer when Reg Saunders skated the length of the ice, faked a pass to C. Gallant and scored from close in on Stull, who had no chance to save. At one time

the Abegweits had but three men on the ice, the rest serving penalties for holding and tripping, but due to Stull's fine goal tending, Crystals could not score. Chick Gallant scored the tying goal at fourteen minutes to finish the scoring for the evening. The Summerside fans, who expected to see the Abegweits defence do some body checking were disappointed, as Gross and Oliver confined themselves to a steady poking-checking game, mostly crowding the puck carrier to the corners.

and it was the duty of this Government to have attended to the matter.

"Good plain suitable, buildings with no frills" were wanted to replace the buildings destroyed by fire. Mr. LePage complained at some length of extravagance and incompetency in tearing down the brick-work at Prince of Wales College. To this criticism Hon. Dr. MacMillan replied sarcastically, "You know a lot about it?"

A further statement by Mr. LePage that doctors could now get "as many scraps as they wanted, and more" was challenged by Hon. Dr. MacMillan.

Mr. LePage: "Well, I got that information."

Hon. Dr. MacMillan: "It is not correct."

Mr. D. F. BETHUNE

After extending complimentary remarks to the Speaker and expressing his regret at the passing of the late Minister of Public Works, Mr. David F. Bethune, Conservative candidate for the Second District of Queens, said the House had heard some remarkable statements from the Liberal member from his district; but they would not be surprised at this if they had followed this election campaign. Mr. LePage had complained of the Conservative roadmaking activities at North Rustico Beach. The people of that vicinity were not of Mr. LePage's opinion; they did not think the project a failure; they had asked for it and they had received it. Mr. LePage had been in the Government during the last four years, and what had he got for the people of that section? Mr. LePage's statement that only three Liberals were employed on that project was incorrect.

Mr. LePage, on a point of order, complained that no member should be allowed to say that another member's statement was incorrect. The Speaker suggested a retraction.

Hon. Mr. Stewart remarked that the expression is made repeatedly in the House of Parliament.

Mr. Bethune said he was quite willing to apologize if the language was unparliamentary but asked how Mr. LePage knew of the political affiliation of all the men working on the project. As a matter of fact the work was not apportioned politically. Had the same methods been employed by the Liberal member when in office it would have been better for the district.

Refutes Statements

The same thing applied to Mr. LePage's criticism of the road graveling at Nine Mile Creek. Both Liberals and Conservatives were employed and the cost to the Government per mile was \$120 a ton landed at the projects. Other statements of Mr. LePage in this connection were answered.

Mr. LePage's own actions when in office were then reviewed by Mr. Bethune, who made scathing criticism of the political partisanship shown by the Liberal member. So much was this the case that complaints had to be made to the Minister of Public Works, who, to his credit, remedied the situation and saw that Conservatives were employed. Mr. Bethune cited specific instances of this which occurred at Oyster Bed Beach. He also disposed of Mr. LePage's further criticisms of road work under the Conservative Liberal administration, instancing particularly the neglect of the North River Bridge road, which had now been put in satisfactory condition by the Conservatives.

Instances of Government officials interfering in the election campaign in the interests of the Liberal candidates in the Second District of Queens were also given.

Mr. Bethune then read an extraordinary letter (published elsewhere in today's Guardian) sent by the Liberal candidates to an elector at Nine Mile Creek on the eve of the campaign.

Other irregularities in the election campaign in his district were cited by the speaker. Mr. LePage denied Mr. Bethune's statement that the New Haven poll had not closed at five o'clock on election day.

Mr. LePage had complained of the local gravel not being 100 per cent pure gravel. Mr. Bethune had been informed that local gravel was the best road surfacing material for local soil and this seemed a reasonable supposition.

At 10.45 p. m. Mr. Bethune moved the adjournment of the debate, the House adjourning until 10 a. m. to-morrow (Thursday).

Annual Meeting Diocesan Board Women's Auxiliary

The Prince Edward Island Diocesan Board of the Women's Auxiliary met for its 35th annual session yesterday. The divine service was held in St. Paul's Church at 10.15 a. m. The Rector, the Rev. H. D. Raymond was assisted by the following clergy, Archdeacon White, R. H. Coleman and Rev. G. West. The Rector extended a welcome to the visiting delegates and to the clergy present. He said it was a pleasure to have with us the Rev. G. A. Andrew, a missionary home on furlough from China, and who was the special preacher, for the service. Several missionary hymns were sung and a special litany used.

In opening his address the Rev. G. A. Andrew said it was a pleasure to be visiting the churches at home and meeting the partners in God's work. One realizes the partnership more at a service of the Women's Auxiliary. He paid great tribute to the work of this organization and said those working in the foreign field could not carry on without the help of those at home. Not only from a financial standpoint. They need our prayers continually. If we knew how to really pray we get very near to God. The speaker said many were asking him about conditions in China, and he would say a little about them first. He described very graphically the situation between China and Japan at the present time and made it easy for everyone to understand how the trouble has arisen. He said Japan is trying to justify itself by saying it is doing what Britain did in 1927, but there is no similarity whatever. We should be proud of Britain in the honorable way in which she deals with other nations. All Japanese are not in favour of what their country is doing.

The speaker said what is to bring peace to the world. Can the League of Nations do it. Would a tiger petted from birth always remain docile. If irritated would not the tiger nature reveal itself. There is a tiger in every one of us and in every nation, and there is only one thing can tame that tiger. We must be born again—receive the spirit of a new man in our hearts through Jesus Christ. That is what the missions are trying to do. Give people that which will make new creatures of them. The speaker said if there was ever a time when we should be enthusiastic for this work it is the present time. The province of Honan in China has practically no religions of its own now, and is open to receive the Gospel. The harvest is ripe but the labourers few. Results are to be seen from the missionary work already done there and there are several native pastors carrying on the work. We must not disappoint Christ who has done all for us. He handed over the work for us to carry on. It is a privilege to be co-workers with Christ to bring in the harvest.

The service closed with Benediction pronounced by Ven. Archdeacon White.

The afternoon meeting opened in St. Paul's Hall at 2 o'clock with Mrs. Raymond Diocesan President in the chair. The roll called showed most of the branches well represented. Messages of greeting from the Dominion President and several of the Diocesan Boards were read by Miss Cotton. Mrs. Bearsto extended a hearty welcome to the visiting delegates and speaking of the W. A. work said we must not let it end in just Dorcas work. Prayer has its place. If we are sincere and wish to advance we must realize our dependence to the Divine Source for help.

Mrs. Champion of Alberton replied to the welcome in a few well chosen words.

The President in her address also welcomed the delegates. She spoke of the work carried on during the past year. Social service work has been added to W. A. activities and it has made us richer in many ways. East and West have been drawn closer together during the depressing times in Western Canada.

The visit of the Dominion Executive last Autumn was beneficial both to the visitors and to those who were privileged to attend the meetings held here.

Some ask why should we support missions. A religion not worth propagating is not worth much, Jesus alone can save for he destroyed death. Everyone has a right to the intimate knowledge of Christ.

At all meetings we should find time to approach the throne of grace in prayer. Every member should be a reader of the "Serving Message" Let us give it an honoured place in our homes.
