REV. W. A. WHITE GIVES STIRRING ADDRESS AT CHURCH MEETING

WOLFVILLE, N.S., Aug. 29.-Members of the Baptist clergy from all parts of the Maritime Provinces at the annual meeting of the United Baptist Institute today heard addresses given by Rev. W. A. White, of Halifax, and Rev. A. E. Herman, of Moncton, on the attitude of the church on "race readjustment" and "the church and the lodge." Economic causes and the "haughty air of superiority" were named by Rev. Capt. White as the cause of racial disension and war. "I do not believe," he said, "that we hate a man because he happens to be black, brown or yellow." "The purpose of the lodge," said Rev. Mr. Herman, in admitting the issue between church and lodge "is fraternity and laudable work of a temporal nature. The church also purposes to be friendly, but the other and supreme purpose of the church is spiritual compared with the program of the church, the lodge looks like a tug alongside a modern leviathan."

Tagging Mackerel

OTTAWA, Aug. 30.-The story of the mackerel recently captured off the Atlantic Coast with a rubber band encircling its body, has been received either as a joke on the mackerel or on the public, and the mystery becomes the more pronounced by the further report that for a number of years past an occasional mackerel has been captured gartered with a rubber band.

Some of the theories advanced have been ingeniously humorous. The true explanation may be found in connection with the experiments by the "North American Commission on Fisheries Investigations" which have been carried on in Canadian and American waters to ascertain, if possible, the movements or migrations of mackerel.

Beginning about 1925, it was arranged that a number of these fish be secured from the mackerel traps along the coast, and a numbered metal tag, attached to a celluloid band, fastened to the tail of each fish and the fish liberated. In addition to the number each tag bore the name "Canada" or "U. S." to more clearly identify the location of the waters and country of origin where the fish were captured and liberated. Publicity was given to experiments, the fishermen being advised in the recapture of such tagged fish to forward the tag with date and place of capture to the proper officials in charge.

In June, 1925, over 600 mackerel were secured from a trap-net at Cranberry Head, Yarmouth County, N. S., and duly tagged and liberated. The experiment was continued each succeeding year at Cranberry Head and other points along the Nova Scotia coast, and also the Magdalen Islands. Similar experiments were conducted by the United States Commission. A number of the tagged fish were recaptured at different points along the Canadian Coast and also United States waters. For instance last year mackerel bearing the "Canada" tag were captured off Block Island, Rhode Island, and other Massachusetts waters.

It is quite probable that the rubber bands were placed on a number of mackerel by persons doing the tagging at one of the tagging points.
