

TWO KILLED AND MANY INJURED

By Explosion in Grain Elevator. Loss \$2500.00. Insured.

(Canadian Press) BUFFALO, June 24.—Two men are known to be dead, fifty are injured, some fatally, and four are unaccounted for as the result of an explosion last night in an elevator grain storehouse of the Husted Milling Co. Fire followed the explosion and destroyed the wooden section of the elevator. The dead are: Michael King, 41 years old. Henry Vetter, 45 years old. An unidentified boy, 12 years old, was run down by an automobile. Fifty were taken to various hospitals, some in a serious condition from burns, broken legs and arms. At the scene of the accident, a priest administered the last rites to twenty-five men, believed at the time to be mortally hurt. Many of the injured cannot survive their wounds. The ultimate death list may reach fifteen, an estimate reached by a canvass added among the scattered hospitals where the injured were taken. The explosion, caused by puffing dust accumulations in a feed house, was of frightful force, tearing out the north wall of the wooden structure and breaking windows for a quarter of a mile around. John Conroy, engineer and switch engineman of the New York, Chicago and St. Louis Railway, was blown from a cab and sustained internal injuries from which he cannot recover. Several windows in the cars of the train were broken but none of the passengers injured. Every ambulance in the city was in commission. The twelve-year-old unidentified boy was running to the fire when struck by an automobile and instantly killed. The body of Henry Vetter was blown fifty feet by the explosion and was found under a box car badly burned and mangled. The Elevator Co. employed 100 men. According to the Vice-President Husted they have all been accounted for except four employees who escaped. It is equally positive that many of their fellow-workmen were cut off by the flames and perished. Ten men were rescued from the roof of an adjoining feed house. They leaped from the elevator, several receiving broken legs. A dozen box cars, loaded with grain, were destroyed. The elevator had a capacity of 500,000 bushels. Half was of wooden construction and was totally destroyed. A modern concrete elevator adjoining withstood the flames but was badly damaged. Officials of the Company estimate their loss at \$250,000, covered by insurance.

The cheque was enclosed in a letter from His Honor to Mr. W. A. Stewart, President of the Y. M. C. A. Needless to say, His Honor's donation is gratefully acknowledged. It will no doubt be of interest to His Honor's many friends in the city, and throughout the Province, to learn that in his letter he says that he has been having a continual good time on his trip, with, however, a little break in the weather during the last week. His Honor has heard out on the Pacific Coast, where he is, the report that there is going to be a Federal shipbuilding yard in Charlottetown, and he trusts that it will materialize. His Honor said he would be leaving for home towards the end of this week, and would probably be as long on the return trip as he was going out to the Pacific.

TICHBORNE CASE IS RECALLED

(Canadian Press.) LONDON, June 24.—A sensational charge was made this afternoon at Bow St. Police Court against a daughter of Arthur Orton, the notorious claimant of the estates of the Tichborne family about whose identity the world was divided into hostile camps for years. The woman was accused of threatening to murder Miss Denise Greville, who is to marry Sir Joseph Doughty Tichborne, the young baronet, at Brompton Oratory tomorrow. The threat was contained in a letter to Earl Cranard who married in 1909, Beatrice Mills, daughter of Ogden Mills, New York. Sir George Lewis, speaking for the prosecution, said he could produce evidence that the accused intended to carry out her threat of murder during the wedding ceremony. The accused, who called herself Theresa Doughty Tichborne, protested that she meant no harm to the bride and only wanted to bring her case before the public. The letter to Earl Cranard referred to the approaching "marriage of my cousin—Joseph Tichborne." It said, "I have asked you to use your influence to make them give me some of the money they have stolen from us. You do nothing. It is nothing to you that I starve as long as you and your wife can give parties and flaunt about with people who, if they knew the truth, would be ashamed of you. You cannot hide any longer for I tell you I am making you accessory before the fact in telling you I am going to shoot that girl rather than Joseph shall marry her and they shall live on my money. As there is a God in Heaven I am going to do it." Another letter advised Col. Stratton Bates to keep the ladies of his family away from the Oratory for it said, "They will be safer." The woman was remanded. Arthur Orton claimed to be Roger Tichborne and demanded the estates of the twelfth Baronet. He came from Australia and the family, believing young Roger Tichborne was lost at sea, refused to acknowledge him. The famous trial ensued, Orton was non-suited and sent to jail for fourteen years. He died after serving his term, but admitted his perjury and said he was originally a butcher in the east end of London.

KING ENTERTAINS FRENCH PRESIDENT

(Canadian Press) LONDON, June 24.—President Raymond Poincare, of the French Republic, was entertained by King George at a state banquet to-night at Buckingham palace. At the state banquet the famous Windsor Castle service gold plate was used with floral decorations blended to show the tricolor of France. The women of the Guard in quaint costumes were posted around the chamber. The President of France sat between King George and Queen Mary at a central table at which were seated other members of the royal family and ambassadors. Other guests numbering about a hundred occupied thirteen tables. The King in proposing the President's health referred to the cordial relations between France and England as the great factor in the preservation of European peace. The President replied in the same strain. PARIS, June 23.—President Raymond Poincare left the French capital to-day on his way to London, where he is to pay his first official visit since his election. He is to pass four days in London where elaborate arrangements have been made for his reception by King George, the government and the municipality.

SUPREME COURT AT CHARLOTTETOWN

Grand Jury Reports Favorably on Public Institutions--No Criminal Cases.

Trinity Term of the Supreme Court was opened in Charlottetown at 11 a.m. yesterday. His Lordship Chief Justice W. W. Sullivan presided and was presented with a pair of white gloves, there being no criminal cases for trial. His Lordship delivered his charge to the Grand Jury, who are as follows: Alexander Horne, Foreman, (of Charlottetown), A. G. Hynes, (Vernon River), James Marks (Long River), George E. Hughes, (Charlottetown), William Moffatt, (Mayfield), Robert Reid (Crapaud), Peter Newsum, (Charlottetown), John Gill, (York), Robert Longworth (East Royalty), Patrick Morris (Donaldson), Norman J. McDonald (Grand Tracadie), John Fraser (Avondale), Daniel J. Riley (Charlottetown), Peter W. McLeod (Mount Stewart), Thomas S. Hughes (Emerald), John McKay (South Rustico), F. T. Morrow (Lot 48), John Johnston (Long River), James Hughes (Milcove), and Alexander McLeod (Point St. Charles). T. P. Duffy, of Emerald, and Patrick Reid of Hope River, who had also been sub-poenaed for the Grand Jury, were absent when the jury assembled. After His Lordship's charge the Grand Jury retired, and in the afternoon, about half past three o'clock, returned with the following report: "The Grand Jury beg to submit the following report: They visited Falconwood Hospital for the Insane, the Infirmary and the Sanatorium. These institutions were found to be clean, and are apparently conducted in a most satisfactory manner. The food was carefully inspected and found to be well cooked, and of good quality. The sanitary arrangements appear to be good. They also visited Queen's County Gaol and found it clean, and well-kept. Only three prisoners are in the institution at the present time. The jury are of the unanimous opinion that in future the Grand Jurors should receive the sum of \$2 a day and mileage." RECAPTURE AN ESCAPED PRISONER

ST. JOHN, June 24. (Special.)—Joseph Wedge, aged 28 years, wanted on the charge of entering and stealing from a store in Campbellton last year, and who made the bold escape from Chief Hughes a few months ago by jumping across fifteen feet of water from the deck of the Calvin Austin to the dock, has been recaptured. Chief Hughes had captured the man in Boston, it will be remembered, and was bringing him to the city. As the boat was docking, the chief became interested in the work of the crew and his attention was attracted from the prisoner. Detective Killen and Deputy Jenkins were waiting at the head of the landing to receive him. The man seeing his opportunity leaped from the deck dashed down Water Street and was free. The local police do not know the particulars of the robbery in Campbellton, but it is said that Wedge is charged with being implicated with several others in entering and ransacking a leading store there. HONOR MEMORY OF H. WARD BEECHER

NEW YORK, June 24.—The universal regard in which the memory of Henry Ward Beecher is held was given expression throughout this section of the country today by exercises commemorating the one hundredth anniversary of the famous preacher's birth. In Connecticut, the ancestral home of the Beecher family, and in Brooklyn, where Mr. Beecher spent so many of the most important years of his life, the principal public observances were held, but there was scarcely a Congregational Church or society in this section which did not devote some time to the memory of the man whose sermons and writings touched the common heart of humanity. ALIENISTS AND NEUROLOGIST CHICAGO, Ill., June 24.—A congress of alienists and neurologists, the first large gathering of its kind held in the United States, assembled in Chicago today for a three days' session. The delegates to the congress include prominent physicians and surgeons appointed by the governors of nearly all the States.

GERMAN BUSINESS MEN SAIL FOR CANADA

BREMEN, June 24.—A part of representative German business men departed today for England, whence they are looked to sail from Liverpool later in the week for Canada. A summer tour of Canada from coast to coast is planned with the object of promoting closer trade relations between Germany and the Dominion. After visiting Quebec and Montreal the tourists will proceed to Ottawa, Toronto and Winnipeg, and then on to the coast. On the return journey Halifax, Fredericton, St. John and other cities of the eastern provinces will be visited.

OFFICIALS OF I. C. R. INJURED

TRURO, June 23.—Whilst travelling on an electric railway trolley between Wentworth Station and Holly two men in the employ of the I.C.R. telegraph department came near losing their lives by a collision with a special freight. The men claim they were informed that the line was clear to their destination, and were proceeding at a lively clip when the special hove in sight, too late to prevent the collision. Both men were injured—one named J. C. Rolfe being severely cut about the head, and the other named Carson badly bruised and injured internally.

COMING TO LOOK OVER SITUATION

J. G. Brew, of the milling firm of James Clow & Co., Portadown, Ireland, arrived in the City on Saturday, says a Halifax exchange. Mr. Brew is engaged in the milling industry in Ireland, and his visit here is for the purpose of looking into the opening for a large rolled oats mill in the Maritime Provinces. As there is no such mill in Eastern Canada at present Mr. Brew has expressed his opinion that there is an excellent opportunity for the establishment of a large plant. To-morrow Mr. Brew will leave for Prince Edward Island, and will examine sites at Charlottetown and Summerside, and later at St. John. Owing to the large quantity of oats produced in the Island, and their superior quality, Mr. Brew believes that there is no better place in Canada for the development of the rolled oats and oatmeal industry, and if a mill should be erected there by Mr. Brew and his associates it will have an initial output of about 500 barrels a day, for a part of which a market has already been found in Great Britain.

BECOMES BISHOP OF KINGSTON

KINGSTON, Ont., June 24.—With all the solemnity and ceremonial attached to the sacred office, Dean E. J. Bidwell was consecrated as Bishop of the Anglican diocese of Kingston in St. George's Cathedral this morning, in the presence of a large congregation of clergy and laity. The service throughout was a most impressive one. Archbishop Hamilton of Ottawa officiated at the ceremony, assisted by the Bishops of Ontario and Huron.

ALBION MINE FIRE CHECKED

STELLARTON, June 23.—Very substantial progress was made to-day in fighting the fire at the Albion Colliery. The company have now three streams of water discharging in the fire district, and the workmen have made good progress getting into the seat of the fire, which may now be considered well under control.

DOUBLE TRACKING THE INTERCOLONIAL

OTTAWA, June 23.—Important plans for the improvement of the Intercolonial railway are under consideration following the visit of Hon. Frank Cochrane to the maritime provinces. These plans involve the double tracking of the line from Moncton to Halifax. Mr. Cochrane and F. P. Cutler, the new general manager of the I. C. R., have been making as thorough a study of the condition of the road as the time at their disposal would permit and it is understood that the decision to have a double line of railway from Moncton to the new terminals at Halifax, has been reached. Before this work is begun the road will be improved in respect to grades so that when the present plans have been carried out, the Intercolonial will be in a first rate position to take care of the increased traffic which the officials of the road expect. Hon. Mr. Cochrane will return to the east this week.

TERRIBLE ACCIDENT AT MAHONE BAY

HALIFAX, June 24.—A terrible accident occurred at Mahone Bay last evening. Just as the special train with St. Mary's excursion was leaving for Halifax, Miss Agnes Shard, age twenty years, of this city in attempting to board the train, which was in motion, missing her footing fell from the steps to the rails, the wheels of the car passing over her right foot, severing it at the ankle. She had a miraculous escape from being killed. The presence of mind of two women who were standing on the platform saved the young girl from being crushed to death. Mrs. T. C. Hamm, and Mrs. E. A. Will setized the skirt of the young woman as she fell under the car and pulled her from underneath, but not in time to save her foot from being severed. Their prompt action saved the young woman from being killed.

POLICE CHIEFS IN SESSION

GALVESTON, Texas, June 24.—Galveston is well policed today. Hundreds of city marshals and police chiefs are here for the annual convention of their State organization. "How to control the wealthy and influential law breaker" was the leading topic of discussion at today's session. The convention will adjourn Thursday night.

PLAN TO BENEFIT HEALTH OF POPE

ROME, June 23.—Owing to the precarious health of the Pontiff after his recent illness, it is understood negotiations are now going on between the Holy See and Prince Torlonia for the purchase of a pine wood owned by the Prince, which lies close to the Vatican gardens. This wood can be reached either by means of an underground passage or an archway, and would enable the Pope to enjoy a very much larger area for his walks. This section allows a magnificent view of the Roman campaigns towards the Mediterranean.

SEEKS REMOVAL OF ADMINISTRATOR

The following from a New York exchange will be interesting in Charlottetown as Miss Stallo referred to made many friends here during the summer she spent at the Dalvey-on-the-sea. "Miss Laura McDonald Stallo, a grand-daughter of the late Alexander McDonald, of Cincinnati, Ohio, Wednesday began an action in the Surrogate's Court for the removal of the Metropolitan Trust Company of this city, as administrator of the estate of Mr. McDonald. Miss Stallo is supported in this move by her father, Edmund K. Stallo. The petition is based upon an alleged disagreement between the heirs of the McDonald estate and the trust regarding the disposition of certain funds obtained by the sale of stocks held by the company as collateral for loans. The trust company, it is said, is a creditor of the estate and for that reason Miss Stallo says that an administrator with no interest adverse to her should be appointed in place of the trust company. At the time of Mr. McDonald's death, on March 18, 1910, stocks and bonds, consisting of the larger part of his estate, was pledged with the trust company as security for a loan of \$2,700,000. It is said that the trust company without the consent of the heirs sold these securities. It is said that the company agreed to a renewal of the note and that the sale of the securities therefore was unnecessary. Some of the securities, it is said, were sold at less than their value, among them being 2,000 shares of Standard Oil stock, which it is alleged, were disposed of at less than \$629 a share. Before the expiration of the renewal period for the note, it is said, these shares were worth \$1,180 each. It is said that \$3,688,000 worth of the securities, par value of the New Orleans, Mobile and Chicago Railway Company were sold below their market value. She alleges that by the sale of these various stocks the estate has been damaged to the extent of \$2,575,000. Miss Stallo also lays claim, in behalf of the estate, to \$240,000 worth of bonds of a railway company now in possession of the trust company. The Metropolitan Trust Company also began an action in the Supreme Court for an accounting from Mr. Stallo and other heirs of the McDonald estate of the partnership which is said to have existed between Mr. McDonald and Mr. Stallo. The dispute about the securities pledged as collateral also figures in this action."

Among the candidates who passed the general competitive examination for clerkship in subdivision B of the Third Division of the Civil Service (Inside Service) was a P. E. Islander, James Curran, of New Perth, West, who came thirty-third in order of merit out of forty-nine candidates who were successful. Five other Islanders were successful in another examination—a preliminary exam. for the Outside Division of the Civil Service. They are all of Charlottetown and their names are: Charles Bore and Daniel Gillis, William Purcell, A. V. Saunders and Joseph F. Stewart. In the qualifying examination for the outside division of the service two more candidates from the city were successful—Martin Kenny and A. V. Saunders.

CYCLONE HITS ESTAVAN, SASK.

ESTAVAN, Sask., June 24.—Many buildings were wrecked and several people injured by a cyclone which struck town last night. People watching the ball game hurriedly fled just before the bleachers were totally wrecked and lay on the ground in a mauling rain, to avoid being carried away. The lighting plant was put out of business, telephone wires damaged and barns in the country were wrecked. Total loss reaches over \$25,000.
