Send me your wool to be spun into Yarn and wove into Blankets. The charges are: single yarn 25 cents, doubled 25 cents per pound. Blankets \$2.00 and if unlandred \$1.85; it takes five lbs. of wool per Blanket. Wool must be well washed and all dirt and burrs picked out. The size of single yarn is medium, and lousled yarn fine, medium, coarse and hooking yarn. Put shipper's name on all parcels and owner's name, address and instructions inside. Send by mail or freight. Special price for washed wool with dirt and burrs picked out. Freight will be paid on 100 lb. lots.
