### Principle Of Enabling Basic Producers To Manage Own Industry Remains Unchanged.

(C. F. By Guardian's Special Wire) OTTAWA, May 11.—A number of changes are made to the Marketing Bill by amendments tabled in the House today by Hon. Robert Weir, Minister of Agriculture. One change in regard to the commodities which shall come under the bill is the marketing of which could be regulated. The amendments define that "natural products" include: "Animals, meats, eggs, wool, dairy products, grains, seeds, fruits and fruit products, vegetables and vegetable products, maple products, honey, tobacco, lumber and such other natural products of the forest sea, lake or river, and any article of food or drink wholly or partly manufactured or derived from any such product that may be designated by the governor-in-council in accordance with the provisions of this act."

### More Specific

It will be noted that the amendment is much more specific than the interpretation in the original bill which defined natural products as: "Any product of agriculture or of the forest, sea, lake or river and any article of food or drink wholly or partly manufactured or derived from any such product."

Another change is in regard to the powers given under the bill to make payments out of consolidated revenue. The amended provision reads: "The Governor-in-Council may from time to time authorize payment to the board out of such sums of money as may be necessary to defray the operating expenses of the board incurred or authorized by the board under the authority of section nine hereof." Section nine is the clause under which the minister may initiate schemes for regulating products.

### Section Four

Section four of the act which provides the authority for the Dominion Marketing Board has the first subsection changed to read as follows: "The board shall, subject to the provisions of this act, have power to regulate the time and place at which, and the agency through which the regulated product shall be marketed; to determine the manner of distribution, the quantity and quality or grade of the regulated product that shall be marketed by any person at any time, and to prohibit the marketing of any of the regulated product of any grade or quality."

The following sub-section has been eliminated: "To acquire, hold and alienate such real property as in the opinion of the Governor-in-Council may be necessary for the purposes of this act."

It was the longest hit seen here this season.

The Orioles made all their runs off Ben Cole, veteran southpaw, who pitched good ball after a half first inning until the fatal seventh. The visitors scored five runs in that inning after two were out.

## Britain's Air Defence To Equal That Of Any Power

Cable By Guardian's Special Wire) LONDON, May 11.—The British Government is determined to bring its air defences up to the level of the air power of any nation with which it could be engaged in a "striking distance," Stanley Baldwin told the national gathering of Women's Conservative Associations today.

The delegates who crowded Albert Hall cheered as he added, "I ask you to trust the government, and put the force of public opinion behind them at a time when they are doing all possible for the peace of Europe and the world—and for the honor and security of their own country."

## CONTACT MADE WITH GETTLE KIDNAPPERS

### Family Agree to Terms and The Payment of \$75,000 Ransom.

(A. F. By Guardian's Special Wire) LOS ANGELES, May 11.—While negotiations for the release of William F. Gettle from the hands of kidnapers apparently were progressing on the basis of a \$75,000 ransom demand to which the family attorney quickly agreed, the invalid wife of the victim received an entirely different demand for \$40,000 tonight.

Further complicating the situation, a second mysterious telephone call was made to the office of the attorney, Ernest E. Noon, late in the day, the anonymous informant demanding that if he was "ready to talk" he should "put an ad in the personal column of one of the morning papers tomorrow."

### Predict Release

The new aspects of the case broke into the open while authorities, who had called off all official activity to allow the negotiations to proceed without police hindrance, were predicting the release of Gettle "within 24 hours."

Starting the series of developments, a telephone call was made to Noon's office this morning in which the caller demanded \$75,000, and to which Noon reputedly agreed with little hesitation.

The letter to the seriously stricken Mrs. Gettle was mailed from San Bernardino, 60 miles east of here, at six p.m., yesterday, 10 hours after Gettle had been seized by two smooth-working masked gunmen.

"Get \$40,000 in used bills in 10's and 20's and keep ready. Don't let the law. We'll get in touch with you later."

It was written upon cheap paper in an ordinary hand.

## CREW ABANDON WRECKED SHIP

### Repair Costs Prove Too Much—Crew Leave For Boston.

(C. F. By Guardian's Special Wire) NORTH SYDNEY, N. S., May 11.—Abandoning their wrecked vessel, 20 members of the crew of the American fishing schooner Pilgrim left today by train to return to their homes in Gloucester.

Captain Cecil Moulton and three seamen remained to strip the schooner of engines and valuable parts.

The Pilgrim ran on Petrie's Ledge at the entrance of Sydney Harbor last Saturday morning in a dense fog. Later she was refloated and brought to North Sydney.

She was badly battered, however, and Captain Ben Pine of Gloucester, one of the owners, who has been here since Tuesday, decided to abandon the vessel rather than attempt to make her seaworthy again. Cost of repairs was estimated at \$4,000.

Work of removing the engines and other equipment from the 20-year old craft was begun yesterday and when it is completed Captain Moulton and his helpers will follow the others of the crew to Gloucester.

Arrangements for transportation of the crew were completed after a Captain Moulton conferred with United States Consul Hugh Watson in Sydney.

## Settlement Reached In U. S. Strike

By Guardian's Special Wire) WASHINGTON, May 11.—One of the major strikes of the United States was settled tonight as walk-outs continued in other branches to cut down production of automobiles, shoes, coal and steel. In Galveston, M. J. Dwyer, President of the International Longshoremen's Association in the Gulf, said nearly all the 5,000 longshoremen hit on a strike for several days in Texas and Lake Charles, La., would return to work Saturday under terms of a new labor contract. The agreement, however, did not affect four steamship lines for which the strikers still refuse to work pending further developments.

Following minor disturbances along the Pacific coast, where longshoremen are on strike, a Presidential mediation board sought to work out a temporary working agreement. The possibility of Government intervention was suggested by one mediation board member.

## RESIGNATION REGRETTED

SUMMERSIDE, P. E. I., May 11.—It was with great disappointment and deep regret that the resignation of the Prince County Hospital nurse, the matron, at their regular monthly meeting held last night. The resignation was accepted and will take effect on June 15th.

Miss Pidgeon came to the hospital in the year of 1930 from Montreal and has given complete satisfaction and the news of her departure will be learned with regret by the patrons of that institution. The trustees came to no decision last night on the appointment of a successor. Miss Pidgeon is a native of Kensington and is well known in Prince County.

## FLYING FLYWHEEL DEATH INSTRUMENT

### Man Killed Instantly When Projectile Hurles 440 Yards Into House.

By Guardian's Special Wire) MONTREAL, May 11.—Hurled with deadly force by an explosion a large part of a flywheel tonight travelled about 440 yards through the air, toward the beryard of the P. J. Dupuis split following an explosion resulting from unknown causes. Employees escaped uninjured but the sawing machine and equipment went flying skywards.

One piece flew some distance into the municipal aqueduct; a second toppled to ground some 100 feet from the lumber yard; a third adhered to the machinery proper while the fourth went flying southward to strike the roof of the house in which Patrick resided.

With a sudden roar the projectile pierced the roof of the floor of the top story home, crashing through carrying with it plaster and laths. It struck Patrick on the head, killing him instantly.

An employee of Nesbitt Thompson and Company, Limited, financial firm, Patrick was alone at the time, his wife being on a visit to Ontario.

## Struck By Train Is Killed

FREDERICTON, May 11.—Struck by a fast moving passenger train and dragged for about 600 feet the badly mutilated body of Thomas Harry Turnbull was found this morning about 6:30 o'clock on the railroad track about a mile and a half above the C. N. R. station near Edmundston.

The body was so badly mutilated that recognition was impossible through some papers in a pocket of his clothes.

## ILL RETURNED TO SENATE

(C. F. By Guardian's Special Wire) OTTAWA, May 11.—The Commons having withheld approval of certain amendments made by the Senate in the Fruit and Honey Act, and returned the bill to the Senate, the Upper Chamber today decided not to insist on the amendments. A number of the amendments made by the Senate were accepted by the Commons but the amendment, providing that the governor-in-council instead of the Minister should approve regulations, was objected by the Commons.

## INSULL IS RELEASED ON BAIL

### Friends of Former Utilities Czar Raise \$250,000 For Liberty Ertty.

(A. F. By Guardian's Special Wire) CHICAGO, May 11.—Samuel Insull, Sr., was at liberty tonight on \$250,000 bail.

Released from Cook County Jail by friends who put up that amount, the deposed utilities czar went at once to a guest room in St. Luke's Hospital.

"I've convinced him," said his son Samuel, Jr., "that he ought to rest there. These last three days (Insull has been in jail for court three days and three nights) have been a strain on him."

## Free of Cost

Insull will rest in the hospital without cost. The superintendent said this was in repayment of Insull's contributions to the institution when he was the city's waterworks man.

Next Tuesday Insull must answer guilty or not guilty to two charges against him. Then, too, a court will rule on his charge that he was "shanghaied" from his seagoing refuge, the Greek freighter Malotis.

On Wednesday he will be arraigned and asked to answer state charges of embezzlement, connected with sums taken from middle-west utilities to meet brokerage accounts of his brother, Martin.

As he left the county jail hospital, dressed in dark blue business clothes again instead of the maroon bathrobe which has been his jail uniform, Insull waved goodbye to the other patients and said, "Well, boys, good luck to you all. And if I see any of you, I want to wish each one of you the very best."

## 14,000 Fisher Body Workers On Strike

(A. F. By Guardian's Special Wire) FLINT, Mich., May 11.—Eighteen hours after union employees of the Fisher Body Corporation Plant No. 1 walked out, the Bulk Motor Co. plant was shut down today, throwing 14,000 men out of work at least until Tuesday.

There was no explanation from Bulk officials for the closing of the plant, on the eve of the introduction of a new model, but since the Bulk No. 1 plant produces bodies for Bulk, it was assumed that operations could not continue in the face of the Fisher strike.

Meyer L. Lewis, American Federation of Labor organizer who is in charge of strike activities temporarily, will address a meeting of Chevrolet Motor Co. workers tomorrow. The announcement said the meeting would be concerned only with union membership figures as a basis for collective bargaining, but the belief was expressed in some quarters that a possible spread of the strike to that plant would be discussed.

Five thousand Fisher employees walked out yesterday in protest against what they said was a reduction of piece work rates; a speeding up of the assembly line and alleged refusal of the management to confer with a union committee.

## Debt Parley Not Favored By The U.S.

WASHINGTON, May 11.—President Roosevelt made it clear today he was opposed to participation in any general conference to consider a settlement on the world's debts.

At the White House, it was authoritatively explained that while the United States was perfectly willing to enter any discussions concerning the reduction of the world's debt, funding agreements with any single nation, the United States would not join in any general debt discussions.

President Roosevelt has left the door open for any suggestions from individual debtor nations and there is still, in high official circles, an expectation that some hitherto undisclosed move will be made—either abroad or in Washington—to break the apparent war debts deadlock.

## Sir John Simon Speaks On British Debt Problem

(C. F. Cable) (By Guardian's Special Wire) MANCHESTER, England, May 11.—Sir John Simon, British Foreign Secretary, took the opportunity today of a public speech upholding protection today to denounce as illogical anyone who believes a nation is able to pay tremendous sums in war debts simply because it happens to have a budget surplus.

Goods cannot be translated into huge monetary sums for international transfer without disrupting world exchanges and trade, he pointed out. He stressed he was not speaking for the government in his reference to war debts, but merely for himself.

## IBN SAUD ADVANCES TO YEMENITE CAPITAL

### Three Saudian Armies On Combined Offensive Against Last Stronghold Of The Imam Of Yemen.

LONDON, May 11.—King Ibn Saud, climaxing his crushing drive to subjugate all Yemen, spurred three separate armies today in a combined movement upon Sana, Yemen's walled and ancient capital. The powerful ruler's largest army, under Crown Prince Emir Saud, had opened an offensive against Sana, key city northwest of Sana and the gateway to the picturesque capital.

It will be only a short time until our armies enter and control Sana.

The Saudians, blaming the Imam of Yemen for the Arabian war, vowed that foreign interests will be fully protected, asserting the main idea of subjugating Yemen is to bring permanent peace to that area.

## Advancing Toward City

The second division was advancing from Hodeidah, Yemen's important Red Sea port, already smashed by Ibn Saud's Saudi Arabian forces and now policed by them while British, French and Italian warships lie watchfully in the Harbor.

The third army, now east of Sana, was ordered to advance immediately upon the capital—a city of about 25,000 population and surrounded by a brick wall five and one half miles in circumference.

## Not Affected By Change In Wheat Quotas

OTTAWA, May 11.—Canada will not lose in the event of wheat quotas being adjusted so as to permit a larger quantity of Argentine, Prime Minister R. B. Bennett informed the House of Commons today.

At the opening of the House today, S. W. Jacobs (Lib. Critic) drew attention to the fact that press despatches stressed the request of the Argentine for a larger quota under the wheat agreement. He wished to know who had represented Canada at the conference and whether any change had been made in the quotas. Canada, replied the Prime Minister, had been represented at the Rome conference by Col. Vanier and John I. McFarland, head of the selling agency of the wheat pools. After a conference in Rome, adjournment had been made to London, but Mr. McFarland returned to Canada.

If any concessions were made, continued Mr. Bennett, they would not leave Canada in any loss of shipments abroad. Such concessions would take the form of a loan for only one year, and there would be no reduction on the amount of wheat which Canada would ship.

## PROVINCIAL GOV'T. LOANS DISCUSSED

### Advisability of Floating Loans On the London Market Is Considered.

(C. F. By Guardian's Special Wire) OTTAWA, May 11.—The floating of loans by Canadian provincial governments on the London market would be somewhat difficult at present, in the opinion of Prime Minister R. B. Bennett. The Prime Minister was dealing with a question of Hon. Ian Mackenzie (Lib. Vancouver Centre), who wished to know what the policy of the Dominion Government was in respect to permitting the provincial governments to enter the British market for re-funding.

London, Closed Market

The matter was one over which the government had not control, answered the Prime Minister. He understood, however, that the tendency over in England was not to permit the provinces to float issues on the London market. The London market was a closed market, he continued, and the permission of the British treasury must be secured before a loan could be floated on it. He understood that it was extremely difficult for the provincial governments to secure permission at present.

## War To Finish

King Ibn Saud decided, the Saudians said, on a "war to the finish" when the Imam Yahya failed to keep promises to enter into a 20-year peace arrangement.

They asserted Yemenis ruler sent raiders into territory of Saudi Arabia.

"A man like the Imam, who has broken his word continually should not be permitted to rule longer," the Saudians said, "so Ibn Saud determined to break that rule."

The Saudians officially absolved any connection with the Yemen, refuting reports that the Imam had a defence pact with Italy, which, like France, has interests across the Red Sea.

## APPEAL MADE IN ASCAH CASE

QUEBEC, May 11.—Appeal of Nelson Phillips, from the death sentence imposed upon him by Chief Justice R. A. E. Greenfield, of Montreal, following his conviction on the charge of murdering his 14-year-old cousin, Maud Ascah, at Gaspé, last summer, was taken under advisement by the Court of Appeals under Chief Justice Sir Mathias Teller here today.

Valmore Bienvenue, K. C., and Lucien Cannon, K. C., prosecuting attorneys, finished presentation of their arguments after Guy Hudon and Lucien Gendron, K. C., of Montreal, had submitted their reasons for quashing the conviction and sentence.

Maud Ascah and her cousin Marguerite Ascah disappeared from Gaspé last August. The former's body was recovered from the river some weeks later but that of Marguerite was never found. Phillips was arrested and charged with the murder and a confession of the crime he is alleged to have made voluntarily is one of the main grounds of the appeal. Defence lawyers also held a change of venue from Gaspé to Quebec should not have been granted and stated certain sections of the charge of the trial judge to the jury were illegal.

Mr. Gendron insisted the alleged confession could not have been made voluntarily by Phillips since, he said, it attributed no motive for the crime and was furthermore full of inaccuracies as to time, place and other important facts.
