BREACH OF CONTRACT CASE BEFORE COURT
The civil case, William L. McEachern vs. Neil C. Reade, action for damages resulting from an alleged breach of contract, was called on the Supreme Court resumed yesterday. Mr. Justice A.C. Saunders presided. Mr. W. E. Bentley, K.C., appeared for the plaintiff and Mr. R. R. Bell for the defendant.
