

ADDRESS AND PRESENTATION TO J. W. RYAN

At the Monthly Meeting of the P. E. I. Poultry Association.

BUSINESS DONE

The regular monthly meeting of the P. E. Island Poultry Association was held in the Prince of Wales College Hall last evening with the largest attendance for some time past showing that interest in the work is on the increase.

It was decided not to exhibit at the Amherst Winter Fair this season though members will show individually. The following resolution was unanimously passed.

That whereas, the present rules governing the Poultry department of the Amherst Winter Fair, necessitate birds entered from the Eastern section of P. E. Island leaving Charlottetown on Friday morning thus spending three extra days in Amherst. Therefore resolved that this association strongly requests the Maritime Poultry Association to arrange that in future that birds coming through Charlottetown be admitted to the Exhibition building up to six o'clock Tuesday of the week of the Exhibition.

The committee appointed at the last meeting to secure a suitable hall in which to hold their annual poultry show in January reported their failure to secure quarters adapted to the purpose. The committee was supplemented by one more member and instructed to report later.

A pleasant feature of the evening was the presentation to the retiring President, J. W. Ryan, who shortly leaves the island on account of the recent Royal-Union Bank merger. Ex-Gov. McKinnon, on behalf of the Association, read the following address and presented Mr. Ryan with a handsome Meerschmum pipe, the gift of the Association.

INTERNATIONAL RAIL TRAFFIC TOLL QUESTION

TORONTO, November 1—After some negotiations between Chief Commissioner Mabee of the Dominion Railway Commission and the United States Interstate Commerce Commission with a view to regulating tolls upon international freight traffic, it has been decided that the matter is one that cannot be satisfactorily dealt with by concurrent legislation.

To establish an international commission would require the sanction of a treaty and this may be found in the approaching reciprocity negotiations.

It is likely that Judge Mabee will be commissioned by the Imperial Government to co-operate with the representatives of the United States in framing a treaty respecting freight rates on international trade.

TEN THOUSAND MEN ON STRIKE IN NEW YORK

NW YORK, Oct. 31.—The striking Expressmen gained adherents today when between 1500 and 1800 workers of Monahan's express, the Boston Despatch and the Manhattan Delivery Company, joined issue with them. The platform men of the American Express Company at the Grand Central Station and the same Company's way bill clerks went out in sympathy. It had previously been reported that the strikers attacked wagons manned by strike breakers. Stones and missiles of all kinds were thrown and several drivers and helpers were badly hurt.

William Hoyt, a helper on the American Express wagon, had his skull crushed with a brick bat and probably will die. All the disturbances were quickly quelled by the police who dealt in no gentle manner with the strikers.

Rev. T. A. Moore, the General Secretary for Canada, and Rev. Mr. Rochester, the new secretary, were then introduced and were received in a hearty manner. The report of the secretary was read and ordered to be printed. The report of the Treasurer was also read and adopted.

The election of officers for the ensuing year resulted as follows:

President—Rev. R. G. Strathie, (re-elected). Secretary—Rev. T. W. Murphy. Treasurer—A. W. Sterns. A resolution was passed expressing the appreciation of the services of Rev. T. Albert Moore.

His Honor the Lieut-Governor presided at the Lord's Day Alliance meeting in Zion Church last evening. The speakers were Dr. T. Albert Moore and Rev. Wm. Rochester. SERIOUS FIRE HITS WINNIPEG HEAVY LOSS

Special to The Guardian. WINNIPEG, November 1—The four story building on the Macdonald Wheelbrake Grocers Co., Ltd., was burned yesterday.

The loss is \$250,000 with insurance of \$200,000.

The building inspector claims that the fire was caused by the floors being overloaded with stock and collapsing, setting fire to a carload of matches.

The company's officials declare the fire started before the collapse.

A SAD DEATH AT EARNSCLIFFE

Augustine McInnis of Earnscliffe, one of the most prominently known and well-to-do farmers of Queen's County, died about 9 o'clock Tuesday night under sad circumstances.

Since the death of his son who was accidentally killed in Colorado recently, Mr. McInnis has brooded much over the sad affair, so that his mind had become completely unbalanced.

Tuesday morning he visited his cousin, Roderick McIsaac of China Point, and it was while there that he took a dose of Paris green.

Two doctors were summoned, and worked hard to save his life, but their efforts proved unavailing.

Mr. McInnis was a man of more than ordinary ability as a farmer; he was a well informed man on many subjects and a devoted member of the Roman Church. At times he was subject to dementia, but when not in this state was a man whom it was a pleasure to know.

He leaves several sons and daughters to mourn, who will have the sympathy of many friends in their sorrow.

Four Calls to Ministers Considered-Church Union Discussion Postponed.

LARGE ATTENDANCE

There was held in St. James' Hall yesterday an important meeting of the P. E. I. Presbytery at which there was present one of the largest attendances for some time past.

There was much urgent business for disposal and to transact this ministers and elders from every part of the province met.

The matter of calls for ministers stationed in this province took up a great deal of the time of the Presbytery. These calls were to Rev. G. E. Ross, City, from Goderich; to Rev. A. D. Stirling, Kensington, from Scotsburn and Upper Shewiache, N. S.; to Rev. W. I. Green, Brookfield, from the Foreign Missionary Committee to go to Trinidad.

In the case of the call to Mr. Ross of Zion Church, City, which he accepted, there appeared a committee from his Church composed of John A. Lawson, for the Session, S. A. McDonald, for the Trustees, J. J. Guthrie for the congregation and Guy McKenzie for the Young People and the Order of Recruits for the Ministry. These pleaded eloquently to the Presbytery in the attempt to retain his services. Rev. Mr. Ross will leave for Goderich about the middle of the month.

In the case of Mr. Stirling, Rev. Crowdis from Pictou County and Mr. Stewart, representing Scotsburn and Rev. W. P. Archibald, representing Upper Stewiacke spoke requesting the acceptance of Mr. Stirling of their respective calls while Kensington sent ten commissioners to plead that Mr. Stirling remain. Mr. Stirling asked for two weeks to consider the question and decide.

Mr. Green accepted the call of the Foreign Mission Committee and will be formally designated to the Field at Brookfield on Nov. 10th. Five members of the Brookfield and Clyde River congregations were present and expressed the universal regret of the people in view of Mr. Green's removal but their sympathetic concurrence in his decision.

The matter of Church Union was to have come up before the Presbytery but the press of other business prevented it. It will be discussed for a whole day, however at a special meeting which will be called for the purpose on the first Tuesday in December (the sixth).

NORTH IS SOLID FOR THE LIBERALS

LONDON, Oct. 31—Premier Asquith, speaking in Fifeshire, made a plea for patience and confidence, apropos of the compromise conference now going on. The Liberals are patient, especially in view of the Times' admission that the Unionists would lose in a general election. This admission is confirmed by a Unionist agent recently sent to make a confidential investigation of the Unionist position in the North. He says the North is solidly Liberal.
