LEGISLATURE IN COMMITTEE YESTERDAY

Provincial Legislature, March 30. The House met at 11.50 a. m. Mr. T. A. Campbell asked the speaker of the House to table a copy of the order or orders-in-council appointing the officials to administer the Old Age Pensions. The answer was tabled. Mr. LePage asked for a list of officials discharged from Falconwood hospital. Hon. Dr. MacMillan furnished the names. Hon. Dr. MacMillan presented a bill to amend the Teachers Superannuation Act 1931. The following Acts were read a third time and passed: An Act to amend an Act to consolidate and amend the various Acts relating to the prohibition of intoxicating liquor. (Hon. Dr. MacMillan). An Act to amend the Public Health Act 1920 and amendments thereto. (Hon. Dr. MacMillan). On motion of Hon. Dr. MacMillan, an Act to amend the Highway Act was referred back to committee. The House went into committee with Mr. Wigmore in the chair. The promoter said he had been advised that Clause One, compelling drivers of vehicles involved in a traffic accident to return to the scene of the accident and give their name and address, was already covered by the Criminal Code and was ultra vires this Legislature. He therefore moved that this provision be deleted. Mr. T. A. Campbell said a great proportion of vehicle drivers were not familiar with their obligations under the statute. Mr. McIntyre thought the section of the Federal Statute dealing with this matter should be published in the Charlottetown newspapers for a week or so. The amendment carried and the bill was reported agreed to. Old Age Pensions On motion of Hon. Mr. MacPhee the House went into committee with Mr. Hunter in the chair on second reading of an Act to amend the Prince Edward Island Old Age Pension Act, 1931. The promoter said the present bill contains a section providing that the Governor-in-Council shall designate the member of the Executive Council to be charged with the administering the Act. The practice in other Provinces is to couple this Act with the department of Health and Education. This was considered in many respects more satisfactory to have the administration of the department coupled with another portfolio. Mr. T. A. Campbell congratulated Mr. MacPhee in setting an example of statesmanship by promoting a measure which had for its purpose directing the Hon. gentleman of a portfolio. He believed the name was a good one. Hon. Dr. MacMillan said the new bill would place a good deal of work on his shoulders but he would endeavor to discharge his duties as well and as competently as possible. The clause carried. Board of Commissioners Clause 2 repeats: Section 13 of the Act and substitutes therefore: 13. (1) The Lieutenant Governor in Council shall appoint persons to constitute a Board to be called the Board of Pension Commissioners, which Board shall consider and decide on applications for old age pensions. (2) In this Act "Pension Authority" shall mean the Board of Pension Commissioners appointed by the Lieutenant Governor in Council in pursuance of the provisions of this Act. (3) The said Board shall be a corporate body with authority to receive conveyances of, hold and dispose of, real estate for all purposes incidental to this Act. Mr. LePage stressed the responsibilities of the new Board of Commissioners and the possible danger of partisanship creeping in. A great deal will depend on their wisdom and justice. There was bound to be a lot of political pressure and these men should be picked with very great care. Hon. Dr. MacMillan said he realized the force of the Opposition leader's remarks. This idea of getting as much as possible out of the Government is becoming almost unbearable. One of the latest applications received was that the Government should pay for confinement cases. The Old Age Pensions would probably be the biggest avenue of demand. Mr. T. A. Campbell asked if this clause abrogated the functions of the Superintendent of Old Age Pensions. There did not seem any necessity with a minister and Board of Commissioners, of having a Superintendent. Hon. Mr. MacPhee said it would be satisfactory in no sense that the minister himself should be the authority to consider and decide on applications. It is contemplated that the Board of Commissioners will act in that capacity. The duties of the Superintendent will be to investigate every case, to see that all the evidence, favorable and unfavorable, regarding the applicant is obtained and placed before the Board. In the beginning, especially, the Commissioner will be a very busy man. The original Act also provided for a Board of Review. Personally Mr. MacPhee did not think any particular need would arise for the latter board, but provision for it was being retained in the Act. Mr. LePage asked if it could not be possible to delegate one of the Judges of the Province to hear complaints of petitioners against decisions of the Board of Commissioners. Mr. MacPhee said that if it was found necessary to appoint a Board of Review, some of the Judges would likely be asked to act in that capacity. Mr. Campbell thought the proper Court of Review would be the County Court Judge in the County in which the dispute arises. The Superintendent under the Act would be required to pass on titles and conveyances, etc., and would have to be a legal man himself or else it would be necessary to employ one or more legal advisers at considerable expense. He suggested that the machinery proposed was too ambitious for this Province and that clause 1 should be reconsidered in order to abolish the Superintendent's office at a salary of \$1800 and appoint instead a legal member of the Government to the portfolio of Minister of Old Age Pensions at a salary of \$1500. At 1 p. m. progress was reported and the House took recess. On motion of Hon. Dr. MacMillan the House went into committee with Mr. Wigmore in the chair on second reading of an Act to further amend the City of Charlottetown Incorporation Act. Sec. 1 provides for various minor changes in the wording of Sec. 23 sub sec. 3. Mr. LePage: This is just changing a few blunders that were in the Act. Hon. Dr. MacMillan: "That is just the explanation I was going to give." 3. Section 112 of the Act as amended by adding to sub-section (2) the following: And for compelling the disconnection, or preventing the connection of any defective or un-inspected installation or appliance. 20-a To license all contractors and workers engaging in the installation, extension or repairing of electric service wiring, outlets, or appliances within the city, and to prohibit, limit or regulate all unlicensed persons from so engaging; to charge fees for such licenses; and to provide for a Board of competent examiners to examine such contractors and workers regarding their proficiency and skill before such licenses shall be granted. The bill was agreed to and the House took recess till 8 p. m.

(Continued from page 3) administering the Treasury Department. Mr. LePage said \$450 was too much for expenses for the Agricultural Minister. It should, he thought be cut out altogether. Mr. Allen asked about grants for exhibitors in Prince Co. Hon. Mr. MacNutt said there was \$750 set aside for Alberton. Mr. Allen: "How much for Summerside?" Hon. Mr. MacNutt: "Nothing for Summerside." Mr. Allen: "There should be," Hon. Mr. MacNutt: "Summerside did not ask for it." Mr. Allen: "Did Alberton ask for it?" Hon. Mr. MacNutt: "Yes." Hon. Dr. MacMillan: "I don't think the last appropriation that was made for Summerside was ever taken up. The Association is evidently not carrying on. They are not asking for the grant." Assistance To Fishermen Mr. Bethune explained that he had been able to give some assistance to the fishermen at Rustico Beach. They had asked for a road and at his request the Government started the road. He again took the matter up last year with the Government and obtained a further grant to complete the work. In south Rustico a delegation waited upon him with regard to boats coming from New Brunswick and fishing lobsters out of season. Mr. Bethune went to Inspector Gallant but the Inspector told him he could do nothing further. However, with Mr. Gallant's approval Mr. Bethune wired to the Minister of Fisheries at Ottawa, as well as Mr. McLure, M.P. and Mr. Myers, M.P. He received a telegram from Mr. Found, Deputy Minister, that he had intercepted the boat Arras and had her sent down here to hold the middle Strait and he promised to send the fastest boat he had to discourage illegal fishing. That boat duly arrived and did wonderful work along the coast. Later a meeting of some forty fishermen was held to discuss lobster fishing from every angle. Before the meeting adjourned Mr. McLure, M. P., stated he would try to get in touch with the Deputy Minister and bring him here. Later Mr. McLure informed the speaker that the Deputy Minister could not attend but he would send down the Chief Inspector, Mr. Sutherland. Mr. Sutherland duly arrived and a meeting was held which was attended by about 90 representative fishermen. The outcome was the appointment of three representative fishermen to work with Mr. Sutherland. Through this conference Mr. Brodie who used to fish 80 boats here has agreed to send only 8 boats to fish this year. That means that the Island fishermen will be better looked after this year. Mr. Allen wondered if there was any legal remedy against fishing of this kind. It was a serious situation for the province. It was a question if there was any remedy. Mr. J. A. Campbell said that \$2,000 of a salary for any Minister owning a car was out of proportion to what farmers were receiving. He criticized paying travelling expenses to different officials at this particular time. Mr. LePage's amendment that the salaries be scaled down, was lost on a straight party vote 11-15. The item passed. Executive Council (\$4,000) passed, the Opposition amendment being again defeated on a party vote. Falconwood Hospital and Infirmary (\$87,200) Mr. McIntyre referred to tenders under different administration. The discussion on tenders was continued by Mr. J. A. MacDonald. Hon. Mr. Sharp said this year the Government would have to purchase a small extra amount of coal for the Infirmary. The estimate is \$85,000 this year. The Government had asked for competitive prices on other than coal, butter, fish, and meat, for which tenders were called in the newspapers. Considerable discussion followed on the question of tenders. The discussion was taken part in by Messrs. LePage, Sharp, McIntyre, Lea, Bethune, Cox, Allen and others. (To Be Continued)

B., March 30.—Beer and wine in New Brunswick again have been reduced in price, according to announcement made today by the New Brunswick Liquor Control Board. The reduction in wine prices has already taken effect but the new beer prices come into effect April 1, when all beer will be reduced by 30 cents per dozen bottles. Native wine that formerly sold for \$2.50 per bottle, now costs \$2.25, while other brands of wine have been reduced from 90 cents per bottle to 65 cents. This is the second price reduction announced by the New Brunswick Liquor Control Board in recent months, the prices on whiskey, gin and liqueurs having been reduced some months ago. MONTREAL, Que., Mar. 30.—Walter Pratt, General Manager of the Hotel Department, Canadian National Railways announces that Jasper Park Lodge, the well known Rocky Mountain resort, will be opened officially this year on June 15th, and not on June 1st, as previously announced. While the New Yorkers outplayed the Red Wings throughout most of the game they failed to roll up a more convincing count due to the brilliant work of the Port Perry Ont. chicken fancier, voted the greatest net minder in the league who played one of his finest games and thoroughly deserved a shutout. Contains Shot Gun Shell WATERTOWN, N. Y., March 30.—(A.P.)—The finding of a third package containing a shot gun shell intended to be sent through the mails to President Franklin D. Roosevelt at Washington, was revealed by the Post Office here today. It was found Wednesday noon at the box across the street from the Post Office where the two previous packages were placed. The latest package was addressed, Post Office officials said, to a man connected with an air line in New Jersey. They declined to reveal the address of same, or city. A note inside the package asked that the container be returned to Mr. Roosevelt. Investigation began after postal clerks recognized the hand-writing of the addresses the same as that on the previous packages. Postal Inspectors C. F. Ford and E. B. Teagle were notified and were to arrive here today. Officials declined to make public further information. Asks Extension Of Time (Canadian Press) CANSO, N. S., March 30.—This eastern shore fishing town's Board of Trade is on record as favoring extension for at least a year of the modus vivendi, under which United States craft may make ordinary purchases in Canadian Atlantic ports. The Federal Government restored the modus vivendi for a period ending May 31. The Canso board contends "this period cannot afford a fair opportunity to gauge the full value of the port trade accruing from the use of these privileges" as the American fleet did not operate on that section of the coast until later in the season.

HAWKS ARE CONFIDENT OF VICTORY

Burrage Will Play In Tonight's Game — Further Changes In Lineup Are Anticipated. (Canadian Press) TORONTO, March 30.—Moncton Hawks today skated through a fast and satisfactory practice session in preparation for the second and deciding game of the senior Eastern Canada hockey championship series with Niagara Falls Cataracts here tomorrow night. Ontario champions won the first contest 1-0 Wednesday. Despite the fact they must overcome a one-goal deficit and score an extra counter to qualify for the Allan Cup final at Vancouver, no gloom appeared today in the Moncton camp. Rather the Maritime time champions, conquerors of Montreal Royals, were confident they would defeat the faster-skating Cataracts. Coach Percy Nicklin and Manager Ambrose Wheeler announced the Hawk cause would be strengthened by the addition of Len Burrage, star defenceman, who has been on the injured list for more than a month. Burrage was originally slated to appear in the first game but was kept on the bench to save him for the last desperate assault on the Niagara Falls citadel. Burrage will probably replace Walker and it is also likely Monty Muckle will be dropped from the right wing with Aubrey Webster relieving. Miller will be used on the alternate forward line. These probable changes were announced by the coach following today's workout. Cataracts will depend on the same smooth team that carried them to a win in the first tilt. They are naturally favored to enter the Allan Cup bracket but Hawks have plenty of supporters who firmly believe they will win the deciding game and the series. (Associated Press) WASHINGTON, March 30.—United States Senate investigation headed tonight towards the most fabled of one of the world's greatest banking houses, J. P. Morgan and Company, determined to bring to light anything that has a bearing on the central task of correcting stock and bond sale practices. Authority to inspect the Morgans records was sought of the Senate or its Banking Committee, which disclosed it had been rebuffed so far in its efforts to bring the big private banking concern into the light of its stock market investigation. There appeared to be no doubt that the Senate would grant this power. But not even that investigation was allowed to stand in the way of action on the Roosevelt proposal for immediate legislation to bring security issuance and sale under the regulation of the Federal Government, to afford investors protection against dishonesty and give them full opportunity to know what they are buying. Both the Banking Committee of the Senate and the Interstate Commerce Committee of the House have set for tomorrow morning the start of hearings on this legislation. The Morgan situation developed when Ferdinand Pecora, committee counsel in charge of the stock market inquiry, reported he had submitted a list of 23 questions to the banking house regarding its operations, the bankers agreed to answer only 15. Through John W. Davis, its counsel, the banking house questioned the committee's authority on seven of the questions and flatly refused to answer the other, Pecora said. The committee instructed him to draft a resolution to give it unquestioned authority to go fully into the field of private banking. This is to be placed before the Senate quickly. Pecora said the questions on which answers were refused had to do with the capital structure of the banking house. He did not disclose the other questions. Minard's Liniment removes dirt.

JURY FINDS NEGRO GUILTY OF MURDER

Mercy Is Strongly Recommended In Verdict. Prisoner Will Be Sentenced Saturday. (Canadian Press) HALIFAX, March 30.—Mercy was strongly recommended by a Supreme Court Jury today in finding Samuel Crawley, 24-year-old negro, guilty of murdering his father in a fit of rage on St. Valentine's Day. Crawley heard the verdict calmly, showing emotion only by tapping lightly against the side of the prisoner's dock with his fingertips. Throughout his trial he had chuckled and smiled as witnesses gave evidence relating to the killing of John Crawley, who died from a blow from an axe wielded by his son. His demeanour lent apparent strength to the testimony of Dr. W. D. Forrest, called by the defence to give evidence as to the mentality of Crawley. The medical expert declared that questioning of the accused had shown him to possess the mentality of a child of seven years. Another witness today was John Crawley, younger brother of Sam and an eye-witness to the death of his father. "Sam hit pappy with the axe; I saw pappy fall and Sam dropped the axe and ran," he related. The incident had taken place at the Crawley homestead in the colored community of Preston, just across the harbor from Halifax. The fact that the son had run away after the deed had shown ability to discriminate between right and wrong, Crown Prosecutor R. H. Murray urged before the jury. "It is a pitiful case," commented Chief Justice J. A. Chisholm in his sum-
