—D. R. Morrison and Peter G. Clark, Summerside, left yesterday for Chatham, N. B., to make arrangements for the resuming of work on their railway contract at that place. They will return in about a week's time.—S.

—The marriage of William F. McArthur of Brocton and Lydia A. Rix of Rosville took place at the home of the bride's mother, Mrs. Parmenus J. McArthur, Elmsdale, on Tuesday, March 21st. The ceremony was performed by the Rev. J. H. McHattie in the presence of near relatives and friends. Miss Annie Brennan of Elmsdale acted as bridesmaid and Parmenus Brennan supported the groom. After the happy couple had received the congratulations of their friends a dainty wedding supper was served. Mr. and Mrs. McArthur will make their home in Rosville.

—The death occurred at the home of her nephew, John D. McFadyen, Augustine Cove, of Mrs. McFadyen, relict of the late Finlay McFadyen. The deceased was in her ninety-fifth year and was an invalid for the past two years. She was a strict adherent of the Church of Scotland and was one of the members of the congregation of the late Rev. Ronald McDonald. She was a woman possessed of a high standard of Christian ideals and was highly respected wherever known. She leaves to mourn, besides other relatives, one son, Neil, Augustine Cove. The funeral takes place this afternoon at two o'clock to the Church of Scotland Cemetery at Cape Traverse, the services being conducted by Rev. James McDougall.

—The citizens of Summerside were shocked yesterday morning to hear of the sudden death of Charles Murphy, chief clerk in the Customs Department. The end came about 10.30 a. m. while he was at his desk in the Custom House. H. M. Baker who was near him at the time noticed his hard breathing and turned around to find him leaning on the arm of his chair with his head resting on his shoulder. He hastily called a doctor, but by the time the latter arrived Mr. Murphy had passed away, death being caused by apoplexy. Deceased was born at Kinkora in 1839 and early in life taught school in Grand River, and afterwards at Summerside. In 1882 he was appointed to the office of chief clerk in the Customs Department, Summerside, which office he acceptably filled up to the time of his death. During the past year or so his health had not been the best, but no one, least of all himself, thought that the end was so near. In religion he was a Roman Catholic. He always took a deep interest in the work of fraternal societies, being a member of the C. M. B. A., and also of the Independent Order of Foresters, having filled for a couple of years the office of high chief ranger in the latter society. He leaves to mourn, besides a sorrowing widow, two sons, Herman in Western Canada, and Fred in the employ of Peter McNut & Son, Malpeque, and 4 daughters, Mrs. (Dr.) L. S. Doyle, Moncton; Maud of the teaching staff of the Georgetown high school, and Ella and Bertha at home; also two brothers, Joseph in Massachusetts, and Frank of Summerside, and one sister, Mrs. Charles Thomas, St. John. The Guardian extends sincere sympathy to the bereaved family.—S.

TAKES SECRET TO THE GRAVE

BANGOR, Me., March 24—Memories of Maine's most famous murder mystery—the long celebrated Dexter bank case, have been revived by the death in Skowhegan almshouse on Thursday of Charlie Stain, the man who, by a confession generally believed to be a pure fake, sent his own father to prison. Charlie Stain died a pauper, a physical and mental wreck, alone and abandoned by all his kin. Just before he died, Stain was asked to make a statement concerning the Dexter bank case; to say whether he spoke the truth or lied when he declared that his father had confessed to him the murder of Cashier Barron, but he would say nothing, the very mention of the Dexter bank seeming to strike him dumb with terror, and he died with the secret unrevealed. On Feb. 22, 1878, Cashier John Wilson Barron of the Dexter Bank in Dexter, was found in the vault room of the bank, gagged and bound. He had been struck upon the head with some heavy instrument, and was nearly or quite dead when found. Apparently it was a case of murder, with robbery as the motive, although it afterward developed that little or no money was missing. In the fall of 1887, Charlie Stain, prisoner in the Somerset county jail at Norridgewock, called Sheriff Mitchell to his cell late one night and made the famous "confession" which resulted in the arrest in Medfield, Mass., of David L. Stain, father of Charlie, and Oliver Cromwell. Young Stain told the sheriff that his father had confessed to him that he, the elder Stain, and Oliver Cromwell murdered Barron. It was a long and circumstantial story, and resulted in the arrest of Stain and Cromwell, who were tried and convicted of murder in the first degree, and sent to prison for life. They were pardoned in December, 1900, and went home to Medfield, Mass.

—The death occurred at his home in Seaview on Saturday morning last of Benj. B. Donald an aged and highly respected farmer of that place after a very short illness of pneumonia, the deceased being in good health up to within a few weeks of his death. The late Mr. Donald was 72 years of age and leaves to mourn besides an aged widow two sons Herbert and Edward both at home and three daughters Mrs. Fred Joyner, St. John, Maud and Amy at home, also one brother, James in Addison, Mass., and two sisters, Mrs. Wm. Wells, Alberton, and Mrs. George Haywood, Elmsdale. This is the third time within the past 15 months that death has visited this home. A daughter Ella, a nurse on the staff of the Worcester General Hospital having died suddenly a year ago last January while her sister Mrs. Fred Matthews died in Western Canada early last summer. The funeral took place on Monday afternoon last to the Malpeque Presbyterian Cemetery and was very largely attended. Rev. E. J. Batters conducted the services at the house and at the grave.—S.

TOOK UP TWELVE PASSENGERS IN AEROPLANE

MOUZON, France, March 25—Roger Sommer, the French aviator, broke Louis Bregue's record, Thursday, in taking up twelve passengers. Sommer carried thirteen persons, weighing in the aggregate 1,463 pounds. He flew, however, only two-thirds of a mile, whereas Bregue, who used a monoplane, went two miles. The weight of Bregue's passengers was 1315 pounds.

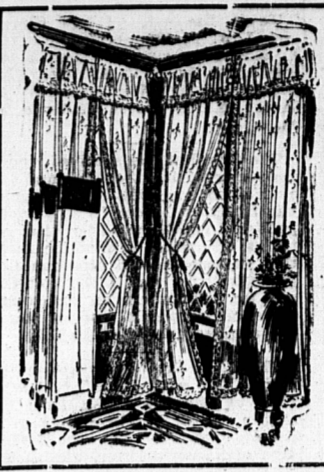
