Cancels Visit to Rome and England.

BOER ORGAN'S THREATS

To Wreck the Mines—Dreyfus Public Courtmartial Begins Today.

LONDON, Aug. 11.—(Special)—Admiral Dewey will not visit England and has cancelled his proposed trip to Rome the latter because the Government fears his warm reception will offend Spain.

The Boer organ here declares that in the event of war Johannesburg will be wrecked and millions worth of mining machinery will be blown up.

This is believed to be a final threat before backing down on the part of Kruger and his backers.

At Ottawa Yesterday Afternoon.

A PARTISAN OFFICIAL

Exposed by Foster—Troops from Halifax for the Transvaal—Man Drowned.

OTTAWA Aug. 11.—(Special)—Parliament was prorogued this afternoon.

Hon. Mr. Foster read a sworn affidavit that H. A. Lamienx, Inspector of Customs at Gaspé, had under the name of H. A. Lamirand represented his son, the present member in the last election and demanded his dismissal and punishment.

Sir Richard Cartwright promised to lay the matter before the Minister of Customs.

Mr. Foster also made a review of the work of the session and charged the Liberals with deserting their pledges.

FAMINE FOLLOWS

Wreck and Ruin Wrought by Storm.

FIVE HUNDRED LIVES

Lost, Including American Soldiers—Failure of McDonald the Klondyke King.

WASHINGTON Aug. 11.—(Special)—The details of the West Indian hurricane show the loss of life and property much larger than was first supposed.

Among the killed at Porto Rico are a number of American soldiers.

The loss of life will be more than five hundred, and many thousands are starving. A famine is impending.

CHICAGO Aug. 11.—(Special)—It is reported that Alex MacDonald the Klondyke King has failed with liabilities of \$6,000,000 and assets not more than one fifth of that sum.

BUTTER AND CHEESE FOR ORIENT.

Experimental Shipments to China, Japan and Sandwich Islands.

HALIFAX, Aug. 9.—Officials of the United States agricultural department are of the opinion that a profitable market can be established for American dairy products in the Orient.

With a view to testing the matter consignments of butter, cheese and condensed cream are about to be shipped from San Francisco to China, Japan and the Sandwich Islands under the auspices of the department.

While in the Orient recently Dr. Knapp, a special agent of the department visited several centres of trade and made arrangements with merchants to handle American dairy products.

The shipments have been delayed several days on account of difficulty experienced by the department officials in securing transportation for the goods.

Outgoing steamships at this time are heavily laden with merchandise, and the shipping people were unwilling to be troubled with handling the small experimental shipment of the department.

An agreement has been reached, however, and the goods will be on the ocean within the next ten days.

5 MILES IN 10.44 2-5

Several of the Events will be Finished Continued This Morning.

MONTREAL, Aug. 11.—(Special)—The Five Mile Handicap for amateurs, postponed yesterday was won by Goodson of Australia; Caldwell of Scotland, second; Sheritt, Brantford third; Boisvert, Montreal fourth. Time 13:33 1-5.

The first heat of the Five Mile Professional Handicap was won by F. Butler; Nat. Butler second; Gibson, third. Time 10:44.

In this heat Nat. Butler started scratch and beat the World's Record, doing the five miles in 10.44 2-5.

The second heat was won by Boake, Toronto; Coleman, Boston, second; Gibson, Ohio, third. Time 11:07 1-5.

The final will be run off tomorrow.

The One Third Mile Amateur was won by Caldwell of Scotland; Boisvert, Montreal, second; Murray, Hamilton, third. Time 48:3-5.

The finish of races will be tomorrow.

MR. SOUSA WORSTED

Has to Account to Mrs. Blakely for

ALL MONEY RECEIVED

Bands not conducted by Mr. Sousa Cannot be Called Sousa's Band.

The suit of Mrs. Ada P. Blakely, administratrix by David Blakely, deceased, against John Philip Sousa, the famous composer and bandmaster, who

with his band visited Charlottetown in the summer of 1897 and gave a concert in the Exhibition Building, has been terminated by a decision of the Common Pleas Court sustaining the report of the referee. The referee recommended that Sousa account to Mrs. Blakely for all moneys received by him for the sale of musical compositions, surrender to her the musical library in his possession and account for use of it from May 23, 1897. The referee also decided that the Blakely estate had the right without regard for the duration of time, to one-half of all the royalties which would be earned from Sousa's musical compositions, provided that such compositions were made prior to Mr. Blakely's death. As to whether the Blakely estate had an exclusive right to the use of Sousa's name, the referee found in Mr. Sousa's favor on the ground that it would be against public policy to permit any band not conducted by Mr. Sousa to be called Sousa's Band, as such name might mislead the public.

Cheese is Booming.

Away Over 10 Cents Paid in the Country Wednesday.

MONTREAL, Aug. 9.—As high as 10 1/2c was paid for cheese in the country yesterday, which is the highest figure yet recorded on the boom. At Ingersoll buyers were not so liberal in their views, with the result that no business was put through.

Cheese is now well over the 10c point, as 10 3/8c was paid yesterday at one of the country boards. Of course this is really an extreme figure and is certainly out of the question here. A fair range would be: Finest Western, 19 1/8c to 10 1/4c, and finest eastern, 9 7/8c to 10c. At the auction sale 125 boxes of Quebec goods realized 9 3/4c, but the quality was hardly A1. The cable was 45c 6d for white and 46c for colored.

The butter market continues very firm and is tending still higher. At the auction sale this morning as high as 20 1-2c was paid for creamery. The jobbing demand for domestic accounts is rather slow, but prices are firm as last quoted. The sales at the auction were as follows:—24 tubs creamery, 20 1-2c; 20 boxes do., 20c; and 41 boxes do., 20 1-2c. For export we quote creamery 20c to 20 1-2c, and Western dairy 14 1-2c to 15c, with jobbing prices 1 1/4c per pound higher.

In eggs a fair trade was done on local account and prices were firm. We quote:—Choice candled stock at 15c to 15 1-2c; ordinary at 12 1-2c to 13c; and No. 2 at 10c to 11c per dozen.

American Sentenced to Death in Porto Rico—Natives Protest.

SAN JUAN, Aug. 8.—The provincial court has passed the death sentence upon Henry James, an American, who, as the evidence brought out in his trial showed, was guilty of murder in having fired into a crowd, killing a boy. The native newspapers protest against the execution of the sentence. Their contention is that the death penalty is against the traditions of the Porto Ricans, declaring that the act of the State in taking the life of a citizen is equally as criminal as the offence of the person so put to death. Only one death sentence has occurred in Porto Rico in ten years.

CROPS PROMISE WFL.

In Manitoba from Thirty-five to Forty Bushels an Acre is Generally Expected.

Winnipeg, Man., August 8.—The Northern Pacific Railway crop report for the week ending August 7 shows the crop all along the company's line to be in splendid condition. An average yield of thirty-five to forty bushels is expected to many localities. Hay cutting is in full swing throughout the Province.
